1 AN ACT concerning ~~school districts; relating to drug screening of~~
2 ~~employees; relating to background checks of teachers; relating to~~

9 *Be it enacted by the Legislature of the State of Kansas:*

10 ~~New Section 1. (a) On or before January 1, 2015, the board of~~
11 ~~education of each school district shall adopt policies and procedures to~~
12 ~~establish and implement a drug screening program for employees of the~~
13 ~~school district. Such policies and procedures shall be adopted in~~
14 ~~accordance with the provisions of this section. A drug screening program~~
15 ~~established pursuant to this section shall be based upon a reasonable~~
16 ~~suspicion of illegal drug use by any employee of the school district.~~

17 (b) (1) ~~No employee shall be terminated solely due to positive results~~
18 ~~of a test administered as a part of a drug screening program established~~
19 ~~pursuant to this section if:~~

20 (A) ~~The employee has not previously had a valid positive test result;~~
21 ~~and~~

22 (B) ~~the employee undergoes a drug evaluation and successfully~~
23 ~~completes any education or treatment program recommended as a result of~~
24 ~~the evaluation.~~

25 (2) ~~Nothing herein shall be construed as prohibiting demotions,~~
26 ~~suspensions or terminations pursuant to article 54 of chapter 72 of the~~
27 ~~Kansas Statutes Annotated, and amendments thereto.~~

28 (c) ~~The results of any test administered as a part of a drug screening~~
29 ~~program established pursuant to this section shall be reported to the state~~
30 ~~board of education, and the state board of education shall maintain a~~
31 ~~record of any such results that are reported. Except as provided in~~
32 ~~subsection (d), the results of any test administered as a part of a drug~~
33 ~~screening program established pursuant to this section and the records of~~
34 ~~the state board of education on such results shall be confidential and shall~~

1 not be disclosed publicly.

2 (d) ~~Prior to any final decision to hire an individual, a school district~~
3 ~~may request from the state board of education the record of such~~
4 ~~individual, if any exists, maintained by the state board of education~~
5 ~~pursuant to subsection (c). Upon receipt of each such request, the state~~
6 ~~board of education shall provide such record, if such record exists, to the~~
7 ~~school district. In order to ensure the confidentiality of the record, the~~
8 ~~school district, in its request to the state board of education, shall identify~~
9 ~~the specific person or persons to whom the record may be disclosed. The~~
10 ~~record shall not be disclosed to any other individuals other than those~~
11 ~~persons specifically named in the school district's request.~~

12 (e) ~~Pursuant to K.S.A. 45-229, and amendments thereto, the~~
13 ~~exception to the Kansas open records act contained in subsections (c) and~~
14 ~~(d) shall expire on June 30, 2019, unless the legislature reviews and~~

16 (f) ~~The state board of education may adopt rules and regulations as~~
17 ~~necessary to carry out the provisions of this section.~~

18 *New Section 1. (a) On or before January 1, 2015, the board of*
19 *education of each school district shall adopt policies and procedures to*
20 *establish and implement a drug screening program for employees of the*
21 *school district. Such policies and procedures shall be adopted in*
22 *accordance with the provisions of this section. A drug screening*
23 *program established pursuant to this section shall be based upon a*
24 *reasonable suspicion of illegal drug use by any employee of the school*
25 *district.*

26 (b) *Any employee who tests positive for the use of drugs under an*
27 *initial test administered as a part of a drug screening program may*
28 *request that the drug screening specimen be sent to a different drug*
29 *testing facility for an additional drug screening. Any such employee who*
30 *requests an additional drug screening at a different drug testing facility*
31 *shall be required to pay the cost of drug screening. Any disciplinary*
32 *action taken by a school district against any employee as a result of a*
33 *positive test for the use of drugs shall be taken only after the employee*
34 *has tested positive under two consecutive drug screenings of the*
35 *employee's specimen, except that disciplinary action may be taken by a*
36 *school district against such employee after only one positive test if the*
37 *employee does not request a second drug screening of the employee's*
38 *specimen.*

39 (c) *Nothing herein shall be construed as prohibiting demotions,*
40 *suspensions, terminations or any other disciplinary action taken in*
41 *accordance with the professional negotiations act, K.S.A. 72-5413 et*
42 *seq., and amendments thereto.*

43 *New Sec. 2. (a) {Except as provided in subsection (d),} the state*

1 *board of education {of each school district} shall establish and*
2 *implement an impaired teacher program. The purpose of the impaired*
3 *teacher program is to provide support and assistance to impaired*
4 *teachers who are unable to adequately engage in performance of the*
5 *teaching profession due to a dependency on alcohol or drugs, or both.*

6 *(b) The superintendent of any school district, or any school district*
7 *official designated by the superintendent, may refer any impaired*
8 *teacher to the impaired teacher program established pursuant to*
9 *subsection (a), and shall make such referral for any impaired teacher*
10 *who is subject to disciplinary action as a result of failing one or more*
11 *tests administered pursuant to a drug screening program established*
12 *under section 1, and amendments thereto. ~~Such referral shall be in-~~*
13 *~~writing and shall be submitted to the state board in such form and~~*
14 *~~manner as prescribed by the state board. All referrals made pursuant to~~*
15 *this section and any information related to a person's participation in*
16 *any evaluations or education or treatment programs shall be*
17 *confidential and shall not be disclosed publicly.*

18 *(c) The impaired teacher program shall:*

19 *(1) Assist those persons referred to the program in undergoing*
20 *alcohol and drug evaluations and any education or treatment programs*
21 *recommended as a result of such evaluations;*

22 *(2) provide support to persons who have successfully completed an*
23 *alcohol or drug education or treatment program in returning to the*
24 *teaching profession; and*

25 *(3) provide guidance on the establishment of programs similar to*
26 *the impaired teacher program by any board of education of a school*
27 *district.*

28 *{(d) In lieu of establishing an impaired teacher program, the board*
29 *of education of a school district may enter into an agreement with the*
30 *board of education of another school district for the purpose of referring*
31 *impaired teachers to such other school district's impaired teacher*
32 *program.}*

33 *~~(d) {(e)}~~ The state board shall adopt rules and regulations necessary*
34 *to carry out the provisions of this section. Such rules and regulations*
35 *shall provide for the review and approval of ~~any programs similar to the~~*
36 *~~impaired teacher program~~ {programs} established ~~by a board of~~*
37 *~~education of a school district~~ {pursuant to this section}. Such rules and*
38 *regulations may provide for the suspension or revocation of a person's*
39 *certificate or license by the state board if such person is referred to the*
40 *impaired teacher program and refuses to participate in the impaired*
41 *teacher program. Prior to the suspension or revocation of any license by*
42 *the state board, the person shall be given notice and an opportunity for a*
43 *hearing in accordance with the provisions of the Kansas administrative*

16 ~~New Sec.-2:~~ 3. (a) Each person making an initial application for a
17 Kansas teaching certificate or teaching license, for renewal of such
18 certificate or license or for the renewal of an expired certificate or license
19 shall submit, at the time of application, a complete set of legible
20 fingerprints of the person taken by a qualified law enforcement agency,
21 *unless such person has previously submitted a complete set of legible*
22 *fingerprints taken by a qualified law enforcement agency to the state*
23 *department of education. Fingerprints submitted pursuant to this*
24 *regulation section, or which were previously submitted by the applicant*
25 *shall be released by the state department of education to the Kansas bureau*
26 *of investigation for the purpose of conducting criminal history records*
27 *checks, utilizing the files and records of the Kansas bureau of investigation*
28 *and the federal bureau of investigation.*

20 (1) A felony under K.S.A. 2010 Supp. 21-36a01 through 21-36a17,
21 prior to their transfer, or article 57 of chapter 21 of the Kansas Statutes
22 Annotated, and amendments thereto, or any felony violation of any
23 provision of the uniform controlled substances act prior to July 1, 2009;

24 (2) a felony described in any section of article 34 of chapter 21 of the
25 Kansas Statutes Annotated, prior to their repeal, or article 54 of chapter 21
26 of the Kansas Statutes Annotated, or K.S.A. 2013 Supp. 21-6104, 21-6325,

28 in subsection (a), or a battery, as described in K.S.A. 21-3412, prior to its

25 (c) The state board of education may issue a license to ~~or renew the~~
26 ~~license of~~ a person who has been convicted of committing an offense or
27 act described in subsection (b) or who has entered into a criminal diversion
28 agreement after having been charged with an offense or act described in
29 subsection (b) if the state board determines, following a hearing, that the
30 person has been rehabilitated for a period of at least five years from the
31 date of conviction of the offense or commission of the act or, in the case of
32 a person who has entered into a criminal diversion agreement, that the
33 person has satisfied the terms and conditions of the agreement. The state
34 board of education may consider factors including, but not limited to, the
35 following in determining whether to grant a license:

36 (1) The nature and seriousness of the offense or act;

37 (2) the conduct of the person subsequent to commission of the
38 offense or act;

39 (3) the time elapsed since the commission of the offense or act;

40 (4) the age of the person at the time of the offense or act;

41 (5) whether the offense or act was an isolated or recurring incident;

43 (6) discharge from probation, pardon or expungement.

1 (d) Before any license is *revoked or* denied by the state board of
2 education for any of the offenses or acts specified in subsections (a) and
3 (b), the person shall be given notice and an opportunity for a hearing in
4 accordance with the provisions of the Kansas administrative procedure act.

5 (e) (1) The county or district attorney shall file a report with the state
6 board of education indicating the name, address and social security
7 number of any person who has been determined to have committed any
8 offense or act specified in subsection (a) or (b) or to have entered into a
9 criminal diversion agreement after having been charged with any offense
10 or act specified in subsection (b). Such report shall be filed within 30 days
11 of the date of the determination that the person has committed any such act
12 or entered into any such diversion agreement.

13 (2) *If any person reported pursuant to paragraph (1) is a licensed*
14 *employee of a unified school district, the state board of education shall*
15 *notify such unified school district within 30 days that such report has been*
16 *received, and upon request by such unified school district shall provide a*

19 to any person refused issuance or renewal of a license by reason of the

21 ~~Sec.-4:~~ 5. K.S.A. 2013 Supp. 72-1923 is hereby amended to read as
22 follows: 72-1923. (a) Except as provided in K.S.A. 2013 Supp. 72-1925,
23 and amendments thereto, the board of education of any school district may
24 apply to the state board for a grant of authority to operate such school
25 district as a public innovative district. The application shall be submitted in
26 the form and manner prescribed by the state board, and shall be submitted
27 not later than December 1 of the school year preceding the school year in
28 which the school district intends to operate as a public innovative district.

29 (b) The application shall include the following:

30 (1) A description of the educational programs of the public innovative
31 district;

32 (2) a description of the interest and support for partnerships between
33 the public innovative district, parents and the community;

34 (3) the specific goals and the measurable pupil outcomes to be
35 obtained by operating as a public innovative district; and

36 (4) an explanation of how pupil performance in achieving the
37 specified outcomes will be measured, evaluated and reported.

38 (c) (1) Within 90 days from the date such application is submitted, the
39 state board shall review the application to determine compliance with this
40 section, and shall approve or deny such application on or before the
41 conclusion of such 90-day period. If the application is determined to be in
42 compliance with this section, the state board shall approve such
43 application and grant the school district authority to operate as a public

1 innovative district. Notification of such approval shall be sent to the board
2 of education of such school district within 10 days after such decision.

3 (2) If the state board determines such application is not in compliance
4 with either this section, or K.S.A. 2013 Supp. 72-1925, and amendments
5 thereto, the state board shall deny such application. Notification of such
6 denial shall be sent to the board of education of such school district within
7 10 days after such decision and shall specify the reasons therefor. Within
8 30 days from the date such notification is sent, the board of education of
9 such school district may submit a request to the state board for
10 reconsideration of the application and may submit an amended application
11 with such request. The state board shall act on the request for
12 reconsideration within 60 days of receipt of such request.

13 (d) A public innovative district shall:

14 (1) Not charge tuition for any of the pupils residing within the public
15 innovative district;

16 (2) participate in all Kansas math and reading assessments applicable
17 to such public innovative district, or an alternative assessment program for
18 measuring student progress as determined by the board of education;

19 (3) abide by all financial and auditing requirements that are
20 applicable to school districts, except that a public innovative district may
21 use generally accepted accounting principles;

22 (4) comply with all applicable health, safety and access laws; ~~and~~

23 (5) *comply with the provisions of section 1, and amendments thereto;*

25 (6) comply with all statements set forth in the application submitted
26 pursuant to subsection (a).

27 (e) (1) Except as otherwise provided in K.S.A. 2013 Supp. 72-1921
28 through 72-1930, and amendments thereto, or as required by the board of
29 education of the public innovative district, a public innovative district shall
30 be exempt from all laws and rules and regulations that are applicable to
31 school districts.

32 (2) A public innovative district shall be subject to the special
33 education for exceptional children act, the virtual school act, the school
34 district finance and quality performance act, the provisions of K.S.A. 72-
35 8801 et seq., and amendments thereto, all laws governing the issuance of
36 general obligation bonds by school districts, the provisions of K.S.A. 74-
37 4901 et seq., and amendments thereto, and all laws governing the election
38 of members of the board of education, the open meetings act as provided
39 in K.S.A. 75-4317 et seq., and amendments thereto, and the open records
40 act as provided in K.S.A. 45-215 et seq., and amendments thereto.

41 (f) *Prior to hiring any person for a teaching position who does not*
42 *hold a valid teaching certificate or license issued by the state board, a*
43 *public innovative district shall require such person to submit a complete*

1 *set of legible fingerprints of such person taken by a qualified law*
2 *enforcement agency. Fingerprints submitted pursuant to this subsection*
3 *shall be released by the public innovative district to the Kansas bureau of*
4 *investigation for the purpose of conducting criminal history records*
5 *checks. The cost of any such criminal history record check shall be borne*
6 *by the public innovative district.*

7 *{Sec. 6. K.S.A. 2013 Supp. 75-4362 is hereby amended to read as*
8 *follows: 75-4362. (a) The director of the division of personnel services of*
9 *the department of administration shall have the authority to establish*
10 *and implement a drug screening program for persons taking office as*
11 *governor, lieutenant governor, attorney general or members of the*
12 *Kansas senate or house of representatives and for applicants for safety*
13 *sensitive positions in state government, but no applicant for a safety*
14 *sensitive position shall be required to submit to a test as a part of this*
15 *program unless the applicant is first given a conditional offer of*
16 *employment.*

17 *(b) The director also shall have the authority to establish and*
18 *implement a drug screening program based upon a reasonable suspicion*
19 *of illegal drug use by any person currently holding one of the following*
20 *positions or offices:*

21 *(1) The office of governor, lieutenant governor or attorney general;*

22 *(2) members of the Kansas senate or house of representatives;*

23 *(3) any safety sensitive position;*

24 *(4) any position in an institution of mental health, as defined in*
25 *K.S.A. 76-12a01, and amendments thereto, that is not a safety sensitive*
26 *position;*

27 *(5) any position in the Kansas state school for the blind, as*
28 *established under K.S.A. 76-1101 et seq., and amendments thereto;*

29 *(6) any position in the Kansas state school for the deaf, as*
30 *established under K.S.A. 76-1001 et seq., and amendments thereto; or*

31 *(7) any employee of a state veteran's home operated by the Kansas*
