1 AN ACT concerning certain crimes and punishment; related to smoking;
2 amending K.S.A. 2013 Supp. 21-6109 and 21-6110 and repealing the
3 existing sections.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2013 Supp. 21-6109 is hereby amended to read as
7 follows: 21-6109. As used in K.S.A. 2013 Supp. 21-6109 through 21-6116,
8 and amendments thereto:

9 (a) "Access point" means the area within a ten foot radius outside of
10 any doorway, open window or air intake leading into a building or facility
11 that is not exempted pursuant to subsection (d) of K.S.A. 2013 Supp. 21-
12 6110, and amendments thereto.

13 (b) "Bar" means any indoor area that is operated and licensed for the
14 sale and service of alcoholic beverages, including alcoholic liquor as
15 defined in K.S.A. 41-102, and amendments thereto, or cereal malt
16 beverages as defined in K.S.A. 41-2701, and amendments thereto, for on-
17 premises consumption.

18 (c) "Employee" means any person who is employed by an employer
19 in consideration for direct or indirect monetary wages or profit, and any
20 person who volunteers their services for a nonprofit entity.

21 (d) "Employer" means any person, partnership, corporation,
22 association or organization, including municipal or nonprofit entities,
23 which employs one or more individual persons.

24 (e) "Enclosed area" means all space between a floor and ceiling
25 which is enclosed on all sides by solid walls, windows or doorways which
26 extend from the floor to the ceiling, including all space therein screened by
27 partitions which do not extend to the ceiling or are not solid or similar
28 structures. For purposes of this section, the following shall not be
29 considered an "enclosed area": (1) Rooms or areas, enclosed by walls,
30 windows or doorways, having neither a ceiling nor a roof and which are
31 completely open to the elements and weather at all times; and (2) rooms or
32 areas, enclosed by walls, fences, windows or doorways and a roof or
33 ceiling, having openings that are permanently open to the elements and
34 weather and which comprise an area that is at least 30% of the total
35 perimeter wall area of such room or area.

36 (f) "Food service establishment" means any place in which food is

1 served or is prepared for sale or service on the premises. Such term shall
2 include, but not be limited to, fixed or mobile restaurants, coffee shops,
3 cafeterias, short-order cafes, luncheonettes, grills, tea rooms, sandwich
4 shops, soda fountains, taverns, private clubs, roadside kitchens,
5 commissaries and any other private, public or nonprofit organization or
6 institution routinely serving food and any other eating or drinking
7 establishment or operation where food is served or provided for the public
8 with or without charge.

9 ~~(g) "Gaming floor" means the area of a lottery gaming facility or~~
10 ~~racetrack gaming facility, as those terms are defined in K.S.A. 74-8702,~~
11 ~~and amendments thereto, where patrons engage in Class III gaming. The~~
12 ~~gaming floor shall not include any areas used for accounting, maintenance,~~
13 ~~surveillance, security, administrative offices, storage, cash or cash-~~
14 ~~counting, records, food service, lodging or entertainment, except that the~~
15 ~~gaming floor may include a bar where alcoholic beverages are served so~~
16 ~~long as the bar is located entirely within the area where Class III gaming is~~
17 ~~conducted.~~

18 ~~(h) (g) "Medical care facility" means a physician's office, general~~
19 ~~hospital, special hospital, ambulatory surgery center or recuperation center,~~
20 ~~as defined by K.S.A. 65-425, and amendments thereto, and any psychiatric~~
21 ~~hospital licensed under K.S.A. 75-3307b, and amendments thereto.~~

22 ~~(i) (h) "Outdoor recreational facility" means a hunting, fishing,~~
23 ~~shooting or golf club, business or enterprise operated primarily for the~~
24 ~~benefit of its owners, members and their guests and not normally open to~~
25 ~~the general public.~~

26 ~~(j) (i) "Place of employment" means any enclosed area under the~~
27 ~~control of a public or private employer, including, but not limited to, work~~
28 ~~areas, auditoriums, elevators, private offices, employee lounges and~~
29 ~~restrooms, conference and meeting rooms, classrooms, employee~~
30 ~~cafeterias, stairwells and hallways, that is used by employees during the~~
31 ~~course of employment. For purposes of this section, a private residence~~
32 ~~shall not be considered a "place of employment" unless such residence is~~
33 ~~used as a day care home, as defined in K.S.A. 65-530, and amendments~~
34 ~~thereto.~~

35 ~~(k) (j) "Private club" means an outdoor recreational facility operated~~
36 ~~primarily for the use of its owners, members and their guests that in its~~
37 ~~ordinary course of business is not open to the general public for which use~~
38 ~~of its facilities has substantial dues or membership fee requirements for its~~
39 ~~members.~~

40 ~~(l) (k) "Public building" means any building owned or operated by:~~
41 ~~(1) The state, including any branch, department, agency, bureau,~~
42 ~~commission, authority or other instrumentality thereof; (2) any county,~~
43 ~~city, township, other political subdivision, including any commission,~~

1 authority, agency or instrumentality thereof; or (3) any other separate
2 corporate instrumentality or unit of the state or any municipality.

3 ~~(m)~~ (l) "Public meeting" means any meeting open to the public
4 pursuant to K.S.A. 75-4317 et seq., and amendments thereto, or any other
5 law of this state.

6 ~~(n)~~ (m) "Public place" means any enclosed areas open to the public or
7 used by the general public including, but not limited to: Banks, bars, food
8 service establishments, retail service establishments, retail stores, public
9 means of mass transportation, passenger elevators, health care institutions
10 or any other place where health care services are provided to the public,
11 medical care facilities, educational facilities, libraries, courtrooms, public
12 buildings, restrooms, grocery stores, school buses, museums, theaters,
13 auditoriums, arenas and recreational facilities. For purposes of this section,
14 a private residence shall not be considered a "public place" unless such
15 residence is used as a day care home, as defined in K.S.A. 65-530, and
16 amendments thereto.

17 ~~(o)~~ (n) "Smoking" means possession of a lighted cigarette, cigar, pipe
18 or burning tobacco in any other form or device designed for the use of
19 tobacco.

20 ~~(p)~~ (o) "Tobacco shop" means any indoor area operated primarily for
21 the retail sale of tobacco, tobacco products or smoking devices or
22 accessories, and which derives not less than 65% of its gross receipts from
23 the sale of tobacco.

24 ~~(q)~~ (p) "Substantial dues or membership fee requirements" means
25 initiation costs, dues or fees proportional to the cost of membership in
26 similarly-situated outdoor recreational facilities that are not considered
27 nominal and implemented to otherwise avoid or evade restrictions of a
28 statewide ban on smoking.

29 Sec. 2. K.S.A. 2013 Supp. 21-6110 is hereby amended to read as
30 follows: 21-6110. (a) It shall be unlawful, with no requirement of a
31 culpable mental state, to smoke in an enclosed area or at a public meeting
32 including, but not limited to:

33 (1) Public places;
34 (2) taxicabs and limousines;
35 (3) restrooms, lobbies, hallways and other common areas in public
36 and private buildings, condominiums and other multiple-residential
37 facilities;

38 (4) restrooms, lobbies and other common areas in hotels and motels
39 and in at least 80% of the sleeping quarters within a hotel or motel that
40 may be rented to guests;

41 (5) access points of all buildings and facilities not exempted pursuant
42 to subsection (d); and

43 (6) any place of employment.

1 (b) Each employer having a place of employment that is an enclosed
2 area shall provide a smoke-free workplace for all employees. Such
3 employer shall also adopt and maintain a written smoking policy which
4 shall prohibit smoking without exception in all areas of the place of
5 employment. Such policy shall be communicated to all current employees
6 within one week of its adoption and shall be communicated to all new
7 employees upon hiring. Each employer shall provide a written copy of the
8 smoking policy upon request to any current or prospective employee.

9 (c) Notwithstanding any other provision of this section, K.S.A. 2013
10 Supp. 21-6111 or 21-6112, and amendments thereto, the proprietor or other
11 person in charge of an adult care home, as defined in K.S.A. 39-923, and
12 amendments thereto, or a medical care facility, may designate a portion of
13 such adult care home, or the licensed long-term care unit of such medical
14 care facility, as a smoking area, and smoking may be permitted within such
15 designated smoking area.

16 (d) The provisions of this section shall not apply to:

17 (1) The outdoor areas of any building or facility beyond the access
18 points of such building or facility;

19 (2) private homes or residences, except when such home or residence
20 is used as a day care home, as defined in K.S.A. 65-530, and amendments
21 thereto;

22 (3) a hotel or motel room rented to one or more guests if the total
23 percentage of such hotel or motel rooms in such hotel or motel does not
24 exceed 20%;

25 ~~(4) the gaming floor of a lottery gaming facility or racetrack gaming~~
26 ~~facility, as those terms are defined in K.S.A. 74-8702, and amendments~~
27 ~~thereto;~~

28 ~~(5)~~ (4) that portion of an adult care home, as defined in K.S.A. 39-
29 923, and amendments thereto, that is expressly designated as a smoking
30 area by the proprietor or other person in charge of such adult care home
31 pursuant to subsection (c) and that is fully enclosed and ventilated;

32 ~~(6)~~ (5) that portion of a licensed long-term care unit of a medical care
33 facility that is expressly designated as a smoking area by the proprietor or
34 other person in charge of such medical care facility pursuant to subsection
35 (c) and that is fully enclosed and ventilated and to which access is
36 restricted to the residents and their guests;

37 ~~(7)~~ (6) tobacco shops;

38 ~~(8)~~ (7) a class A or class B club defined in K.S.A. 41-2601, and
39 amendments thereto, which (A) held a license pursuant to K.S.A. 41-2606
40 et seq., and amendments thereto, as of January 1, 2009; and (B) notifies
41 the secretary of health and environment in writing, not later than 90 days
42 after the effective date of this act, that it wishes to continue to allow
43 smoking on its premises;

1 ~~(9)~~ (8) a private club in designated areas where minors are prohibited;
2 and

3 ~~(10)~~ (9) any benefit cigar dinner or other cigar dinner of a
4 substantially similar nature that:

5 (A) Is conducted specifically and exclusively for charitable purposes
6 by a nonprofit organization which is exempt from federal income taxation
7 pursuant to section 501(c)(3) of the federal internal revenue code of 1986;

8 (B) is conducted no more than once per calendar year by such
9 organization; and

10 (C) has been held during each of the previous three years prior to
11 January 1, 2011.

12 Sec. 3. K.S.A. 2013 Supp. 21-6109 and 21-6110 are hereby repealed.

14 publication in the statute book.
