

**HOUSE BILL No. 2060**

1 AN ACT concerning motor vehicles; relating to registration, fees, certain  
2 vehicles; amending K.S.A. 2016 Supp. 8-143 and repealing the existing  
3 section.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. K.S.A. 2016 Supp. 8-143 is hereby amended to read as  
7 follows: 8-143. (a) All applications for the registration of motorcycles,  
8 motorized bicycles and passenger vehicles other than trucks and truck  
9 tractors, except as otherwise provided, shall be accompanied by an annual  
10 license fee as follows:

11 (1) For motorized bicycles, \$11;

12 (2) for motorcycles, \$16;

13 (3) for passenger vehicles, other than motorcycles, used solely for the  
14 carrying of persons for pleasure or business, and for hearses and  
15 ambulances a fee of:

16 (A) For those having a gross weight of 4,500 pounds or less, \$30; ~~and~~

17 (B) for those having a gross weight of more than 4,500 pounds, \$40;

18 (C) *for those motor vehicles propelled by more than one power*  
19 *source mated together to work in conjunction, \$75; and*

20 (D) *for each electric vehicle, \$150.*

21 (4) Except for motor vehicles, trailers or semitrailers registered under  
22 the provisions of K.S.A. 8-1,134, and amendments thereto, the annual  
23 registration fee for each motor vehicle, trailer or semitrailer owned by any  
24 political or taxing subdivision of this state or by any agency or  
25 instrumentality of any one or more political or taxing subdivisions of this  
26 state and used exclusively for governmental purposes and not for any  
27 private or utility purposes, which is not otherwise exempt from  
28 registration, shall be \$2.

29 (b) (1) As used in this subsection, the term "gross weight" shall mean  
30 and include the empty weight of the truck, or combination of the truck or  
31 truck tractor and any type trailer or semitrailer, plus the maximum weight  
32 of cargo which will be transported on or with the same, except when the  
33 empty weight of a truck plus the maximum weight of cargo which will be  
34 transported thereon is 12,000 pounds or less. The term gross weight shall  
35 not include: The weight of any travel trailer propelled thereby which is  
36 being used for private recreational purposes; or the weight of any vehicle

1 or combination of vehicles for which wrecker or towing service, as defined  
 2 in K.S.A. 66-1329, and amendments thereto, is to be provided by a  
 3 wrecker or tow truck, as defined in K.S.A. 66-1329, and amendments  
 4 thereto. Such wrecker or tow truck shall be registered for the empty weight  
 5 of such vehicle fully equipped for the recovery or towing of vehicles. The  
 6 gross weight license fees hereinafter prescribed shall only apply to the  
 7 truck or truck tractor used as the propelling unit for the cargo and vehicle  
 8 propelled, either as a single vehicle or combination of vehicles. On  
 9 application for the registration of a truck or truck tractor, the owner thereof  
 10 shall declare as a part of such application the maximum gross weight the  
 11 owner desires to be applicable to such vehicle, which declared gross  
 12 weight in no event shall be in excess of the limitations described by K.S.A.  
 13 8-1908 and 8-1909, and amendments thereto, for such vehicle or  
 14 combination of vehicles of which it will be a part. All applications for the  
 15 registration of trucks or truck tractors, except as otherwise provided  
 16 herein, shall be accompanied by an annual license fee as follows:

21 (2) If the applicant for registration of any truck or truck tractor for a  
22 gross weight of more than 12,000 pounds is the state of Kansas or any  
23 political or taxing subdivision or agency of the state, except a city or  
24 county, whose truck or truck tractor is not otherwise entitled to the \$2  
25 license fee or otherwise exempt from all fees, such vehicle may be  
26 licensed for a fee in accordance with the schedule hereinafter prescribed  
27 for local trucks or truck tractors.

28 (3) If the applicant for registration of any truck or truck tractor for a  
29 gross weight of more than 12,000 pounds shall under oath state in writing  
30 on a form prescribed and furnished by the director of vehicles that the  
31 applicant does not expect to operate it more than 6,000 miles in the  
32 calendar year for which the applicant seeks registration, and that if the  
33 applicant shall operate it more than 6,000 miles during such registration  
34 year such applicant will pay an additional fee equal to the fee required by  
35 the schedule under paragraph (1), less the amount of the fee paid at time of  
36 registration, such vehicle may be licensed for a fee in accordance with the  
37 schedule prescribed for local trucks or truck tractors. Whenever a truck or  
38 truck tractor is registered on a local truck or truck tractor fee basis a tab or  
39 marker shall be issued in connection with the regular license plate, which  
40 tab or marker shall be attached or affixed to and displayed with the regular  
41 license plate and the failure to have the same attached, affixed or displayed  
42 shall be subject to the same penalties as provided by law for the failure to  
43 display the regular license plate; and the secretary of revenue may adopt

1 rules and regulations requiring the owners of trucks and truck tractors so  
2 registered on a local truck or truck tractor fee basis to keep such records  
3 and make such reports of mileage of such vehicles as the secretary of  
4 revenue shall deem proper.

5 (4) A transporter delivering vehicles not the transporter's own by the  
6 driveaway method where such vehicles are being driven, towed, or  
7 transported singly, or by the saddlemount, towbar, or fullmount methods,  
8 or by any lawful combination thereof, may apply for license plates which  
9 may be transferred from one such vehicle or combination to another for  
10 each delivery without further registration, and the annual license fee for  
11 such license plate shall be as follows:

12 (A) Prior to January 1, 2013:

13 For the first such set of license plates .....\$44  
14 For each additional such set of license plates .....18

15 (B) On January 1, 2013, through December 31, 2013:

16 For the first such set of license plates .....\$54  
17 For each additional such set of license plates .....28

21 (5) A truck or truck tractor registered for a gross weight of more than  
22 12,000 pounds, which is operated wholly within the corporate limits of a  
23 city or village or within a radius of 25 miles beyond the corporate limits,  
24 shall be classified as a local truck except that in no event shall such  
25 vehicles operated as contract or common carriers outside a radius of three  
26 miles beyond the corporate limits of the city or village in which such  
27 vehicles were based when registered and licensed be considered local  
28 trucks or truck tractors. The secretary of revenue is hereby authorized and  
29 directed to adopt rules and regulations prescribing a procedure for the  
30 issuance of permits by the division of vehicles whereby owners of local  
31 trucks or truck tractors may operate any such vehicle, empty, beyond the  
32 radius hereinbefore prescribed, when such operation is solely for the  
33 purpose of having such vehicle repaired, painted or serviced or for adding  
34 additional equipment thereto. The annual license fee for a local truck or  
35 truck tractor, except as otherwise provided herein, shall be as follows:

36 (A) Prior to January 1, 2013:

37 (6) A truck or truck tractor registered for a gross weight of more than

38 12,000 pounds, which is owned by a person engaged in farming and which

39 truck or truck tractor is used by such owner to transport agricultural

40 products produced by such owner or commodities purchased by such

41 owner for use on the farm owned or rented by the owner of such farm

42 truck or truck tractor, shall be classified as a farm truck or truck tractor and

43 the annual license fee for such farm truck shall be as follows:

12 A vehicle licensed as a farm truck or truck tractor may be used by the  
13 owner thereof to transport, for charity and without compensation of any  
14 kind, commodities for religious or educational institutions. A truck which  
15 is licensed as a farm truck may also be used for the transportation of sand,  
16 gravel, slag stone, limestone, crushed stone, cinders, black top, dirt or fill  
17 material to a township road maintenance or construction site of the  
18 township in which the owner of such truck resides. Any applicant for  
19 registration of any farm truck or farm truck tractor used in combination  
20 with a trailer or semitrailer shall register the farm truck or farm truck  
21 tractor for a gross weight which shall include the empty weight of the  
22 truck or truck tractor or of the combination of any truck or truck tractor  
23 and any type of trailer or semitrailer, plus the maximum weight of cargo  
24 which will be transported on or with the same. The applicant for  
25 registration of any farm truck or farm truck tractor used to transport a  
26 gross weight of more than 54,000 pounds shall durably letter on the side of  
27 the motor vehicle the words "farm vehicle—not for hire." If an applicant  
28 for registration of any farm truck or farm truck tractor operates such  
29 vehicle for any use or purpose not authorized for a farm truck or farm  
30 truck tractor, such applicant shall pay an additional fee equal to the fee  
31 required for the registration of all trucks or truck tractors not registered as  
32 local, 6,000-mile or farm truck or farm truck tractor motor vehicles, less  
33 the amount of the fee paid at time of registration. Nothing in this or the  
34 preceding paragraph shall authorize a gross weight of a vehicle or  
35 combination of vehicles on the national system of interstate and defense  
36 highways greater than permitted by laws of the United States congress.  
37 (7) Except as hereinafter provided, the annual license fee for each  
38 local urban transit bus used in local urban transit operations exempted  
39 under the provisions of ~~subsection (a)~~ of K.S.A. 66-1,109(a), and  
40 amendments thereto, shall be based on the passenger seating capacity of  
41 the bus and shall be as follows:  
42 (A) Prior to January 1, 2013:  
43 8 or more, but less than 31 passengers .....\$15

1 31 or more, but less than 40 passengers .....30  
2 More than 39 passengers .....60  
3 (B) On January 1, 2013, through December 31, 2013:  
4 8 or more, but less than 31 passengers .....\$25  
5 31 or more, but less than 40 passengers .....40  
6 More than 39 passengers .....70  
7 (C) On January 1, 2014:  
8 8 or more, but less than 31 passengers .....\$35  
9 31 or more, but less than 40 passengers .....50  
10 More than 39 passengers .....80

11 The annual license fee for each local urban transit bus which is owned  
12 by a metropolitan transit authority established pursuant to articles 25 and  
13 28 of chapter 12 or pursuant to article 31 of chapter 13 of the Kansas  
14 Statutes Annotated, and amendments thereto, shall be \$2.

15 (8) For licensing purposes, station wagons with a carrying capacity of  
16 less than 10 passengers shall be subject to registration fees based on the  
17 weight of the vehicles, as provided in subsection (a). Station wagons with  
18 a carrying capacity of 10 or more passengers shall be subject to the truck  
19 classifications and license fees as provided.

20 (9) For any trailer, semitrailer, travel trailer or pole trailer the annual  
21 license fee shall be as follows:

22 (A) (i) Until January 1, 2013, for any such vehicle with a gross  
23 weight of more than 12,000 pounds the annual fee shall be \$35; *and*

24 (ii) on January 1, 2013, for any such vehicle with a gross weight of  
25 more than 12,000 pounds but less than 54,000 pounds the annual fee shall  
26 be \$45, on January 1, 2014, \$55;

27 (B) any such vehicle grossing more than 8,000 pounds but not over  
28 12,000 pounds, the annual fee shall be \$25, on January 1, 2013, \$35, on  
29 January 1, 2014, \$45; *and*

30 (C) for any such vehicle grossing more than 2,000 pounds but not  
31 over 8,000 pounds, the annual fee shall be \$15, on January 1, 2013, \$25,  
32 on January 1, 2014, \$35.

33 Any such vehicle having a gross weight of 2,000 pounds or less may, at  
34 the owner's option, be registered and the fee for such registration shall be  
35 as provided in paragraph (C).

36 Any trailer, semitrailer or travel trailer owned by a nonresident of this  
37 state and based in another state, which is properly registered and licensed  
38 in the state of residence of the owner or in the state where based, may be  
39 operated in this state without being registered or licensed in this state if the  
40 truck or truck tractor propelling the same is properly registered and  
41 licensed in this state, or is registered and licensed in some other state and  
42 is entitled to reciprocal privileges of operation in this state, but this  
43 provision shall not apply to any trailer or semitrailer owned by a

1 nonresident of this state when such trailer or semitrailer is owned by a  
2 person who has proportionately registered and licensed a fleet of vehicles  
3 under the provisions of K.S.A. 8-1,101 to 8-1,123, inclusive, and  
4 amendments thereto, or under the terms of any reciprocal or proration  
5 agreement made pursuant thereto.

6 At the option of the owner, any trailer, semitrailer or pole trailer, with a  
7 gross weight of more than 12,000 pounds, may be issued a multi-year  
8 registration for a five-year period upon payment of the appropriate  
9 registration fee. The fee for a five-year registration of such trailer shall be  
10 five times the annual fee for such trailer. If the annual registration fee is  
11 increased during the multi-year registration period, the owner of the trailer  
12 with such multi-year registration shall be subject to the amount of the  
13 increase of the annual registration fee for the remaining calendar years of  
14 such multi-year registration. When the owner of any trailer, semitrailer or  
15 pole trailer registered under this multi-year provision transfers or assigns  
16 the title, or interest thereto, the registration of such trailer shall expire. The  
17 owner shall remove the license plate from such trailer and forward the  
18 license plate to the division of vehicles or may have such license plate  
19 assigned to another trailer, semitrailer or pole trailer upon the payment of  
20 fees required by law. Any owner of a trailer, semitrailer or pole trailer  
21 where the multi-year registration fee has been paid and the trailer is sold,  
22 junked, repossessed, foreclosed by a mechanic's lien or title transferred by  
23 operation of law, and the registration thereon is not going to be transferred  
24 to another trailer, may secure a refund for the registration fee for the  
25 remaining calendar years by making application to the division of vehicles  
26 on a form and in the manner prescribed by the director of vehicles. The  
27 secretary of revenue may adopt such rules and regulations necessary to  
28 implement the multi-year registration of such trailers, semitrailers and pole  
29 trailers.

30 (c) Any truck or truck tractor having a gross weight of 4,000 pounds  
31 or over, using solid tires, shall pay a license fee of double the amount  
32 herein charged. The annual fees herein provided for trucks, truck tractors  
33 and trailers not subject to K.S.A. 8-134a, and amendments thereto, shall be  
34 due January 1 of each year and payable on or before the last day of  
35 February in each year. If the fee is not paid by such date a penalty of \$1  
36 shall be added to the fee charged herein for each month or fraction thereof  
37 and until December 31 of each registration year. The annual registration  
38 fee for all passenger vehicles and vehicles subject to K.S.A. 8-134a, and  
39 amendments thereto, shall be due on or before the last day of the month in  
40 which the registration plate expires and shall be due for other vehicles as  
41 provided by K.S.A. 8-134, and amendments thereto. If the registration fee  
42 is not paid by such date a penalty of \$1 shall be added to the fee charged  
43 herein for each month or fraction thereof until such registration fee is paid.

1 Members of the armed forces of the United States shall be permitted to  
2 apply for registration at any time and be subject to registration fee, less  
3 penalties, applicable at the time the application is made. If any motorcycle,  
4 motorized bicycle, trailer, semitrailer, travel trailer, or pole trailer is either  
5 purchased or acquired after the anniversary or renewal date in any  
6 registration year there shall immediately become due and payable a  
7 registration fee as follows: If purchased or acquired between the  
8 anniversary or renewal date of any registration year and the first six  
9 months of such registration year, the annual fee hereinbefore provided; if  
10 purchased or acquired during the last six months of any registration year,  
11 50% of such annual fee. If any truck or truck tractor, except trucks subject  
12 to K.S.A. 8-134a, and amendments thereto, is purchased or acquired prior  
13 to April 1 of any year the fee shall be the annual fee hereinbefore provided,  
14 but if such truck or truck tractor is purchased or acquired after the end of  
15 March of any year, the license fee for such year shall be reduced  $\frac{1}{12}$   
16 for each calendar month which has elapsed since the beginning of the year. If  
17 any truck registered for a gross weight of 12,000 pounds or less or  
18 passenger vehicle is purchased or acquired and less than 12 months remain  
19 in the registration period, the fee shall be  $\frac{1}{12}$  of the annual fee for each  
20 calendar month remaining in the registration period.

21 (d) The owner of any motorcycle, motorized bicycle, passenger  
22 vehicle, truck, truck tractor, trailer, semitrailer, or electrically propelled  
23 vehicle who fails to pay the registration fee or fees herein provided on the  
24 date when the same become due and payable shall be guilty of a  
25 misdemeanor, and upon conviction thereof shall be subject to a penalty in  
26 the sum of \$1 for each month or fraction thereof during which such fee has  
27 remained unpaid after it became due and payable; and in addition thereto  
28 shall be subject to such other punishment as is provided in this act. Upon  
29 the transfer of motorcycles, motorized bicycles, passenger vehicles,  
30 trailers, semitrailers, trucks or truck tractors, on which registration fees  
31 have been paid for the year in which the transfer is made, either: (1) To a  
32 corporation by one or more persons, solely in exchange for stock or  
33 securities in such corporation; or (2) by one corporation to another  
34 corporation when all of the assets of such corporation are transferred to the  
35 other corporation, then in either case (1) or case (2) the corporation shall  
36 be exempt from the payment of registration fees on such vehicles for the  
37 year in which such transfer is made. Applications for transfer or  
38 registration shall be accompanied by a fee of \$1.50. When the registration  
39 of a vehicle has expired at midnight on the last day of any registration  
40 year, and such vehicle is not thereafter operated upon the highways, any  
41 application for renewal of registration made subsequent to the anniversary  
42 or renewal date of any registration year following the expiration of such  
43 registration and for succeeding registration years in which such vehicle has

1 not been registered shall be accompanied by an affidavit of nonoperation  
2 and nonuse, and such application for renewal or registration shall be  
3 received by the division of vehicles upon payment of the proper fees for  
4 the current registration year and without penalty.

5 (e) Any nonresident of Kansas purchasing a vehicle from a Kansas  
6 resident and desiring to secure registration on the vehicle in the state of  
7 such person's residence may make application in the office of any county  
8 treasurer for a sixty-day temporary registration. The county treasurer upon  
9 presentation of evidence of ownership in the applicant and evidence the  
10 sales tax has been paid, if due, shall charge and collect a fee of \$3 for each  
11 sixty-day temporary license and issue a sticker or paper registration as may  
12 be determined by the director of vehicles, and the registration so issued  
13 shall be valid for a period of 60 days from the date of issuance.

14 (f) Any owner of any motor vehicle which is subject to taxation under  
15 the provisions of article 51 of chapter 79 of the Kansas Statutes Annotated,  
16 and amendments thereto, or any other truck or truck tractor where the  
17 annual registration fee has been paid and the vehicle is sold, junked,  
18 repossessed, foreclosed by a mechanic's lien or title transferred by  
19 operation of law, and the registration thereon is not going to be transferred  
20 to another vehicle may secure a refund for the registration fee for the  
21 remaining portion of the year by making application to the division of  
22 vehicles on a form and in the manner prescribed by the director of  
23 vehicles, accompanied by all license plates and attachments issued in  
24 connection therewith. If the owner of the registration becomes deceased  
25 and the vehicle is not going to be used on the highway, and title is not  
26 being currently transferred, the proper representative of the estate shall be  
27 entitled to the refund. The refund shall be made only for the period of time  
28 remaining in the registration year from the date of completion and filing of  
29 the application with and delivery of the license plate and attachments to  
30 the division of vehicles. Where the registration is secured under a quarterly  
31 payment annual registration fee, as provided for in K.S.A. 8-143a, and  
32 amendments thereto, such refund shall be made on the quarterly fee paid  
33 and unused and all remaining quarterly payments shall be canceled. Any  
34 truck or truck tractor having the registration fee paid on quarterly payment  
35 basis, all quarterly payments due or a fraction of quarterly payment due  
36 shall be paid before title may be transferred, except that in case of death,  
37 the filing of the application and returning of the license plate and  
38 attachment shall cancel the remaining annual payments due. Whenever a  
39 truck or truck tractor, where the registration is secured on a quarterly  
40 payment of the annual registration, the one repossessing the truck or truck  
41 tractor, or foreclosing by a mechanic's lien, or securing title by court order,  
42 the mortgagor or the assigns of the mortgagor, or the one securing title  
43 may pay the balance due on date of application for title, but the payments

1 for the remaining portion of the year shall not be canceled unless  
2 application is made and the license plate and attachments are surrendered.  
3 Nothing in this subsection shall apply when registration is secured under  
4 the provisions of K.S.A. 8-1,101 to 8-1,123, inclusive, and amendments  
5 thereto. Notwithstanding any of the foregoing provisions of this section,  
6 no refund shall be made under the provisions of this section where the  
7 amount thereof does not exceed \$5. The division of vehicles shall furnish  
8 such blank forms as may be required under the provisions of this  
9 subsection as it deems necessary to be completed by the applicant.  
10 Whenever a registration which has been secured on a quarterly basis shall  
11 be canceled as provided in this subsection, the division of vehicles shall  
12 notify the county treasurer issuing the original registration of such  
13 cancellation so that the county treasurer may, and the county treasurer shall  
14 cancel the registration of such vehicle in the county treasurer's office and  
15 release any lien issued in connection with such registration.

16 (g) Every owner of a travel trailer designed for or intended to be  
17 moved upon any highway in this state shall, before the same is so moved,  
18 apply for and obtain the proper registration thereof as provided in this act,  
19 except when such unit is permitted to be moved under the special  
20 provisions relating to secured parties, manufacturers, dealers and  
21 nonresidents contained in this act. At the time of registering any travel  
22 trailer for the purpose of moving any such vehicle upon any highway in  
23 this state, the owner thereof shall indicate on the registration form whether  
24 or not such vehicle is being moved permanently to a location outside of the  
25 county in which such vehicle is being registered. No such vehicle which  
26 the owner thereof intends to move to a permanent location outside the  
27 boundaries of such county shall be registered for movement on the  
28 highways of this state until all taxes levied against such vehicle have been  
29 paid. A copy of such registration form shall be sent to the county clerk or  
30 assessor of the county to which such vehicle is being moved. When such  
31 travel trailer is used for living quarters and not operated on the highways,  
32 the owner shall be exempt from the license fees as provided in subsection  
33 (b)(9) so long as such travel trailer is not operated on the highway.
