1 AN ACT making and concerning appropriations for the fiscal years ending  
2 June 30, 2018, June 30, 2019, June 30, 2020, June 30, 2021, June 30,  
3 2022, and June 30, 2023, for the department of education.

5 *Be it enacted by the Legislature of the State of Kansas:*

6 Section 1. (a) For the fiscal years ending June 30, 2018, June 30,  
7 2019, June 30, 2020, June 30, 2021, June 30, 2022, and June 30, 2023,  
8 appropriations are hereby made, restrictions and limitations are hereby  
9 imposed, and transfers, capital improvement projects, fees, receipts,  
10 disbursements, procedures and acts incidental to the foregoing are hereby  
11 directed or authorized as provided in this act.

12 (b) This act shall not be subject to the provisions of K.S.A. 75-  
13 6702(a), and amendments thereto.

14 (c) The appropriations made by this act shall not be subject to the  
15 provisions of K.S.A. 46-155, and amendments thereto.

4 Sec. 8. If any fund or account name described by words and the  
5 numerical accounting code that follows such fund or account name do not  
6 match, it shall be conclusively presumed that the legislature intended that  
7 the fund or account name described by words is the correct fund or  
8 account name, and such fund or account name described by words shall  
9 control over a contradictory or incorrect numerical accounting code.

10 Sec. 9. *Severability*. If any provision or clause of this act or  
11 application thereof to any person or circumstance is held invalid, such  
12 invalidity shall not affect other provisions or applications of the act that  
13 can be given effect without the invalid provision or application, and to this  
14 end the provisions of this act are declared to be severable.

15 Sec. 10. *Appeals to exceed expenditure limitations*. (a) Upon written  
16 application to the governor and approval of the state finance council,  
17 expenditures from special revenue funds may exceed the amounts  
18 specified in this act.

19 (b) This section shall not apply to the expanded lottery act revenues  
20 fund, the state economic development initiatives fund, the children's  
21 initiatives fund, the state water plan fund or the Kansas endowment for  
22 youth fund, or to any account of any of such funds.

23 Sec. 11. This act shall take effect and be in force from and after its  
24 publication in the Kansas register.
