1 AN ACT concerning the Kansas state employees health care commission;
2 changing membership thereon ~~to include a current and retired state~~
3 ~~employee enrolled in the state healthcare benefits program group health~~
4 ~~insurance medical plan~~; *providing responsibility to balance the*
5 *healthcare needs of state employees with the financial impact on the*
6 *state; requiring reports to the legislature on current and projected*
7 *reserve balances in the state healthcare benefits program*; amending
8 K.S.A. 75-6501, 75-6502 and 75-6509 and repealing the existing
9 ~~section sections~~.

11 *Be it enacted by the Legislature of the State of Kansas:*

12 **Section 1.** *K.S.A. 75-6501 is hereby amended to read as follows: 75-*
13 *6501. (a) Within the limits of appropriations made or available therefor*
14 *and subject to the provisions of appropriation acts relating thereto, the*
15 *Kansas state employees health care commission shall develop and*
16 *provide for the implementation and administration of a state health care*
17 *benefits program. The state employees health care commission shall*
18 *balance the healthcare needs of state employees at an affordable cost to*
19 *the employees with the financial impact on the state.*

20 *(b) (1) Subject to the provisions of paragraph (2), the state health*
21 *care benefits program may provide benefits for persons qualified to*
22 *participate in the program for hospitalization, medical services, surgical*
23 *services, nonmedical remedial care and treatment rendered in*
24 *accordance with a religious method of healing and other health services.*
25 *The program may include such provisions as are established by the*
26 *Kansas state employees health care commission, including, but not*
27 *limited to, qualifications for benefits, services covered, schedules and*
28 *graduation of benefits, conversion privileges, deductible amounts,*
29 *limitations on eligibility for benefits by reason of termination of*
30 *employment or other change of status, leaves of absence, military service*
31 *or other interruptions in service and other reasonable provisions as may*
32 *be established by the commission.*

33 *(2) The state health care benefits program shall provide the benefits*
34 *and services required by K.S.A. 75-6524, and amendments thereto.*

35 *(c) The Kansas state employees health care commission shall*
36 *designate by rules and regulations those persons who are qualified to*

1 *participate in the state health care benefits program, including active*
2 *and retired public officers and employees and their dependents as*
3 *defined by rules and regulations of the commission. Such rules and*
4 *regulations shall not apply to students attending a state educational*
5 *institution as defined in K.S.A. 76-711, and amendments thereto, who*
6 *are covered by insurance contracts entered into by the board of regents*
7 *pursuant to K.S.A. 75-4101, and amendments thereto. In designating*
8 *persons qualified to participate in the state health care benefits program,*
9 *the commission may establish such conditions, restrictions, limitations*
10 *and exclusions as the commission deems reasonable. Such conditions,*
11 *restrictions, limitations and exclusions shall include the conditions*
12 *contained in K.S.A. 75-6506(d), and amendments thereto. Each person*
13 *who was formerly elected or appointed and qualified to an elective state*
14 *office and who was covered immediately preceding the date such person*
15 *ceased to hold such office by the provisions of group health insurance or*
16 *a health maintenance organization plan under the law in effect prior to*
17 *August 1, 1984, or the state health care benefits program in effect after*
18 *that date, shall continue to be qualified to participate in the state health*
19 *care benefits program and shall pay the cost of participation in the*
20 *program as established and in accordance with the procedures*
21 *prescribed by the commission if such person chooses to participate*
22 *therein.*

23 *(d) (1) Commencing with the 2009 plan year that begins January 1,*
24 *2009, if a state employee elects the high deductible health plan and*
25 *health savings account, the state's employer contribution shall equal the*
26 *state's contribution to any other health benefit plan offered by the state.*
27 *The cost savings to the state for the high deductible health plan shall be*
28 *deposited monthly into the employee's health savings account up to the*
29 *maximum annual amount allowed pursuant to 26 U.S.C. § 223(d), as*
30 *amended, for as long as the employee participates in the high deductible*
31 *plan.*

32 *(2) If the employee had not previously participated in the state*
33 *health benefits plan, the employer shall calculate the average savings to*
34 *the employer of the high deductible plan compared to the other available*
35 *plans and contribute that amount monthly to the employee's health*
36 *savings account up to the maximum annual amount allowed pursuant to*
37 *26 U.S.C. § 223(d), as amended.*

38 *(3) The employer shall allow additional voluntary contributions by*
39 *the employee to their health savings account by payroll deduction up to*
40 *the maximum annual amount allowed pursuant to 26 U.S.C. § 223(d), as*
41 *amended.*

42 *(e) The commission shall have no authority to assess charges for*
43 *employer contributions under the student health care benefits*

1 *component of the state health care benefits program for persons who are*
2 *covered by insurance contracts entered into by the board of regents*
3 *pursuant to K.S.A. 75-4101, and amendments thereto.*

4 *(f) Nothing in this act shall be construed to permit the Kansas state*
5 *employees health care commission to discontinue the student health care*
6 *benefits component of the state health care benefits program until the*
7 *state board of regents has contracts in effect that provide student*
8 *coverage pursuant to the authority granted therefor in K.S.A. 75-4101,*
9 *and amendments thereto.*

10 *(g) (1) On and after July 1, 2018, the commission shall designate*
11 *claimants, as defined in K.S.A. 2020 Supp. 60-5004, and amendments*
12 *thereto, as qualified to participate in the state health care benefits*
13 *program. The commission shall implement this subsection in*
14 *accordance with applicable federal law, including, but not limited to, the*
15 *employee retirement income security act of 1974 and any regulations*
16 *issued by the United States department of the treasury.*

17 *(2) A claimant shall have 31 calendar days from the date of*
18 *judgment entered pursuant to K.S.A. 2020 Supp. 60-5004, and*
19 *amendments thereto, to complete or decline enrollment in the state*
20 *health care benefits program. A claimant shall be qualified to participate*
21 *in the state health care benefits program for the remainder of the plan*
22 *year when judgment is entered pursuant to K.S.A. 2020 Supp. 60-5004,*
23 *and amendments thereto, and for the next ensuing plan year. A claimant*
24 *shall not be qualified to elect a high-deductible health plan and health*
25 *savings account under the state health care benefits program.*

26 *(3) Costs of premiums under the state health care benefits program*
27 *for a claimant shall be paid from the tort claims fund established by*
28 *K.S.A. 75-6117, and amendments thereto, and shall not be charged to*
29 *the claimant. A claimant shall be responsible to pay any applicable*
30 *copayments, deductibles and other related costs under the state health*
31 *care benefits program.*

32 *(4) A claimant may elect to include the claimant's dependents under*
33 *the state health care benefits program. For any covered dependents, the*
34 *claimant shall be responsible to pay the costs of premiums, copayments,*
35 *deductibles and other related costs under the state health care benefits*
36 *program.*

37 *(5) The secretary of health and environment or the secretary's*
38 *designee shall provide assistance to a claimant to obtain and maintain*
39 *coverage under the state health care benefits program pursuant to this*
40 *subsection, including: Enrollment; maintenance of related records; and*
41 *other assistance as may be required or incidental to implement this*
42 *subsection.*

43 Section 1. *Sec. 2.* K.S.A. 75-6502 is hereby amended to read as

1 follows: 75-6502. (a) There is hereby established the Kansas state
2 employees health care commission which is composed of ~~five~~ **seven**
3 members as follows: (1) The commissioner of insurance; (2) the secretary
4 of administration; (3) a current state employee ~~in the classified service~~
5 ~~under the Kansas civil service act~~ *who is currently enrolled in the state*
6 *healthcare benefits program group health insurance medical plan,*
7 appointed by the governor; (4) a person who retired from a position in ~~the~~
8 ~~classified service under the Kansas civil service act~~ *state service and who*
9 *is currently enrolled in the state healthcare benefits program group health*
10 *insurance medical plan,* appointed by the governor; ~~and~~ (5) a
11 representative of the general public, appointed by the governor; (6) **a**
12 **member of the senate ways and means committee, appointed by the**
13 **president of the senate; and (7) a member of the house of representatives**
14 **appropriations committee, appointed by the speaker of the house of**
15 **representatives.** A state officer or employee may not be appointed as the
16 member representative of the general public.

17 (b) Each member appointed under this section by the governor shall
18 serve at the pleasure of the governor. ***The member appointed by the***
19 ***president of the senate shall serve at the pleasure of the president of the***
20 ***senate, and the member appointed by the speaker of the house of***
21 ***representatives shall serve at the pleasure of the speaker of the house of***
22 ***representatives.*** Not more than ~~three~~ **five** members of the commission
23 shall be members of the same political party.

24 (c) The chairperson of the commission shall be ~~designated by the~~
25 ~~governor~~ ***the commissioner of insurance in odd-numbered years and the***
26 ***secretary of administration in even-numbered years.*** The commission
27 shall meet at least once each calendar quarter and at such other times as
28 may be required on call of the chairperson or any three members thereof.

29 (d) A quorum of the Kansas state employees health care commission
30 shall be ~~three~~ **four**. All actions of the commission shall be taken by a
31 majority of all of the members of the commission.

32 (e) Members of the Kansas state employees health care commission
33 attending meetings of such commission, or attending a subcommittee
34 meeting thereof authorized by such commission, shall be paid
35 compensation, subsistence allowances, mileage and other expenses as
36 provided in K.S.A. 75-3223, and amendments thereto.

37 ***Sec. 3. K.S.A. 75-6509 is hereby amended to read as follows: 75-***
38 ***6509. Commencing with the regular session of the legislature in 1985***
39 ***and with each regular session of the legislature thereafter, the Kansas***
40 ***state employees health care commission shall submit to the president of***
41 ***the senate and to the speaker of the house of representatives, on the day***
42 ***the governor's budget report is submitted to the legislature,***
43 ***recommendations with respect to the state health care benefits program***

1 *together with estimates of the cost of the program proposed by the*
2 *commission, including a five-year projection of the cost of the program,*
3 *and the estimated cost of admitting each entity pursuant to ~~subsection (e)~~*
4 *of K.S.A. 75-6506(c), and amendments thereto. The recommendations*
5 *shall include a report on the current and projected reserve balance,*
6 *including as a percentage of total plan expenses. For any reserve balance*
7 *over 10% of expected plan expenses for the next plan year, the commission*
8 *shall provide recommendations for reducing reserves by minimizing*
9 *increases to employee contributions or cost-sharing requirements.*
10 *Together with the recommendations submitted, the commission shall*
11 *include alternatives for cost containment and benefit coverage for*
12 *qualified persons for both the proposed program and the five-year*
13 *projected program. The commission shall also submit any*
14 *recommendations for legislation with respect to the state health care*
15 *benefits program.*
