1 AN ACT concerning roads and highways; designating a portion of K-67
2 highway as the ~~COI~~ **COII** Trenton J Brinkman memorial highway;
3 **designating bridges on U.S. highway 54 as the Jack Taylor**
4 **memorial bridge and the Max Zimmerman memorial bridge;**
5 **designating a bridge on United States highway 77 as the PFC Loren**
6 **H Larson memorial bridge; designating a bridge on United States**
7 **highway 166 as the SGT Tyler A Juden memorial bridge{;**
8 **designating a portion of United States highway 69 as the Senator**
9 **Dennis Wilson memorial highway}.**

11 *Be it enacted by the Legislature of the State of Kansas:*

12 Section 1. The portion of K-67 from the southern limits of the Norton
13 correctional facility then north to the northern limits of the Norton
14 correctional facility in Norton county is hereby designated as the ~~COI~~
15 **COII** Trenton J Brinkman memorial highway. Upon compliance with
16 K.S.A. 68-10,114, and amendments thereto, the secretary of transportation
17 shall place suitable signs to indicate that the highway is the ~~COI~~ **COII**
18 Trenton J Brinkman memorial highway.

19 **Sec. 2. Bridge no. 54-88-17.86 (013) located on United States**
20 **highway 54 in Seward county is hereby designated as the Jack Taylor**
21 **memorial bridge. Upon compliance with K.S.A. 68-10,114, and**
22 **amendments thereto, the secretary of transportation shall place**
23 **suitable signs to indicate the bridge is the Jack Taylor memorial**
24 **bridge.**

25 **Sec. 3. Bridge no. 54-88-17.87 (006) located on United States**
26 **highway 54 in Seward county is hereby designated as the Max**
27 **Zimmerman memorial bridge. Upon compliance with K.S.A. 68-**
28 **10,114, and amendments thereto, the secretary of transportation shall**
29 **place suitable signs to indicate the bridge is the Max Zimmerman**
30 **memorial bridge.**

31 **Sec. 4. Bridge no. 0081-B0058 located on United States highway**
32 **77 in Riley county is hereby designated as the PFC Loren H Larson**
33 **memorial bridge. Upon compliance with K.S.A. 68-10,114, and**
34 **amendments thereto, the secretary of transportation shall place**

1 suitable signs to indicate that the bridge is the PFC Loren H Larson
2 memorial bridge.

3 **Sec. 5. Bridge no. 0018-0089 located on United States highway**
4 **166 in Cowley county is hereby designated as the SGT Tyler A Juden**
5 **memorial bridge. Upon compliance with K.S.A. 68-10,114, and**
6 **amendments thereto, the secretary of transportation shall place**
7 **suitable signs to indicate the bridge is the SGT Tyler A Juden**
8 **memorial bridge.**

9 {**Sec. 6. The portion of United States highway 69 from the**
10 **southern junction of United States highway 69 with interstate highway**
11 **435 in Johnson county, then south on United States highway 69 to the**
12 **junction of United States highway 69 and 135th street is hereby**
13 **designated as the Senator Dennis Wilson memorial highway. Upon**
14 **compliance with K.S.A. 68-10,114, and amendments thereto, the**
15 **secretary of transportation shall place highway signs along the**
16 **highway right-of-way at proper intervals to indicate that the highway**
17 **is the Senator Dennis Wilson memorial highway.}**
