Dear Education Committee Members,

I am a registered nurse with close to 20 years experience. I have worked in the medical field since 1997. I received my bachelors of science in nursing in 2000 from MidAmerica Nazarene University. I graduated in the top of my class with honors. My experience is in adult/pediatric med-surg. and postpartum care. Here's the red flag that prompted me to dig deeper into vaccines. Every pregnant woman, just prior to delivery, gets checked as to whether or not she's positive for Hep B. Even though she's negative the CDC states that a newborn, within the first two hours of life, should receive the Hep B vaccine. Hep B is transmitted most commonly through IV drug use (dirty needles) and sexual intercourse (mostly with prostitutes). This is absolutely unnecessary. This vaccine made no sense so I kept digging and digging. I have seen too many moms bullied into a vaccine that goes against their "gut." When bullying is part of the practice it, most often times, ends with a reaction or permanent injury. We need to start listening to those that know their child best, the parents.

How can vaccine mandates be made when:



**manufacturers carry ZERO liability?** So if you're injured by a vaccine you have to go to vaccine court (which takes years) and if you win you're essentially suing yourself and the American people because rewards are paid by taxpayers. Prior to 1986 the manufacturers were being sued so bad and so many injuries occurring that they threatened President Reagan to pull them off the market because they weren't making any money. So he passed a no liability act in 1986. HHS was supposed to oversee the safety of the vaccines and manufacturers since liability was removed. They were to deliver a written report every 2 years. This has never been done. Not one report.



**every vaccine insert states, "has not been evaluated for carcinogenic or mutagenic potential or for impairment of fertility?"** Look up any vaccine insert online or locate the actual physical insert. Scroll down to statement or bullet point 13.1 and here is where you will find this exact statement. Childhood cancer is the #1 disease related killer of children in the U.S.



**none have been tested against a true inert placebo?** Unfortunately, unlike all non-vaccine drugs licensed by the FDA, vaccines are not required to undergo long-term double-blind inert-placebo controlled trials to assess safety. In fact, not a single one of the clinical trials for vaccines given to babies and toddlers had a control group receiving an inert placebo. Further, most pediatric vaccines currently on the market have been approved based on studies with inadequate follow-up periods of only a few days or weeks. For example, there are two Hepatitis B vaccines licensed for one day old babies in the United States – one manufactured by Merck and the other by GlaxoSmithKline. Merck's Hepatitis B vaccine was licensed by the FDA after trials which solicited adverse reactions for only five days after vaccination. Similarly, GlaxoSmithKline's Hepatitis B vaccine was licensed by the FDA after trials which solicited adverse reactions for only four days after vaccination.



**a vaccine isn't just a live or dead virus and saline?** Adjuvants: like aluminum and formaldehyde are present.



**a vaccinated vs unvaccinated study has not been conducted?** It would be simple for the government to do a retrospective study.



**regulatory agencies (i.e. CDC & FDA) are a revolving door to high positions at drug companies?** For example Julie Gerberding.



**there is NOT true informed consent?** The information you're given prior to any vaccine is a sheet of commentary that is coming from the CDC. The CDC is more concerned about \$\$ than it is about the health and lives of the American people. Those making up the rules are also those that are benefiting from the profit of vaccines. If you're tied, in any way, to a vaccine profit then you shouldn't be making up the rules. Those working for the CDC also hold multiple patents on vaccines.
