Mobile Driver's Licensing


- ➤ In October, 2019 a Mobile Unit Coordinator was hired full time

- In 2019 the Quality Assurance team reviewed 14,846 transactions; 8,395 were completed for county treasurer offices, 1,430 for third party vendors (KMCA AND KVTSC) and the balance of 5,042 transactions for KDOR staff. The completion of the follow up reviews in 2019 overall we have seen stakeholders improve compliance in meeting the business process requirements for Titles and Registration of about 10%, CMV/IRP Registration of about 70% and Driver License issuance at 40%.
- The Quality Assurance team completed 73 County office reviews. Reviews consist of Drivers License, Titles, Commercial Vehicle and IRP. Other reviews also include our third party title contractor.
- Working toward implementation of National Motor Vehicle
 Title Information System (NMVTIS). NMVTIS is designed to
 prevent vehicle histories from being "washed" or concealed.
 All title information is electronically checked through a
 national database before titles are issued.
- Motor Vehicle Examination (MVE 1) collection Collecting vehicle inspection fees at title transaction event and passing the money through to Kansas Highway Patrol.
- Continue the monthly Dealer Licensing training for new dealers.
- Monthly conference calls with County Treasurers.

MOVRS classes & KCoVRS classes added a SME; Third party provider training; IRP/CMV renewal training through webinar, 18 were offered.


State Motor Vehicle Administration Overall Compliance
