While this bill was initially marketed as a way to provide opportunities for low-income families, it has become clear that families earning up to \$120,000 would be eligible for these credits. This removes any true "low-income" requirement and instead seems to be aimed at reimbursing families who are already sending their children to private schools.

Thank you for the opportunity to provide written testimony in opposition of SB 83.

I am writing to express my concern regarding SB 83 and respectfully request you vote against it. I believe public tax dollars should not be used to fund private tuition or provide private tuition tax credits. Although this bill was initially intended to help low-income families, it now includes families of four earning up to \$120,000, which is 400% above the poverty level. This change effectively eliminates any "low-income status," indicating that the bill was not designed to assist low-income students but to reimburse families already sending their children to private schools.

As a Kansan who actively participates in our political process, I am disappointed this bill was not given enough time and transparency to allow for accurate voter testimony to be submitted in a timely manner. If the bill is to stand on its own, Kansans should be given adequate time to express their support or opposition.

Furthermore, after providing oral testimony to HB2218 and being called up for additional questions, I was told the low-income students in my district who were not achieving adequate progress on state assessments deserved an alternative. In all due respect, I ask by what measures will private schools will be held accountable? How will you know when this 'experiment' has been a success or failure unless all schools are held to the exact same standards? If your answer is private schools should not be held to the same scrutiny as public schools, then I would suggest any conversation regarding state assessments for any district be avoided in any future dialog.

Madam Chair, Members of the Committee;

I am writing today because I am opposed to any expansion to the tax credit scholarship program and urge you to vote NO on this bill.

There Is Harm

There are some who say that because this program doesn't take money *directly* away from the General Fund or because it is money that the state *never received* in the first place it is somehow not taking money away from the state so there is no fiscal harm. This is a particularly cynical and self-serving view which deliberately ignores the fact that tax credits are a significant reduction in a person or entity's tax bill. In the absence of these credits, some or all of the taxes that would have gone to Kansas' general fund.

This bill, as written, is nothing more than a way to subsidize private educational choices with public money.

Here's an example of how it will work:

- A family of four with an income of \$110,000 owes \$10,000 in private school tuition.
- They are encouraged to donate the value of their tuition to a TCS.
- Because their income is below 400% federal poverty level (\$111,000 in 2022) their children will qualify for scholarships.
- Tuition is given to the private school by the TCS.
- Because they filtered their tuition through at TCS, the family receives \$7,500 (75% of their tuition payment) from Kansas in the form of a tax credit, effectively reducing their tuition bill to \$2,500.
- If they owe less than \$7,500 in Kansas tax (which they likely do, given their income), they pay no state tax (probably for several years) until the amount they owe in tax exceeds their credit.

This cycle can be repeated each year, preventing Kansas from collecting taxes needed to pay not only for education but for other vital services that serve all Kansans.

Allowing up to \$20 million in tax dollars to evaporate this way so a few children can attend a private (probably religious) school is a dereliction of this committee's obligation to work towards the betterment of Kansas and education programs that serve ALL Kansas children.

Tax Credits for Private Services are Strange in Any Other Context

I can't help but feel like this program is one that sacrifices income that could be used to serve all Kansans in order to support a minority's private choices and that's weird and wrong.

If we use this mechanism to fund private school attendance, why not other private choices? Some people don't like public transportation and want to use a private car. Kansas could set up private car granting organizations. You may think this is a farcical example, but it is not. It is exactly the same thing as what this bill proposes. My local community pays for public transportation. The state pays for public education. I don't like public transportation, I want to use a car. I don't like public schools, I want my child to attend a private one. If I give to an organization that funds private school tuition, I get a tax credit. If I give to an organization that

gives certain people cars, I get a tax credit. How is it different? The same mechanism could be set up for lots for other things but because schools and kids are involved, we are made to feel that it is somehow different but it is not. We are not “saving kids”, we are facilitating unnecessary tax diversion and funding private choices.

What's the Point and How Will We Know It's Working?

When the TCS program was first proposed and passed, we were told the point of the program was only to lift up a minority of the poorest public elementary school students. The parameters were narrow. It wasn't long before the parameters shifted. Today, the TCS is open to K-8 students. This bill proposes including high school students. The TCS is currently only for families that qualified for free or reduced lunch (130% and 185% of federal poverty guidelines, respectively). This bill is proposing a jump to 400% of federal poverty guidelines. That's \$111,000 for a family of four. The parameters keep shifting and it's clear that growing the program is the point. The broader the parameters, the more kids that qualify and the more attractive Kansas is to the private school industry. They are the true beneficiaries of this plan, not kids.

As a taxpayer, I am concerned that this bill grows a program that encourages private schools to set up shop in our state by giving them taxpayer dollars without fiscal oversight. In any other circumstance, this legislature would expect thorough reporting in exchange for public funds. It is irresponsible not to put financial reporting requirements on participating schools. Similarly, this bill does nothing to protect children and ensure they are getting an appropriate education. Facilitating the move to private schools without setting educational standards and requiring participating private schools to prove they are meeting state-established educational goals risks the future of any child enrolled in the program. Any school receiving tax dollars, even indirectly, should be required to provide student progress data sufficient to prove their students learning as expected. Without data, Kansas is throwing money away and risking the futures of the young scholars you seek to protect.

Public schools are one of Kansas' strengths. If families of public school children find room for improvement, then please work to make those improvements so all Kansas children can thrive. Families who feel they want an educational experience that more closely aligns with their personal values and beliefs outside the public schools should always have that option to do so. However, I urge you to remember it is not the obligation of the state to fund private choices made in lieu of public services and to vote no on this bill.

The quality education I received in Kansas public schools provided the foundation for my life, including my pursuit of higher education.

I am now an attorney and mother of three children, all of whom will attend Kansas public schools. I request that you please vote no on Senate Bill 83 because it will hurt public education and reduce the opportunities for other children in the state to receive a quality public education.

Senate Bill 83 will divert public tax dollars to private schools at a time when legislators should be focused on the **\$160 million shortfall in special education funding**. The state should fully fund special education, not private schools. Using public taxpayer dollars for private schools drains the public schools of needed resources for successful student learning.

I know this testimony is coming in less than the required 48 hours' notice period, but this hearing was not announced until this afternoon, and the hearing is tomorrow. Please consider this testimony.

I am writing to voice my opposition to bill SB 83.

Public tax dollars should not be used to fund private tuition or for private tuition tax credits. This bill was supposed to provide funding for at risk students, especially those of low income, to be able to have a choice a private school if it better met their needs. It has now been amended to include families of 4 making \$120,00 per year. This is 400% of the poverty level. This removes any low-income status, which shows the bill was never intended to help at-risk students. I work in a Title 1, ELL school and if this bill passes, funding for at-risk students and special education services will likely be cut. This harms at-risk students; it does not help them.

Private schools are under no obligation to accept all students, and they have zero accountability standards they must meet. The very students this bill claims to help, are the ones who will be left out in the cold, when the private school decides they do not want to deal with a language barrier, behavior disorder, need for an IEP or SPED services or any other reason they choose not to accept that student. Chairwoman Williams, members of the committee, thank you for the opportunity to submit written testimony in opposition to Senate Bill 83.

Kansas NEA has opposed these tax credits since their origin years ago. This bill is not about helping low-income children. It is nothing more than a tax break for wealthy Kansans and corporations on the backs of Kansas public schools and their students. Particularly now after it was amended on the floor of the Senate to expand eligibility to students from families at 400% above the poverty level (\$120,000 for a family of four).

Under Senate Bill 83 as amended, a corporation or wealthy individual can contribute up to the maximum of \$100,000 in a year and the state will grant that corporation or individual a 75% tax credit. This means \$75,000 of the contribution is knocked off the donor's tax liability. If the donor owes less than that amount in taxes, the remainder can be carried into the future and used against later tax liability. There is no other charitable tax credit in Kansas like this.

Proponents of this "scholarship program" will argue that no money is being taken away from public schools. That is technically true. Instead, it is a shell game. This provides up to \$20 million in tax credits for donors who make contributions to "scholarship granting organizations" who then turn around and give it to a student in the form of a "scholarship," which is spent at participating private schools. This program takes public dollars away from the state general fund for the purpose of supplementing the budgets of private schools.

These private schools get to be selective on the students they accept. A brief review of admissions policies of schools currently participating in the "scholarship" program shows how these schools reserve the right to discriminate against children based on their religion as well as their needs, abilities, and academic performance. Taxpayer dollars should not be helping cover the costs of these discriminatory practices.

Since its inception, more than \$21 million in tax credits have been granted through this program, but what have Kansans gotten for it? As legislators you often ask about the return on investment related to programs. You question whether our public schools are producing results worthy of your investment. You ask what the relationship is between spending and learning outcomes. Yet, in this bill, you are willing to expand a program and give away millions more in taxpayer money to schools that will never report results to you.

SB 83 expands a program that does not benefit all Kansas students. Instead, it encourages cherry picking of students by private schools, and it allows state dollars to be used to send children to unaccountable, and often for-profit private schools.

We urge you to reject this bill and return the millions of dollars to the state general fund for the purpose of serving all Kansans.

I have been following the activity of SB 83 and HB2218. I am writing in support of our local public schools. I would ask that you do not proceed with this scholarship bill that will divert an estimated \$150 million dollars in public funds from public schools.

This bill should have never been passed out of committee. Of the 296 pieces of testimony shared with the committee, only 26 supported the bill. Over 90% of testimony was in opposition of “student scholarships” - 252 of those opposed were from local citizens in Kansas.

In reviewing the activity being considered in committee including this current bill, it appears that outside special interest groups are trying to influence the Kansas Legislature in defunding Public K-12 Education in our State once again.
