## 2023 Kansas Statutes

75-3680. Same; terms and conditions of repayment. Commencing in calendar year 1988, the principal and interest of such loan amounts shall be repaid in payments payable annually in the month of March over a period of 15 years. The repayment amounts shall be recomputed each year to reflect the interest rate prescribed by K.S.A. 753679 and shall be calculated each year on a substantially level payment basis based on a total original amortization period of 15 years.
