Are there sufficient limits on type of "fund raising events"? Could they occur every day/night? Would such a definition allow regular open public events? What is the difference from a DE license? Such distinctions are necessary to know what license an establishment should have and what practices are allowed. This is a very important issue to our members.

I realize that you are not re-addressing the comprehensive issue of all on-premise licenses so I will not expand in that area other than to ask that if you do now or in the future, to please be allowed to offer you further current information.
