1 AN ACT concerning sheriffs; relating to fees; amending K.S.A. 2011  
2 Supp. 28-110 and repealing the existing section.

3 *Be it enacted by the Legislature of the State of Kansas:*

4 Section 1. K.S.A. 2011 Supp. 28-110 is hereby amended to read as  
5 follows: 28-110. (a) The sheriff of each county in the state shall charge the  
6 following fees for the services required by law to be performed by them:  
7 \$30 for serving, executing and returning, or endeavoring to serve, execute  
8 and return, any writ, process, order, notice, summons, or any alias thereof,  
9 including a copy of the same, whenever a copy is required by law, except  
10 as otherwise provided, for the first person.

1 person, no fee shall be taxed or allowed and no person shall be required to  
 2 pay any fee unless at the time of making returns the sheriff makes and files  
 3 with the returns, or as a part thereof, a statement showing the service on  
 4 the first person named by the sheriff and the service on the second person  
 5 named by the sheriff and so on for each person served. If more than one  
 6 process is served in the same case or on the same person, not requiring  
 7 more than one journey from the office, the sheriff shall charge a fee for  
 8 one service only.

9 (b) If more than one process for the same person, or in the same case,  
 10 is issued and is in the hands of the sheriff at one time, it shall be the duty  
 11 of the sheriff to make service of the processes, if possible, on the one trip  
 12 for a single fee.

13 (c) If more than one process for the same address, in the same case,  
 14 is issued and is in the hands of the sheriff at one time, one fee shall be  
 15 charged.

16 (d) Where service is not affected or timely return is not made  
 17 pursuant to K.S.A. 60-312 or 61-3005, and amendments thereto, no fee  
 18 shall be taxed or allowed on subsequent alias, writ, process, order or notice  
 19 as required to effect service and the return of service.

20 (e) Except as provided by K.S.A. 19-269, and amendments thereto,  
 21 the sheriff shall be reimbursed for the necessary transportation and board  
 22 expenses incurred while serving under requisition made by the governor.

23 (f) All fees charged by the sheriff pursuant to this section for the same  
 24 case may be paid by a single check, money order or other form of payment  
 25 at the discretion of the person making such payment.

26 (g) The state of Kansas and all municipalities in this state, as defined  
 27 in K.S.A. 12-105a, and amendments thereto, are hereby exempt, in any  
 28 civil action in which such state or municipality is involved, from paying  
 29 service of process fees prescribed herein, except that such exemption shall  
 30 not apply when the case is filed by a nongovernmental firm on behalf of  
 31 the state or any municipality for the purpose of debt collection.

32 Sec. 2. K.S.A. 2011 Supp. 28-110 is hereby repealed.

33 Sec. 3. This act shall take effect and be in force from and after its  
 34 publication in the statute book.
