1 AN ACT concerning driver's licenses; relating to motorcycles; amending
2 K.S.A. 2011 Supp. 8-240 and repealing the existing section.

4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. K.S.A. 2011 Supp. 8-240 is hereby amended to read as
6 follows: 8-240. (a) (1) Every application for an instruction permit shall be
7 made upon a form furnished by the division of vehicles and accompanied
8 by a fee of \$2 for class A, B, C or M and \$5 for all commercial classes.
9 Every other application shall be made upon a form furnished by the
10 division and accompanied by an examination fee of \$3, unless a different
11 fee is required by K.S.A. 8-241, and amendments thereto, and by the
12 proper fee for the license for which the application is made. If the
13 applicant is not required to take an examination the examination fee shall
14 not be required. The examination shall consist of three tests, as follows: (1)
15 (A) Vision; (2)(B) written; and (3)(C) driving. If the applicant fails the
16 vision test, the applicant may have correction of vision made and take the
17 vision test again without any additional fee. If an applicant fails the written
18 test, the applicant may take such test again upon the payment of an
19 additional examination fee of \$1.50. If an applicant fails the driving test,
20 the applicant may take such test again upon the payment of an additional
21 examination fee of \$1.50. If an applicant fails to pass all three of the tests
22 within a period of six months from the date of original application and
23 desires to take additional tests, the applicant shall file an application for
24 reexamination upon a form furnished by the division, which shall be
25 accompanied by a reexamination fee of \$3, except that any applicant who
26 fails to pass the written or driving portion of an examination four times
27 within a six-month period, shall be required to wait a period of six months
28 from the date of the last failed examination before additional examinations
29 may be given. Upon the filing of such application and the payment of such
30 reexamination fee, the applicant shall be entitled to reexamination in like
31 manner and subject to the additional fees and time limitation as provided
32 for examination on an original application. If the applicant passes the
33 reexamination, the applicant shall be issued the classified driver's license
34 for which the applicant originally applied, which license shall be issued to

1 expire as if the applicant had passed the original examination.

2 (2) *Applicants for class M licenses who have completed prior*
3 *motorcycle safety training in accordance with department of defense*
4 *instruction 6055.04 (DoDI 6055.04) are not required to complete further*
5 **written and driving ~~training~~ {testing} ~~or testing~~** *pursuant to paragraph (1)*
6 *of this subsection.*

7 (b) (1) For the purposes of obtaining any driver's license or
8 instruction permit, an applicant shall submit, with the application, proof of
9 age and proof of identity as the division may require. The applicant also
10 shall provide a photo identity document, except that a non-photo identity
11 document is acceptable if it includes both the applicant's full legal name
12 and date of birth, and documentation showing the applicant's name, the
13 applicant's address of principal residence and the applicant's social security
14 number. The applicant's social security number shall remain confidential
15 and shall not be disclosed, except as provided pursuant to K.S.A. 74-2012,
16 and amendments thereto. If the applicant does not have a social security
17 number the applicant shall provide proof of lawful presence and Kansas
18 residency. The division shall assign a distinguishing number to the license
19 or permit.

20 (2) The division shall not issue any driver's license or instruction
21 permit to any person who fails to provide proof that the person is lawfully
22 present in the United States. Before issuing a driver's license or instruction
23 permit to a person, the division shall require valid documentary evidence
24 that the applicant: (A) Is a citizen or national of the United States; (B) is an
25 alien lawfully admitted for permanent or temporary residence in the
26 United States; (C) has conditional permanent resident status in the United
27 States; (D) has an approved application for asylum in the United States or
28 has entered into the United States in refugee status; (E) has a valid,
29 unexpired nonimmigrant visa or nonimmigrant visa status for entry into
30 the United States; (F) has a pending application for asylum in the United
31 States; (G) has a pending or approved application for temporary protected
32 status in the United States; (H) has approved deferred action status; or (I)
33 has a pending application for adjustment of status to that of an alien
34 lawfully admitted for permanent residence in the United States or
35 conditional permanent resident status in the United States.

36 (3) If an applicant provides evidence of lawful presence set out in
37 subsections (b)(2)(E) through (2)(I), or is an alien lawfully admitted for
38 temporary residence under subsection (b)(2)(B), the division may only
39 issue a driver's license to the person under the following conditions: (A) A
40 driver's license issued pursuant to this subparagraph shall be valid only
41 during the period of time of the applicant's authorized stay in the United
42 States or, if there is no definite end to the period of authorized stay, a
43 period of one year; (B) a drivers' license issued pursuant to this

1 subparagraph shall clearly indicate that it is temporary and shall state the
2 date on which it expires; (C) no driver's license issued pursuant to this
3 subparagraph shall be for a longer period of time than the time period
4 permitted by subsection (a) of K.S.A. 8-247, and amendments thereto; and
5 (D) a driver's license issued pursuant to this subparagraph may be
6 renewed, subject at the time of renewal, to the same requirements and
7 conditions as set out in this subsection (b) for the issuance of the original
8 driver's license.

9 (4) The division shall not issue any driver's license or instruction
10 permit to any person who is not a resident of the state of Kansas, except as
11 provided in K.S.A. 8-2,148, and amendments thereto.

12 (5) The division shall not issue a driver's license to a person holding a
13 driver's license issued by another state without making reasonable efforts
14 to confirm that the person is terminating or has terminated the driver's
15 license in the other state.

16 (6) The parent or guardian of an applicant under 16 years of age shall
17 sign the application for any driver's license submitted by such applicant.

18 (c) Every application shall state the full legal name, date of birth,
19 gender and address of principal residence of the applicant, and briefly
20 describe the applicant, and shall state whether the applicant has been
21 licensed as a driver prior to such application, and, if so, when and by what
22 state or country. Such application shall state whether any such license has
23 ever been suspended or revoked, or whether an application has ever been
24 refused, and, if so, the date of and reason for such suspension, revocation
25 or refusal. In addition, applications for commercial drivers' licenses and
26 instruction permits for commercial licenses must include the following:
27 The applicant's social security number; the person's signature; the person's
28 colored digital photograph; certifications, including those required by 49
29 C.F.R. 383.71(a), effective January 1, 1991; a consent to release driving
30 record information; and, any other information required by the division.

31 (d) When an application is received from a person previously licensed
32 in another jurisdiction, the division shall request a copy of the driver's
33 record from the other jurisdiction. When received, the driver's record shall
34 become a part of the driver's record in this state with the same force and
35 effect as though entered on the driver's record in this state in the original
36 instance.

37 (e) When the division receives a request for a driver's record from
38 another licensing jurisdiction the record shall be forwarded without charge.

39 (f) A fee shall be charged as follows:

40 (1) For a class C driver's license issued to a person at least 21 years of
41 age, but less than 65 years of age, \$18;

42 (2) for a class C driver's license issued to a person 65 years of age or
43 older, \$12;

1 (3) for a class M driver's license issued to a person at least 21 years of
2 age, but less than 65 years of age, \$12.50;

3 (4) for a class M driver's license issued to a person 65 years of age or
4 older, \$9;

5 (5) for a class A or B driver's license issued to a person who is at least
6 21 years of age, but less than 65 years of age, \$24;

7 (6) for a class A or B driver's license issued to a person 65 years of
8 age or older, \$16;

9 (7) for any class of commercial driver's license issued to a person 21
10 years of age or older, \$18; or

11 (8) for class A, B, C or M, or a farm permit, or any commercial
12 driver's license issued to a person less than 21 years of age, \$20.

13 A fee of \$10 shall be charged for each commercial driver's license
14 endorsement, except air brake endorsements which shall have no charge.

15 A fee of \$3 per year shall be charged for any renewal of a license issued
16 prior to the effective date of this act to a person less than 21 years of age.

17 If one fails to make an original application or renewal application for a
18 driver's license within the time required by law, or fails to make
19 application within 60 days after becoming a resident of Kansas, a penalty
20 of \$1 shall be added to the fee charged for the driver's license.

21 (g) Any person who possesses an identification card as provided in
22 K.S.A. 8-1324, and amendments thereto, shall surrender such
23 identification card to the division upon being issued a valid Kansas driver's
24 license or upon reinstatement and return of a valid Kansas driver's license.

25 (h) The division shall require that any person applying for a driver's
26 license submit to a mandatory facial image capture.

27 (i) The director of vehicles may issue a temporary driver's license to
28 an applicant who cannot provide valid documentary evidence as defined
29 by subsection (b)(2), if the applicant provides compelling evidence
30 proving current lawful presence. Any temporary license issued pursuant to
31 this subsection shall be valid for one year.
