1 AN ACT concerning elections; relating to voting; regarding penalties for
2 voting crimes; concerning prosecution of election crimes; amending
3 K.S.A. 25-2409, 25-2416, 25-2423 and 25-2431 and K.S.A. 2012 Supp.
4 25-1128 and 25-2507 and repealing the existing sections.
5

6 *Be it enacted by the Legislature of the State of Kansas:*

7 *{New Section 1. (a) Except as provided in subsection (b), the*
8 *secretary of state shall not establish any political committee, a major*
9 *purpose of which is to expressly advocate the nomination, election or*
10 *defeat of a clearly identified candidate for the legislature or statewide*
11 *office or make contributions or expenditures for the nomination,*
12 *election or defeat of a clearly identified candidate for the legislature or a*
13 *statewide office.*

14 *(b) The provisions of this section shall not apply to any political*
15 *committee which is established to expressly advocate for the election of a*
16 *candidate for the office of secretary of state or to make contributions or*
17 *expenditures for the election of a candidate for the office of secretary of*
18 *state.*

19 *(c) Any political committee currently in existence, which is in*
20 *violation of subsection (a), is hereby abolished.*

21 *(d) The provisions of this section shall be part of and supplemental*
22 *to the campaign finance act.*

23 ~~New Section 1. {Sec. 2.}~~ (a) Voting more than once is knowingly
24 ~~intentionally.~~

25 (1) Voting or offering attempting to vote more than once in the same
26 jurisdiction or voting in more than one jurisdiction in the United States in
27 an election held on a particular date.

28 (2) Inducing or aiding any person to vote more than once in the same
29 jurisdiction or voting in more than one jurisdiction in the United States in
30 an election held on a particular date.

31 (b) Voting more than once is a severity level nonperson felony.

32 (c) *This section shall be part of and supplemental to article 24 of*
33 *chapter 25 of the Kansas Statutes Annotated, and amendments thereto.*

34 ~~New Sec.-2. {3.}~~ (a) Independent authority to prosecute any person

1 who has violated or attempted to violate any act that constitutes a Kansas
2 elections crime defined in K.S.A. 25-2401 through 25-2433, and
3 amendments thereto, and including this act 25-1128 or article 24 of
4 chapter 25 of the Kansas Statutes Annotated, and amendments thereto,
5 shall be vested in:

6 (1) The district attorney or county attorney of the county where such
7 violations occurred;

8 (2) the Kansas attorney general;

9 ~~(3) the Kansas secretary of state;~~

10 (b) If one of the officers listed in section (a) has commenced the
11 prosecution of a person who has violated or attempted to violate any act
12 that constitutes a Kansas election crime, the other officers listed in section
13 (a) may provide assistance to the prosecuting officer but may not
14 commence a separate prosecution.

15 Sec. 3-4, K.S.A. 2012 Supp. 25-1128 is hereby amended to read as
16 follows: 25-1128. (a) No voter shall knowingly mark or transmit to the
17 county election officer more than one advance voting ballot, or set of one
18 of each kind of ballot, if the voter is entitled to vote more than one such
19 ballot at a particular election.

20 (b) Except as provided in K.S.A. 25-1124, and amendments thereto,
21 no person shall knowingly interfere with or delay the transmission of any
22 advance voting ballot application from a voter to the county election
23 officer, nor shall any person mail, fax or otherwise cause the application to
24 be sent to a place other than the county election office. Any person or
25 group engaged in the distribution of advance voting ballot applications
26 shall mail, fax or otherwise deliver any application signed by a voter to the
27 county election office within two days after such application is signed by
28 the applicant.

29 (c) Except as otherwise provided by law, no person other than the
30 voter, shall knowingly mark, sign or transmit to the county election officer
31 any advance voting ballot or advance voting ballot envelope.

32 (d) Except as otherwise provided by law, no person shall knowingly
33 sign an application for an advance voting ballot for another person. This
34 provision shall not apply if a voter has a disability preventing the voter
35 from signing an application or if an immediate family member signs an
36 application on behalf of another immediate family member with proper
37 authorization being given.

38 (e) No person, unless authorized by K.S.A. 25-1122 or K.S.A. 25-
39 1124, and amendments thereto, shall knowingly intercept, interfere with,
40 or delay the transmission of advance voting ballots from the county
41 election officer to the voter.

42 (f) No person shall knowingly and falsely affirm, declare or subscribe
43 to any material fact in an affirmation form for an advance voting ballot or

or

1 set of advance voting ballots.

2 (g) A voter may return such voter's advance voting ballot to the
3 county election officer by personal delivery or by mail. Upon written
4 designation by the voter, a person other than the voter may return the
5 advance voting ballot by personal delivery or mail. Any such person
6 designated by the voter shall sign a statement that such person has not
7 exercised undue influence on the voting decisions of the voter and agrees
8 to deliver the ballot as directed by the voter.

9 (h) Violation of any provision of this section is a ~~class C~~
10 ~~misdemeanor~~ ^{class A misdemeanor}.

11 Sec. 4-15.} K.S.A. 25-2409 is hereby amended to read as follows: 25-
12 2409. (a) Election bribery is conferring, offering or agreeing to confer, or
13 soliciting, accepting or agreeing to accept any benefit as consideration to
14 or from any person either to vote or withhold any person's vote, or to vote
15 for or against any candidate or question submitted at any public election.

16 (b) *This section shall not apply to a business or organization that*
17 *provides a product of a value less than \$3.00 to any person who asserts*
18 *that such person has voted, without regard to the voter's vote for or*
19 *against any candidate or issue.*

20 (c) Election bribery is a severity level 7, nonperson felony.

21 Sec. 5-16.} K.S.A. 25-2416 is hereby amended to read as follows: 25-
22 2416. (a) Voting without being qualified is knowingly and willfully: (a):

23 (1) Voting or attempting to vote ~~at~~ *in* any election district when not a
24 lawfully registered voter; *in such election district; or*

25 (b)(2) ~~Voting or offering to vote more than once at the same~~
26 ~~election or attempting to vote at any election by a person who is not~~
27 ~~a citizen of the United States or who does not otherwise meet the~~
28 ~~qualification of an elector.~~

29 (c)(b) ~~Inducing or aiding any person to vote more than once at the~~
30 ~~same election; Voting without being qualified is a class A misdemeanor~~
31 ~~severity level 7 nonperson felony.~~ 9

32 Sec. 6-17.} K.S.A. 25-2423 is hereby amended to read as follows: 25-
33 2423. (a) Election tampering is, while being charged with no election duty,
34 making or changing any election record.

35 (b) Election tampering is a severity level 8 ⁷ nonperson felony. 8

36 Sec. 7-18.} K.S.A. 25-2431 is hereby amended to read as follows: 25-
37 2431. (a) False impersonation of a voter is representing oneself as another
38 person whether real or fictitious and ~~thereas~~ *thereby* voting or attempting
39 to vote.

40 (b) False impersonation of a voter is a severity level 9 ⁸ nonperson
41 felony. 9

42 Sec. 8-19.} K.S.A. 2012 Supp. 25-2507 is hereby amended to read as
43 follows: 25-2507. (a) "Poll book" means a book in which each voter may

Sec. 9. In addition to any sentence that may be imposed for a violation of article 24 of chapter 25 of the Kansas Statutes Annotated, and amendments thereto, the court shall order the right of the convicted person to vote be disenfranchised for a period of three years. The court shall direct that a copy of the order disenfranchising the right to vote be delivered to the election officer of the county of residence of the convicted person and the secretary of state for the purpose of removing the defendant from the official records for voter registration.

2 the election board when the voter is given a ballot or set of ballots. If the
3 county election officer determines that voters shall sign the poll book, such
4 book shall also contain on each page the declaration prescribed by
5 subsection (d).

6 (b) "Registration book" means: (1) A book or list containing the
7 names and other information relating to registered voters. Registration
8 books shall have the names entered therein before the same or copies
9 thereof are delivered to the supervising judges. Registration books may
10 also contain blank lines on which each voter shall sign the voter's
11 signature. If the county election officer determines that voters shall sign
12 the registration book, such book shall also contain on each page the
13 declaration prescribed by subsection (d); or

14 (2) a book meeting the requirements of K.S.A. 25-2507 (b)(1), and
15 amendments thereto; containing blank lines on which each voter shall sign
16 the voter's signature; containing on each page the declaration prescribed
17 by subsection (d); and containing the numbers assigned by one of the
18 clerks of the election board when voters are given ballots or sets of ballots.

19 (c) "Party affiliation lists" means a list containing the names of all
20 registered voters of a county who have lawfully designated a party
21 affiliation.

22 (d) "Declaration" means the following: "I, the undersigned, declare
23 under penalty of perjury that I am a registered voter in the state of Kansas,
24 county of _____, that I have not signed a name other than my own in
25 order to represent myself as any other registered voter, and that I am
26 qualified to vote and have not previously voted and will not vote again-at
27 this-election in the election held on this date, in this or any other
28 jurisdiction in the United States; for any offices or ballot issues."
