Mr. Chairman and members of the committee. Thank you for the opportunity to testify on this bill. ABC is opposed to this bill as it is written.

Under current law, convicted felons can be employed in establishments licensed by the ABC but are prohibited from dispensing or serving alcoholic liquor. For example, they can be employed as a cook, dishwasher or door person. They cannot be a bartender or serve alcoholic liquor directly to customers.

Keeping the criminal element out of the liquor industry is a priority of the ABC. A person convicted of any type of felony cannot be an owner or officer of an entity owning a liquor license.

ABC was asked by the Department of Corrections to review their bill proposal and provide feedback. The ABC recommended retaining certain specified convictions and allowing persons convicted of certain non-person felonies be allowed to dispense and serve alcoholic liquor.

Allowing convicted felons, particularly of sex or violent crimes, to dispense and serve alcoholic liquor could present a public safety issue. To remedy this, the ABC respectfully requests that our recommendation submitted to the Department of Corrections be adopted.

I have attached a copy of the response ABC submitted to the Department of Corrections for your review.

ABC RESPONSE REGARDING DEPARTMENT OF CORRECTIONS LEGISLATIVE PROPOSAL DEC. 2016

41-2610. Unlawful acts of licensee; employment restrictions. It shall be unlawful for any licensee or holder of a temporary permit under this act to:

(a) Employ any person under the age of 18 years in connection with the serving of alcoholic liquor.

(b) Employ knowingly or continue in employment any person in connection with the dispensing or serving of alcoholic liquor or the mixing of drinks containing alcoholic liquor who has been adjudged guilty of a felony or of any crime involving a morals charge in this or any other state, or of the United States.

(c) Knowingly employ or continue to employ any person in connection with the dispensing or serving of alcoholic liquor, or the mixing of drinks containing alcoholic liquor, who has been adjudged guilty of two or more violations of K.S.A. 2014 Supp. 21-5607, and amendments thereto, furnishing alcoholic liquor to minors or a similar law of any other state, or of the United States, pertaining to furnishing alcoholic liquor to minors within the immediately preceding five years, or who has been adjudged guilty of three or more violations of any intoxicating liquor law of this or any other state, or of the United States, not involving the furnishing of alcoholic liquor to minors within the immediately preceding five years.

(d) In the case of a club, fail to maintain at the licensed premises a current list of all members and their residence addresses or refuse to allow the director, any of the director's authorized agents or any law enforcement officer to inspect such list.

(e) Purchase alcoholic liquor from any person except from a person authorized by law to sell such alcoholic liquor to such licensee or permit holder.

(f) Permit any employee of the licensee or permit holder who is under the age of 21 years to work on premises where alcoholic liquor is sold by such licensee or permit holder at any time when not under the on-premises supervision of either the licensee or permit holder, or an employee who is 21 years of age or over.

(g) Employ any person under 21 years of age in connection with the mixing or dispensing of drinks containing alcoholic liquor.
