Services taxed in HB 2384

House Bill 2384 imposes sales tax on a number of services not previously taxed in Kansas beginning January 1, 2018. Any service that is currently taxed under Kansas law would continue to be taxed under the provisions of the bill. Additionally, the bill would remove a current sales tax exemption for non-profit gym memberships<sup>1</sup>. The new services being taxed are described by their industry code as established by the North American Industry Classification System (NAICS). Below is a brief description of each code, as provided by the NAICS Association<sup>2</sup>.

- 488410 Motor Vehicle Towing comprises establishments primarily engaged in towing light or heavy motor vehicles, both local and long distance. These establishments may provide incidental services, such as storage and emergency road repair services.
- 561611 **Investigation Services** comprises establishments primarily engaged in providing investigation and detective services.
- 561612 **Security Guards and Patrol Services** -- establishments primarily engaged in selling, installing, monitoring and maintaining security systems and devices such as burglar and fire alarms and locking devices.
- 561621 Security Systems Services (except Locksmiths) comprises establishments primarily engaged in (1) selling security alarm systems, such as burglar and fire alarms, along with installation, repair or monitoring services or (2) remote monitoring of electronic security alarm systems.
- 561720 Janitorial Services<sup>3</sup> -- comprises establishments primarily engaged in cleaning building interiors, interiors of transportation equipment (e.g., aircraft, rail cars, ships), and/or windows.

- 812111 **Barber Shops** comprises establishments known as barber shops or men's hair stylist shops primarily engaged in cutting, trimming and styling men's and boy's hair; and/or shaving and trimming men's beards.
- 812112 **Beauty Salons** comprises establishments (except those known as barber shops or men's hair stylist shops) primarily engaged in one or more of the following: (1) cutting, trimming, shampooing, coloring, waving, or styling hair; (2) providing facials; and (3) applying makeup (except permanent makeup).
- 812113 Nail Salons comprises establishments primarily engaged in providing nail care services, such as manicures, pedicures and nail extensions.
- 812199 Other Personal Care Services comprises establishments primarily engaged in providing personal care services (except hair, nail, facial, nonpermanent makeup, or nonmedical diet and weight reducing services).
- 812910 Pet Care (except Veterinary) Services comprises establishments primarily
  engaged in providing pet care services (except veterinary), such as boarding, grooming,
  sitting and training pets.
- 812930 Parking Lots and Garages comprises establishments primarily engaged in providing parking space for motor vehicles, usually on an hourly, daily, or monthly basis and/or valet parking services.
- 812990 **All Other Personal Services**<sup>4</sup> comprises establishments primarily engaged in providing personal services (except personal care services, death care services, dry cleaning and laundry services, pet care services, photofinishing services, or parking space and/or valet parking services).
