1 AN ACT concerning cities; relating to the rehabilitation of abandoned
2 property; amending K.S.A. 2016 Supp. 12-1750 and 12-1756a and
3 repealing the existing sections; also repealing K.S.A. 2016 Supp. 12-
4 1756e.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 2016 Supp. 12-1750 is hereby amended to read as
8 follows: 12-1750. As used in this act:

9 (a) "Structure" means any building, wall or other structure.

10 (b) "Enforcing officer" means the building inspector or other officer
11 designated by ordinance and charged with the administration of the
12 provisions of this act.

13 (c) ~~(1)~~ "Abandoned property" means:

14 ~~(A)~~ (A) Any residential real estate for which taxes are delinquent for
15 the preceding two years and which has been unoccupied continuously by
16 persons legally in possession for the preceding 90 days; ~~or~~

17 ~~(B)~~ (B) any residential real estate which has been unoccupied
18 continuously by persons legally in possession for the preceding 15 months
19 and which has a blighting influence on surrounding properties, unless the
20 exterior of the property is being maintained and the property is either the
21 subject of a probate action, action to quiet title or other ownership
22 dispute, or the property is subject to a mortgage; or

23 ~~(C)~~ (C) commercial real estate for which the taxes are delinquent for
24 the preceding two years and which has a blighting influence on
25 surrounding properties. "Commercial real estate" means any real estate for
26 which the present *approved* use is other than one to four residential units
27 or for agricultural purposes.

28 (2) *"Abandoned property" shall not mean any real estate where the*
29 *owner of such real estate is known and has expressed in writing to the*
30 *governing body a desire to retain ownership and maintain such real*
31 *estate and has brought the property into code compliance within 90 days*
32 *of such expressed desire.*

33 (d) "Blighting influence" means conditions in such structure which
34 are dangerous or injurious to the health, safety or ~~morals~~ *welfare* of the
35 occupants of such buildings or other residents of the municipality ~~or which~~
36 ~~have an adverse impact on properties in the area.~~ Such conditions may

1 include, but are not limited to, the following: Defects increasing the
2 hazards of fire, accident, or other calamities; air pollution; ~~light or lack of~~
3 sanitary facilities; dilapidation; disrepair; structural defects; ~~uncleanliness;~~
4 ~~dead and dying trees, limbs or other unsightly natural growth or unsightly~~
5 ~~appearances that constitute a blight to adjoining property, the~~
6 ~~neighborhood or the city; walls, sidings or exteriors of a quality and~~
7 ~~appearance not commensurate with the character of the properties in the~~
8 ~~neighborhood;~~ unsightly stored or parked material, equipment, supplies,
9 machinery, trucks or automobiles or parts thereof; vermin infestation;
10 ~~inadequate drainage;~~ or any violation of health, fire, building or *property*
11 *maintenance codes* or zoning regulations *which constitute a health or*
12 *safety threat.*

13 (e) "Organization" means any nonprofit corporation organized under
14 the laws of this state ~~and~~ which has among its purposes the improvement
15 of housing *and has been in existence for a period of three years or more.*

16 (f) "Rehabilitation" means the process of improving the property into
17 compliance with applicable fire, housing and building codes.

18 (g) "Parties in interest" means any owner or owners of record,
19 judgment creditor, tax purchaser or other party having any legal or
20 equitable title or interest in the property.

21 (h) "Last known address" includes the address where the property is
22 located, or the address as listed in the tax records.

23 *The provisions of subsection (c)(2) shall expire on July 1, 2021.*

24 Sec. 2. K.S.A. 2016 Supp. 12-1756a is hereby amended to read as
25 follows: 12-1756a. (a) (1) An organization may file a petition with the
26 district court for an order for temporary possession of property if:

27 ~~(1)-(A)~~ The property meets the definition of abandoned as set forth in
28 K.S.A. 12-1750, and amendments thereto;

29 ~~(2)-(B)~~ the organization intends to rehabilitate the property and use
30 the property as housing *or if the petition is filed prior to July 1, 2021, for*
31 *ancillary facilities relating to housing, including infrastructure, parks and*
32 *parking facilities;* and

33 ~~(3)-(C)~~ the organization has sent notice to the enforcing officer and
34 the parties in interest of the property, by certified or registered mail, mailed
35 to their last known address and posted on the property at least 20 days but
36 not more than 60 days before the date the petition is filed, of the
37 organization's intent to file a petition for possession under K.S.A. 12-1750
38 through ~~12-1756e~~ *12-1756d*, and amendments thereto.

39 (2) *Prior to July 1, 2021, the governing body of any city may file a*
40 *petition with the district court for an order for temporary possession of*
41 *property if:*

42 (A) *The property meets the definition of abandoned in K.S.A. 12-*
43 *1750, and amendments thereto;*

1 (B) *the governing body of the city filing a petition under this section*
2 *has designated an organization to rehabilitate the property;*

3 (C) *such designated organization intends to rehabilitate the property*
4 *and use the property as housing or for ancillary facilities related to*
5 *housing, including, but not limited to, infrastructure, open space, parks or*
6 *parking facilities;*

7 (D) *the governing body of the city filing the petition under this*
8 *section has sent notice to the enforcing officer and the parties in interest of*
9 *the property, owners of property located within 200 feet of the property*
10 *that is subject to the petition and any neighborhood improvement*
11 *association or associations in which the property is located, by certified or*
12 *registered mail, mailed to their last known address and posted on their*
13 *property at least 20 days but not more than 60 days before the date the*
14 *petition is filed, of the governing body's intent to file a petition for*
15 *temporary possession under K.S.A. 12-1750 through 12-1756d, and*
16 *amendments thereto; and*

17 (E) *the governing body of the city filing the petition under this section*
18 *has formally approved the filing of the petition.*

19 (b) (1) The proceeding shall be commenced by filing a verified
20 petition in the district court in the county in which the property is located.
21 The petition shall state that the conditions specified in subsection (a) exist.
22 All parties in interest of the property shall be named as defendants in the
23 petition.

24 (2) *The petition shall include the following information:*

25 (A) *The history of municipal utility service for the property for the*
26 *preceding 365 days or longer;*

27 (B) *the history of property tax payments for the preceding three years*
28 *or longer;*

29 (C) *the history of code violations for the preceding two years or*
30 *longer and efforts by the city to remedy the code violations;*

31 (D) *the history of attempts to notify the last known owner or owners*
32 *of any enforcement action or actions; and*

33 (E) *the history of actions taken by other governmental entities*
34 *regarding the property, including, but not limited to, tax liens or*
35 *bankruptcy proceedings.*

36 (3) Summons shall be issued and service shall be made pursuant to
37 K.S.A. 60-303, and amendments thereto. Service may be made by
38 publication if the organization *or the governing body of a city* with due
39 diligence is unable to make service of summons upon a defendant pursuant
40 to ~~subsection (a)(3)~~ of K.S.A. 60-307(a)(3), and amendments thereto.

41 (c) Any defendant may file as part of such defendant's answer, as an
42 affirmative defense, a plan for the rehabilitation of the property and
43 evidence of capacity and resources necessary to complete rehabilitation of

1 the property. The court shall grant the defendant 90 days to bring the
2 property into compliance with applicable fire, housing and building codes
3 and to pay all delinquent ad valorem property tax. For good cause shown,
4 the court may extend the ninety-day compliance period ~~for an additional~~
5 ~~90 days~~. If the property is brought into such compliance within the ninety-
6 day period or extension of time thereof, the petition shall be dismissed. If
7 the defendant fails to bring the property into such compliance within the
8 ninety-day period or extension of time thereof, or if the defendant's plan is
9 otherwise insufficient, the defendant's affirmative defense shall be
10 stricken. *In no case shall the defendant's affirmative defense be stricken*
11 *solely on the basis of delinquent property taxes.*

12 (d) At the hearing on ~~the organization's~~ a petition filed in accordance
13 with, and as permitted by, subsection (a), the petitioning organization or
14 governing body of a city shall submit to the court a plan for the
15 rehabilitation of the property and present evidence that the organization
16 has adequate resources to rehabilitate and thereafter manage the property.
17 For the purpose of developing such a plan, representatives of the
18 organization *or the governing body of a city* may be permitted entry onto
19 the property by the court at such times and on such terms as the court may
20 deem appropriate.

21 (e) The court shall make its own determination as to whether the
22 property is in fact abandoned consistent with the terms of K.S.A. 12-1750
23 through ~~12-1756~~ 12-1756d, and amendments thereto.

24 (f) If the court approves the petition, the court ~~shall~~ may enter an
25 order approving the rehabilitation plan and granting temporary possession
26 of the property to the *petitioning organization or governing body of a city*.
27 ~~The organization, subject to court approval, may enter into leases or other~~
28 ~~agreements in relation to the property.~~ Whether the court approves or
29 denies the petition, the organization shall provide the governing body of a
30 city a copy of the order within 30 days of the organization's receipt or
31 knowledge of such order.

32 (g) (1) *Not less than 365 days nor more than 730 days after receiving*
33 *temporary possession of property by an order of the court upon a petition*
34 *for temporary possession, an organization shall seek quiet title to such*
35 *property by petition to the court. The petitioner for quiet title shall send*
36 *notice of intent to file the petition to the parties of interest of the property,*
37 *by certified or registered mail, mailed to their last known address at least*
38 *20 days but not more than 60 days before the date the petition is filed.*

39 (2) *Upon a finding by the court that the property has been*
40 *rehabilitated in accordance with the approved rehabilitation plan, the*
41 *court shall grant the petition for quiet title. If no petition for quiet title is*
42 *filed as permitted by this subsection or a petition for quiet title is filed as*
43 *permitted by this subsection but the court finds that the organization that*

1 *filed the petition has not rehabilitated the property in accordance with the*
2 *rehabilitation plan approved by the court, the property shall immediately*
3 *be sold by either the board of county commissioners or the governing body*
4 *of a city in the manner prescribed for sale of property at a judicial tax*
5 *foreclosure sale pursuant to K.S.A. 79-2801 et seq., and amendments*
6 *thereto.*

7 Sec. 3. K.S.A. 2016 Supp. 12-1750, 12-1756a and 12-1756e are
8 hereby repealed.

10 publication in the statute book.
