

**SENATE BILL No. 390**

1 AN ACT concerning motor vehicles; relating to license plates; permitting  
2 concrete mixer trucks to display license plates on the front of the  
3 vehicle; amending K.S.A. 2019 Supp. 8-133 and repealing the existing  
4 section.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. K.S.A. 2019 Supp. 8-133 is hereby amended to read as  
8 follows: 8-133. (a) The license plate assigned to the vehicle shall be  
9 attached to the rear ~~thereof of the vehicle~~ and shall be ~~so~~ displayed during  
10 the current registration year or years. *Except as otherwise provided in*  
11 *subsection (b), a Kansas registered vehicle shall not have no registration a*  
12 *license plate for any year on attached to the front of the vehicle, except*  
13 *that: (a).*

14 (b) *The following classes of vehicles shall attach a license plate in*  
15 *the location or locations specifically stated:*

16 (1) The license plate issued for a truck tractor shall be attached to the  
17 front of the truck tractor; ~~(b)~~

18 (2) a model year license plate ~~may be attached to the front of issued~~  
19 *for an antique vehicle, in accordance with K.S.A. 8-172, and amendments*  
20 *thereto, may be attached to the front of the antique vehicle; or (e)*

21 (3) a personalized license plate ~~as authorized under subsection (e) of~~  
22 *issued to a passenger vehicle or truck pursuant to K.S.A. 8-132(c), and*  
23 *amendments thereto, may be attached to the front of a the passenger*  
24 *vehicle or truck; and*

25 (4) *the license plate issued for a motor vehicle used as a concrete*  
26 *mixer truck may be attached to either the front or rear of the vehicle.*

27 (c) Every license plate shall at all times be securely fastened to the  
28 vehicle to which it is assigned ~~so as~~, to prevent the plate from swinging,  
29 and at a height not less than 12 inches from the ground, measuring from  
30 the bottom of such plate; *The license plate shall be fastened in a place and*  
31 *position to be clearly visible, and shall be maintained free from foreign*  
32 *materials and in a condition to be clearly legible.*

33 (d) During any period in which the construction of license plates has  
34 been suspended pursuant to the provisions of K.S.A. 8-132, and  
35 amendments thereto, the plate, tag, token, marker or sign assigned to such  
36 vehicle shall be attached to and displayed on such vehicle in such place,

1 position, manner and condition as shall be prescribed by the director of  
2 vehicles.

3 Sec. 2. K.S.A. 2019 Supp. 8-133 is hereby repealed.

4 Sec. 3. This act shall take effect and be in force from and after its  
5 publication in the statute book.
