My name is Terry Humphrey, the lobbyist for the Humane Society of the United States and Stray Dog Policy. I am here today asking you to amend HB 2199 on behalf of a coalition of 39 animal welfare organizations across Kansas listed below.

These organizations do not oppose sports wagering legislation **unless** it permits wagering on greyhound races. As written, HB 2199 incentives the return of greyhound racing in two ways.

First, HB 2199 permits racetrack gaming facilities to offer sports wagering. According to the Kansas Expanded Lottery Act, they must run live greyhound races in order to open their doors to offer sports wagering. For this reason, the bill should be amended to exclude racetrack gaming facility managers from offering sports wagering in New Section 1(b)(2) and removing all references to racetrack gaming facility managers in the bill.

Our second issue with the bill is the definition of a "sporting event." HB 2199 only excludes sports betting on greyhound racing that *occurs in Kansas* and *is regulated by the Kansas Parimutuel Racing Act*. This bill should be amended to prohibit betting on greyhound races **everywhere**.

To ensure that there is no sports wagering on greyhound races anywhere, we ask that you adopt the following amendment in Section 20:

- (oo)(2) The term "sporting event" does not include:
- (A) Any horse or greyhound race that is subject to the provisions of the Kansas parimutuel racing act, K.S.A. 74-8801 et seq., and amendments thereto; or
- (B) any greyhound race; or
- (C) any sporting or athletic event where a majority of the participants are less than 18 years of age

We respectfully request that you amend HB 2199 as outlined above to prohibit betting on greyhound racing.
