Re: 2021 HB 2078 Requested Report

Chair Warren, Chair Patton, and members of the Senate and House Judiciary Committees:

Please find attached four reports that disaggregate, by judicial district, the following information in compliance with 2021 H.B. 2078 (2021 Supp. K.S.A. 22-3402(*l*)):

The number of pending criminal cases in each judicial district on January 1, 2022 (Attachment 1);

The number of criminal cases resolved during fiscal year 2021 and the method of disposition in each case (Attachment 2);

The number of jury trials conducted in criminal cases during fiscal year 2021 (Attachment 3); and

The number of new criminal cases filed in fiscal year 2021 (Attachment 4).

I want to share some information about the data that may be helpful. First, these are preliminary numbers that could change slightly once case filing statistics for fiscal year 2021 are finalized. The judicial branch is integrating procedures for obtaining case filing statistics from

the three case management systems currently being used across the state as we transition to a new statewide, centralized case management system. As that integration progresses, these numbers will be cross-checked using a consistent data point.

Second, the data includes criminal felony and misdemeanor cases only. Traffic and fish and game cases are not included. Third, a criminal case is not counted as a filing until a first appearance has been made or an entry of appearance has been filed. The statistical termination of a case is determined by the most work intensive termination type on the charges. So, if there were two charges on a case and one charge was dismissed and the other charge went to trial, the case termination would be the trial. Fourth, within the statistical termination section, "other terminations" include formal stays, cases that have been statistically closed due to an outstanding bench warrant, and any other terminations that don't fit the other categories. And finally, the jury trial totals include those cases in which the jury was assembled and (1) the parties reached a plea agreement and (2) a jury reached a verdict (guilty, not guilty, or mistrial).
