Current Congressional maps were created by the courts and should be altered as little as necessary to accommodate population shifts. The Kansas City Metro is currently whole within Kansas' Third congressional district and should remain in a single district as residents have shared interests in representation. The Committees on Redistricting should make their maps, agendas, and deadlines available to the public with at least a full week's notice to allow enough time to review maps, and prepare and submit testimony.

We live in a representative democracy. We elect our representatives to speak up for our interests and it appears some of you want to take that representation away and just throw urban areas with votes you'd like to dilute into rural districts. All in the name of removing a U.S. representative who actually listens to and responds to her constituents. So I ask this body, what are you afraid of?
