Be it enacted by the Legislature of the State of Kansas:

Section. 1. K.S.A. 74-4908 is hereby amended to read as and-as such shall have charge of the office, records and supervision and direction of the employees of the system. The executive director shall be in follows: 74-4908. (1) The board shall appoint an executive director and shall establish the compensation therefor. Subject to the direction of the board, the executive director shall be the managing officer of the system the unclassified service under the Kansas civil service act.

Such independent audit and evaluation shall include a review of all assumptions, evaluations and methodology utilized by the regarding the reasonableness or accuracy of the actuarial assumptions, qualified actuaries in accordance with accepted actuarial procedures and annual valuation and three-year performance actuarial experience review conducting the independent actuarial audit and evaluation as required by this section shall be employed by the legislative coordinating council as accordance with principles of practices prescribed by the actuarial provided in K.S.A. 46-1204, and amendments thereto.

Sec. 3. K.S.A. 74-4908 and 74-4908a are hereby repealed.
