## Written testimony presented to the

## **Senate Transportation Committee**

## Senate Bill 25

Chairman Petersen and members of the Senate Transportation Committee, Safe Kids Kansas is pleased to provide testimony in support of SB 25. Safe Kids Kansas is a nonprofit coalition of statewide agencies, organizations and businesses dedicated to preventing unintentional injuries and injury-related death to Kansas children ages 0-19.

As injury prevention specialists and safety advocates we know that driving a vehicle weighing two or more tons on our roadways is a serious responsibility. The driver must not only process hundreds of tiny decisions each mile driven for their own safety, but also for the safety of others using or crossing these shared roads. In addition to the numerous distractions that take place in our vehicles such as alerts on the dashboard, music on the radio, eating and conversations with passengers, mobile devices provide even more. From texts and other notifications, to music, movies, apps, and phone conversations, these devices pull the driver's attention away from their most important task, driving. In the matter of just a moment, the driver's attention may be pulled away from a bicyclist or motorcycle in the lane ahead, or a pedestrian walking on a stretch of road without sidewalks.

According to the National Highway Traffic Safety Administration (NHTSA), distracted driving claimed 3,142 lives in 2019 alone. That was a 9.9% increase from the previous year. And, in Kansas, one in every four crashes are caused by distracted driving. As drivers, it is our responsibility to take caution and be aware of our surroundings. When a person is negligent in their driving responsibilities, it can result in serious or fatal consequences.

Safe Kids Kansas supports SB 25 and reasonable penalties for distracted driving behaviors.
