Hello Committee.

Thank you for hearing from the public today. My name is Marci Laffen. I live in Andover which is in Butler County. I hadn't planned to come to Topeka, but I was watching online yesterday and was getting more and more concerned, so I came. I've been in Topeka more times than I could ever imagine this year, and sent many emails in communication. I am a person that is very concerned for our country. I'm very concerned we've lost our plumb line. Our plumb line is our Constitution, federal and state.

We have a President right now who does not know he's out of his lane. We also have a Congress from the same party, so they're happy to let him be out of his lane, so you guys are having a lot of crud coming to down to you that you are having to deal with. And we citizens really feel like you are our "stop gap."

We are seeing things erupting all about us and we keep being told as citizens to get a lawyer and fight this on our own personal front and there is nothing the legislature can do. Who has money to lawyer up left and right to fight the tyranny coming to our door step in this season? My husband and I have actually done that on our city level. Sadly, the reality is that precedence in the courts is that there are two very limited scenarios in which citizens win against a municipality. This can be despite that very municipality ignoring their very own laws. What are citizens to do with their elected officials defy the law? We heard replace them the next election, but when is there justice?

Please be the stop gap. The growth of our government is out of control. The federal government is spending at the insane rate of passing bills that are in the trillions. Their yearly budget is 10 trillion which is \$30 billion per day!!! This is tanking our country and shackling future generations. Do not be a part of this madness and look for supposed freebies from DC, because they are not free. We pay for them. It comes from our wallet, goes to Washington, DC, and comes back with pennies on the dollar, of which we'll be paying the interest on into generations to come if the economy doesn't collapse before then.
