Agency Estimate

The **agency** estimates revised expenditures of \$34.7 million, all from special revenue funds, in FY 2021. This is an all funds increase of \$707,822, or 2.1 percent, above the FY 2021 approved amount. The increase is primarily attributable to increased expenditures for accounting services, litigation support services, and advertising the new anti-fraud and investor education campaign. The revised estimate includes 136.0 FTE positions, which is an increase of 0.4 FTE positions above the approved number.
