## **HOUSE BILL No. 2072**

By Committee on Education

AN ACT concerning school districts; conferring the power of local control on boards of education; amending K.S.A. 72-8205 and repealing 10 11 the existing section.

Be it enacted by the Legislature of the State of Kansas: 13

Section 1. K.S.A. 72-8205 is hereby amended to read as follows: 72-14 8205. (a) The board of education shall meet at least once each month. At 15 some time during the month of July of each year, the board shall adopt 16 a resolution specifying a regular meeting time of the board and such 17 resolution shall specify the regular hour of commencement of the meet-18 ing, as well as the day of the week and the week of the month. Such 19 resolution shall also provide that if the regular meeting date occurs on a 20 Sunday or on a legal holiday or on a holiday specified by the board, such 21 regular meeting shall be held on the day following commencing at the 22 same hour. Such resolution shall also specify the regular meeting place 23 of the board and may specify that any regular meeting may be adjourned 24 to another time and place. Special meetings may be called at any time by 25 26 the president of the board or by joint action of any three members thereof. Written notice, stating the time and place of any special meeting 27 and the purpose for which called, shall, unless waived, be given each 28 member of the board at least two days in advance of the special meeting 29 and no business other than that stated in the notice shall be transacted 30 at such meeting. A majority of the full membership of the board shall 31 constitute a quorum for the purpose of conducting any business of the 32 school district, and the vote of a majority of the full membership of the 33 board shall be required for the passage of any motion or resolution. Any 34 member who abstains from voting shall be counted as having voted 35 against the motion or resolution. If a member announces a conflict of 36 interest with regard to the issue, the member may leave the meeting until 37 the voting on the issue is concluded and the member who abstains from 38 voting thereby shall not be counted as having voted. 39

(b) Except as otherwise provided in the unification acts, the board *of* 40 education shall have and may exercise the same powers and authorities 41 as were immediately prior to this act conferred uniformly upon boards of 42 education in cities of the first class, and, in addition thereto, the powers 43

and authority expressly conferred by law. 

(c) The board *of education* shall have authority to prescribe courses of study for each year of the school program and provide rules and reg-ulations for teaching in the school district and general government thereof, and to approve and adopt suitable textbooks and study material for use therein subject to the plans, methods, rules and regulations for-mulated and recommended by the state board of education. 

(d) The board *of education* may provide legal counsel at district ex-pense to any members of the board of education, or school district officers or employees who are sued in situations relating to and arising out of the performance of their office or employment. No teacher or other employ-ment contract shall make reference to or incorporate the provisions of this subsection, nor shall the provisions of this subsection be construed as any part of the consideration of employment of any teacher, officer or other employee of the board. 

(e) (1) The board of education may transact all school district busi-ness and adopt policies that the board deems appropriate to perform its constitutional duty to maintain, develop and operate local public schools. 

(2) The power and authority conferred on school districts by this sub-section shall not be construed to relieve any other unit of government of its duties and responsibilities which are prescribed by law, nor to create any responsibility on the part of a school district to assume the duties or responsibilities which are required of another unit of government. 

(3) School districts shall exercise the powers of local control conferred 

by this subsection by resolution of the board of education. 

Sec. 2. K.S.A. 72-8205 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the statute book.
