## **HOUSE BILL No. 2187**

AN ACT concerning school district finance; revising the definition of
enrollment; amending K.S.A. 2000 Supp. 72-6407 and repealing the
existing section.

13 Be it enacted by the Legislature of the State of Kansas:

14Section 1. K.S.A. 2000 Supp. 72-6407 is hereby amended to read as 15 follows: 72-6407. (a) "Pupil" means any person who is regularly enrolled 16 in a district and attending kindergarten or any of the grades one through 1712 maintained by the district or who is regularly enrolled in a district and 18 attending kindergarten or any of the grades one through 12 in another 19 district in accordance with an agreement entered into under authority of 20 K.S.A. 72-8233, and amendments thereto, or who is regularly enrolled in 21 a district and attending special education services provided for preschoolaged exceptional children by the district. Except as otherwise provided 22 23 in this subsection, a pupil in attendance full time shall be counted as one 24pupil. A pupil in attendance part time shall be counted as that proportion 25of one pupil (to the nearest <sup>1</sup>/10) that the pupil's attendance bears to full-26 time attendance. A pupil attending kindergarten shall be counted as  $\frac{1}{2}$ 27 pupil. A pupil enrolled in and attending an institution of postsecondary 28education which is authorized under the laws of this state to award aca-29 demic degrees shall be counted as one pupil if the pupil's postsecondary 30 education enrollment and attendance together with the pupil's attend-31 ance in either of the grades 11 or 12 is at least 5% time, otherwise the 32 pupil shall be counted as that proportion of one pupil (to the nearest 1/10) 33 that the total time of the pupil's postsecondary education attendance and 34 attendance in grade 11 or 12, as applicable, bears to full-time attendance. 35 A pupil enrolled in and attending an area vocational school, area voca-36 tional-technical school or approved vocational education program shall be 37 counted as one pupil if the pupil's vocational education enrollment and 38 attendance together with the pupil's attendance in any of grades nine 39 through 12 is at least <sup>5</sup>% time, otherwise the pupil shall be counted as that 40proportion of one pupil (to the nearest  $\frac{1}{10}$ ) that the total time of the 41 pupil's vocational education attendance and attendance in any of grades 42 nine through 12 bears to full-time attendance. A pupil enrolled in a dis-43 trict and attending special education services, except special education

services for preschool-aged exceptional children, provided for by the dis-1 trict shall be counted as one pupil. A pupil enrolled in a district and 2 3 attending special education services for preschool-aged exceptional children provided for by the district shall be counted as <sup>1</sup>/<sub>2</sub> pupil. A preschool-4 aged at-risk pupil enrolled in a district and receiving services under an 56 approved at-risk pupil assistance plan maintained by the district shall be 7 counted as <sup>1</sup>/<sub>2</sub> pupil. A pupil in the custody of the secretary of social and rehabilitation services and enrolled in unified school district No. 259, 8 9 Sedgwick county, Kansas, but housed, maintained, and receiving educa-10 tional services at the Judge James V. Riddel Boys Ranch, shall be counted 11 as two pupils. A pupil residing at the Flint Hills job corps center shall not 12 be counted. A pupil confined in and receiving educational services pro-13 vided for by a district at a juvenile detention facility shall not be counted. 14 A pupil enrolled in a district but housed, maintained, and receiving ed-15ucational services at a state institution shall not be counted.

(b) "Preschool-aged exceptional children" means exceptional children, except gifted children, who have attained the age of three years but
are under the age of eligibility for attendance at kindergarten.

(c) "At-risk pupils" means pupils who are eligible for free meals under the national school lunch act and who are enrolled in a district which
maintains an approved at-risk pupil assistance plan.

22 "Preschool-aged at-risk pupil" means an at-risk pupil who has (d) 23attained the age of four years, is under the age of eligibility for attendance 24at kindergarten, and has been selected by the state board in accordance 25with guidelines consonant with guidelines governing the selection of pu-26 pils for participation in head start programs. The state board shall select not more than 1,794 preschool-aged at-risk pupils to be counted in the 27 1999-2000 school year and not more than 2,230 preschool-aged at-risk 2829 pupils to be counted in any school year thereafter.

30 (e) "Enrollment" means, for districts scheduling the school days or 31 school hours of the school term on a trimestral or quarterly basis, the 32 number of pupils regularly enrolled in the district on September 20 plus 33 the number of pupils regularly enrolled in the district on February 20 34 less the number of pupils regularly enrolled on February 20 who were 35 counted in the enrollment of the district on September 20; and for dis-36 tricts not hereinbefore specified, the number of pupils regularly enrolled 37 in the district on September 20. Notwithstanding the foregoing: (1) If 38 enrollment in a district in any school year has decreased from enrollment in the preceding school year, enrollment of the district in the current 39 40school year means whichever is the greater of (1) (A) enrollment in the preceding school year minus enrollment in such school year of preschool-4142 aged at-risk pupils, if any such pupils were enrolled, plus enrollment in 43 the current school year of preschool-aged at-risk pupils, if any such pupils

are enrolled, or (2)(B) the sum of enrollment in the current school year 1 2 of preschool-aged at-risk pupils, if any such pupils are enrolled and the 3 average (mean) of the sum of (A) (i) enrollment of the district in the current school year minus enrollment in such school year of preschool-4 aged at-risk pupils, if any such pupils are enrolled and (B)(ii) enrollment 5in the preceding school year minus enrollment in such school year of 6 7 preschool-aged at-risk pupils, if any such pupils were enrolled and (C)(iii) enrollment in the school year next preceding the preceding school 8 9 year minus enrollment in such school year of preschool-aged at-risk pu-10 pils, if any such pupils were enrolled; and (2) for the purpose of deter-11 mining enrollment, the number of pupils who are exceptional children enrolled in the district is the number of such pupils enrolled on September 12 13 20, or November 20 or April 20, whichever is the greatest number of such 14 pupils.

(f) "Adjusted enrollment" means enrollment adjusted by adding atrisk pupil weighting, program weighting, low enrollment weighting, if any,
correlation weighting, if any, school facilities weighting, if any, ancillary
school facilities weighting, if any, and transportation weighting to
enrollment.

20 (g) "At-risk pupil weighting" means an addend component assigned 21 to enrollment of districts on the basis of enrollment of at-risk pupils.

(h) "Program weighting" means an addend component assigned to
enrollment of districts on the basis of pupil attendance in educational
programs which differ in cost from regular educational programs.

(i) "Low enrollment weighting" means an addend component assigned to enrollment of districts having under 1,725 enrollment on the
basis of costs attributable to maintenance of educational programs by such
districts in comparison with costs attributable to maintenance of educational programs by districts having 1,725 or over enrollment.

30 "School facilities weighting" means an addend component as-(i) 31 signed to enrollment of districts on the basis of costs attributable to com-32 mencing operation of new school facilities. School facilities weighting may 33 be assigned to enrollment of a district only if the district has adopted a local option budget and budgeted therein the total amount authorized for 34 35 the school year. School facilities weighting may be assigned to enrollment of the district only in the school year in which operation of a new school 36 37 facility is commenced and in the next succeeding school year.

(k) "Transportation weighting" means an addend component assigned to enrollment of districts on the basis of costs attributable to the
provision or furnishing of transportation.

(l) "Correlation weighting" means an addend component assigned to
enrollment of districts having 1,725 or over enrollment on the basis of
costs attributable to maintenance of educational programs by such dis-

1	tricts as a correlate to low enrollment weighting assigned to enrollment
2	of districts having under 1,725 enrollment.
3	(m) "Ancillary school facilities weighting" means an addend compo-
4	nent assigned to enrollment of districts to which the provisions of K.S.A.
5	2000 Supp. 72-6441, and amendments thereto, apply on the basis of costs
6	attributable to commencing operation of new school facilities. Ancillary
7	school facilities weighting may be assigned to enrollment of a district only
8	if the district has levied a tax under authority of K.S.A. 2000 Supp. 72-
9	6441, and amendments thereto, and remitted the proceeds from such tax
10	to the state treasurer. Ancillary school facilities weighting is in addition
11	to assignment of school facilities weighting to enrollment of any district
12	eligible for such weighting.
13	(n) "Juvenile detention facility" means any community juvenile cor-
14	rections center or facility, the Forbes Juvenile Attention Facility, the
15	Sappa Valley Youth Ranch of Oberlin, Salvation Army/Koch Center Youth
16	Services, the Clarence M. Kelley Youth Center, Trego County Secure
17	Care Center, St. Francis Academy at Atchison, St. Francis Academy at
18	Ellsworth, St. Francis Academy at Salina, and St. Francis Center at Salina.
19	Sec. 2. K.S.A. 2000 Supp. 72-6407 is hereby repealed.
20	Sec. 3. This act shall take effect and be in force from and after its
21	publication in the statute book.
