AN ACT concerning teacher certification; relating to teachers holding certificates valid in other states; amending K.S.A. 72-1396 and repealing the existing section.

3 Be it enacted by the Legislature of the State of Kansas:

New Section 1. In order to improve the education system in this 14state, the state board of education shall take advantage of the preparation 15and experience of teachers certified in any other state by issuing certifi-16 cates to teach in this state to applicants for such certificates who hold a 17certificate valid in any other state. Any such certificate issued by the state 18board of education under this section shall be limited to teaching at the 19level and in those subjects or fields for which the applicant is qualified to 20teach in another state. 21Sec. 2. K.S.A. 72-1396 is hereby amended to read as follows: 72-22

1396. (a) Any person holding a teaching certificate valid in the state of
Kansas which was issued prior to May 1, 1986, is exempt from the examination required by this act. Any person holding a teaching certificate
valid in any other state is exempt from the examination required by this
act.

(b) The following persons, or any class or classes thereof, may beexempted by the state board of education from the examination requiredby this act:

31 (1) Any person holding a teaching certificate valid in any other state
 32 if the requirements under which the certificate was issued are compara-

33 ble, in the opinion of the state board, to the requirements of this state,

34 other than examination, for issuance of a teaching certificate.

35 -(2) Any person applying for a one-year, nonrenewable certificate if
 36 the person meets all certification requirements, other than examination,
 37 for issuance of a teaching certificate.

38 (3) (2) Any person applying for certification by the state board to 39 provide services in a position for which the state board deems the ex-40 amination is inappropriate or unnecessary if the person meets the certi-41 fication requirements which have been established by the state board as 42 appropriate and necessary for the position.
