AN ACT concerning the lottery and lottery machines; amending K.S.A. 74-8702 and 74-8722 and K.S.A. 2000 Supp. 74-8710, 74-8718 and 79-4701 and repealing the existing sections.
Be it enacted by the Legislature of the State of Kansas:
Section 1. K.S.A. 74-8702 is hereby amended to read as follows: 74-
8702. As used in this act, unless the context otherwise requires:
(a) "Commission" means the Kansas lottery commission.
(b) "Executive director" means the executive director of the Kansas
lottery.
(c) "Gaming equipment" means any electric, electronic or mechani-
cal device or other equipment unique to the Kansas lottery used directly
in the operation of any lottery and in the determination of winners pur-
suant to this act.
(d) "Kansas lottery" means the state agency created by this act to
operate a lottery or lotteries pursuant to this act.
(e) "Lottery retailer" means any person with whom the Kansas lottery
has contracted to sell lottery tickets or shares, or both, to the public.
(f) "Lottery" or "state lottery" means the lottery or lotteries operated
pursuant to this act.
(g) "Major procurement" means any gaming product or service, in-
cluding but not limited to facilities, advertising and promotional services,
annuity contracts, prize payment agreements, consulting services, equip-
ment, tickets and other products and services unique to the Kansas lot-
tery, but not including materials, supplies, equipment and services com-
mon to the ordinary operations of state agencies.
(h) "Person" means any natural person, association, corporation or
partnership.
(i) "Prize" means any prize paid directly by the Kansas lottery pur- suant to its rules and regulations.

(j) "Share" means any intangible manifestation authorized by the Kansas lottery to prove participation in a lottery game.
(k) "Ticket" means any tangible evidence issued by the Kansas lottery
to prove participation in a lottery game.

2 (m) "Returned ticket" means any ticket which was transferred to a 3 lottery retailer, which was not sold by the lottery retailer and which was 4 returned to the Kansas lottery for refund by issuance of a credit or 5 otherwise.

6 (n) "Video lottery machine" means any electronic video game ma-7 chine that, upon insertion of cash, is available to play or simulate the play 8 of a video game authorized by the commission, including but not limited 9 to bingo, poker, black jack and keno, and which uses a video display and 10 microprocessors and in which, by chance, the player may receive free 11 games or credits that can be redeemed for cash.

12 (o) "Lottery machine" means:

(1) Any machine or device that allows a player to insert cash or other
form of consideration, and may deliver, as the result of an element of
chance, regardless of the skill required by the player, a prize or evidence
of a prize, including, but not limited to, an interactive lottery machine or
device or a noninteractive lottery machine or device;

(2) any interactive lottery machine or device in which the prize is
determined by both chance and player or players' skill and in which the
player or players can influence the prize through one-on-one interaction
with the machine or device, including, but not limited to, a machine or
device on which lottery games, such as poker and blackjack, are played;
or

(3) any noninteractive lottery machine or device in which the prize
is determined only by chance, including, but not limited to, any slot machine, bingo, keno ticket dispenser, lottery ticket dispenser, pull-tab dispenser and instant bingo dispenser.

Sec. 2. K.S.A. 2000 Supp. 74-8710 is hereby amended to read as 28follows: 74-8710. (a) The commission, upon the recommendation of the 29executive director, shall adopt rules and regulations governing the estab-30 lishment and operation of a state lottery as necessary to carry out the 31 purposes of this act. Temporary rules and regulations may be adopted by 32 the commission without being subject to the provisions and requirements 33 of K.S.A. 77-415 through 77-438, and amendments thereto, but shall be 34 subject to approval by the attorney general as to legality and shall be filed 35 with the secretary of state and published in the Kansas register. Tem-36 porary and permanent rules and regulations may include but shall not be 37 limited to: 38

if a lottery game utilizes a drawing of winning numbers, a drawing among 1 entries or a drawing among finalists, such drawings shall always be open 2 to the public and shall be recorded on both video and audio tape. 3 (3) The manner of payment of prizes to the holders of winning tickets 4 or shares. 5(4) The frequency of the drawings or selections of winning tickets or 6 7 shares. The type or types of locations at which tickets or shares may be 8 (5)9 sold. 10The method or methods to be used in selling tickets or shares. (12) The major procurement contracts or portions thereof to be
awarded to minority business enterprises pursuant to subsection (a) of
K.S.A. 74-8705, and amendments thereto, and procedures for the award
thereof.

(b) The lottery shall adopt rules and regulations concerning the game
of keno. Such rules and regulations shall require that the amount of time
which elapses between the start of games shall not be less than four
minutes.

28 (b)(c) No new lottery game shall commence operation after the ef-29 fective date of this act unless first approved by the governor or, in the 30 governor's absence or disability, the lieutenant governor.

Sec. 3. K.S.A. 2000 Supp. 74-8718 is hereby amended to read asfollows: 74-8718. (a) It is unlawful for:

(1) Any person to sell a lottery ticket or share at a price other thanthat fixed by rules and regulations adopted pursuant to this act;

(2) any person other than a lottery retailer authorized by the Kansas
lottery to sell or resell any lottery ticket or share; or

(3) any person to sell a lottery ticket or share to any person, knowing
such person to be under 18 years of age; or

(4) any person to sell a lottery ticket or share by electronic mail, the
 40 internet or telephone.

41 (b) No lottery retailer shall accept payment for a lottery ticket or 42 share in the form of a credit card.

43 (b) (c) (1) Violation of this section is a class A nonperson misde-

1 meanor upon conviction for a first offense; and

2 (2) violation of this section is a severity level 9, nonperson felony upon3 conviction for a second or subsequent offense.

4 Sec. 4. K.S.A. 74-8722 is hereby amended to read as follows: 74-5 8722. (*a*) The Kansas lottery shall not recruit for employment or as a 6 volunteer any person under 18 years of age for the purpose of appearing, 7 being heard or being quoted in any advertising or promotion of any lottery 8 in any electronic or print media.

9 (b) The Kansas lottery shall not advertise or promote any lottery by 10 electronic mail, the internet or telephone.

(c) All advertising and marketing practices of the Kansas lottery shall
meet or exceed the standards of the North American association of state
and provincial lotteries (NASPL) which are in effect on July 1, 2001, or
any later version as adopted by the commission in rules and regulations.

Sec. 5. K.S.A. 2000 Supp. 79-4701 is hereby amended to read asfollows: 79-4701. As used in this act:

17 (a) "Act" means the bingo act.

(b) "Administrator" means the administrator of charitable gaming
designated by the secretary pursuant to K.S.A. 2000 Supp. 79-4717, and
amendments thereto.

21 (c) "Bingo" or "games of bingo" means the games of call bingo and 22 instant bingo.

23 "Bingo" or "games of bingo" shall not include games played on a video 24 lottery machine or lottery machine.

(d) "Bingo card" or "card" means a reusable card which is marked off into 25 squares arranged in five horizontal rows of five squares each and five vertical rows of five squares each, with each square being designated by a number, letter or combination of numbers and letters. Only the center square shall be designated with the word "free". No two cards in the same game shall be identical.

(e) "Bingo face" or "face" means a piece of paper which is marked 31 off into 25 squares arranged in five horizontal rows of five squares each 32 and five vertical rows of five squares each, with each square being des-33 34 ignated by a number, letter or combination of numbers and letters. Only the center square shall be designated with the word "free". No two bingo 35 faces in the same game shall be identical. Faces shall be disposable and 36 shall not be reused after the game in which a player has used such face. 37 (f) "Call bingo" means a game in which: (1) Each player pays a 38 39 charge; (2) a prize or prizes are awarded to the winner or winners; (3)each player receives one or more cards or faces; and (4) each player covers 40the squares on each card or face as the operator of such game announces 41 a number, letter or combination of numbers and letters appearing on an 42object selected by chance, either manually or mechanically from a recep-43

1 tacle in which have been placed objects bearing numbers, letters or com-

2 binations of numbers and letters corresponding to the system used for

designating the squares. The winner of each game is the player or players
first covering properly a predetermined and announced pattern of squares

 $5 \quad$ upon the card or face being used by such player or players.

6 "Call bingo" shall include any regular, special, mini and progressive 7 game of bingo.

6 "Call bingo" shall not include any game utilizing an electronic or com-9 puterized card system.

10 (g) "Department" means the department of revenue.

11 (h) "Director" means the director of taxation.

(i) "Distributor" means any person or entity that sells or distributesinstant bingo tickets, bingo cards or bingo faces.

(j) "Instant bingo" means a game: (1) In which each player pays a 14charge; (2) in which a prize or prizes are awarded to the winner or win-15ners; (3) in which each player receives one or more disposable pull-tab 16or break-open tickets which accord a player an opportunity to win some-17thing of value by opening or detaching the paper covering from the back 18of the ticket to reveal a set of numbers, letters, symbols or configurations, 19 or any combination thereof; (4) which is conducted by a licensee under 20this act; (5) the conduct of which must be in the presence of the players; 21and (6) which does not utilize any dice, normal playing cards, instant ticket 22 23with a removable latex covering or slot machines. Winners of instant bingo shall be determined either (1) by a combination of letters, numbers or 24symbols determined and posted prior to the sale of instant bingo tickets 25or (2) by matching a letter, number or symbol under a tab of an instant 2627bingo ticket with the winning letter, number or symbol in a designated call game of bingo during the same session. 28"Instant bingo" shall not include any game utilizing electronically gen-29 erated or computer-generated tickets. 30 (k) "Lessor" means the owner, coowner, lessor or sublessor of prem-31 ises upon which a licensee is permitted to manage, operate or conduct 32 games of bingo, whether or not a written lease has been entered into and 33

submitted to the administrator as required in subsection (c) of K.S.A. 794703, and amendments thereto, and includes all political subdivisions and
other public agencies.

(l) "Licensee" means any nonprofit organization holding a license to
manage, operate or conduct games of bingo pursuant to K.S.A. 79-4701 *et seq.*, and amendments thereto.

40 (m) "Mini bingo" means a game of call bingo in which the prizes
41 awarded are not less than 50% of the gross receipts derived from the sale
42 of cards or faces for participation in the game, but not more than \$50.

 $43 \qquad (n) \quad ``Net proceeds'' means the gross receipts received by the licensee$

from charges imposed on players for participation in games of bingo and
 any admission fees or charges less amounts actually paid as prizes in
 games of bingo and any tax payable by the licensee.

(o) "Nonprofit religious organization" means any organization, 4 church, body of communicants, or group, gathered in common member-5ship for mutual support and edification in piety, worship, and religious 6 observances, or a society of individuals united for religious purposes at a 7 definite place and of which no part of the net earnings inures to the 8 benefit of any private shareholder or individual member of such organi-9 10zation, and which religious organization maintains an established place of worship within this state and has a regular schedule of services or meet-11ings at least on a weekly basis and has been determined by the adminis-12trator to be organized and created as a bona fide religious organization 13 and which has been exempted from the payment of federal income taxes 14as provided by section 501(c)(3) or section 501(d) of the federal internal 15revenue code of 1986, as amended, or determined to be organized and 16operated as a bona fide nonprofit religious organization by the 17administrator. 18

(p) "Nonprofit charitable organization" means any organizationwhich is organized and operated for:

21 (1) The relief of poverty, distress, or other condition of public con-22 cern within this state; or

(2) for financially supporting the activities of a charitable organizationas defined in paragraph (1); or

(3) for conferring direct benefits on the community at large; and of 25which no part of the net earnings inures to the benefit of any private 26shareholder or individual member of such organization and has been de-27termined by the administrator to be organized and operated as a bona 28fide charitable organization and which has been exempted from the pay-29 ment of federal income taxes as provided by sections 501(c)(3), 501(c)(4), 30 501(c)(5), 501(c)(6) and 501(c)(7) of the federal internal revenue code of 31 1986, as amended, or determined to be organized and operated as a bona 32 fide nonprofit charitable organization by the administrator. 33

(q) "Nonprofit fraternal organization" means any organization within 34 this state which exists for the common benefit, brotherhood, or other 35 interests of its members and is authorized by its written constitution, 36 charter, articles of incorporation or bylaws to engage in a fraternal, civic 37 or service purpose within this state and has been determined by the ad-38 ministrator to be organized and operated as a bona fide fraternal organ-39 ization and which has been exempted from the payment of federal income 40taxes as provided by section 501(c)(8) or section 501(c)(10) of the federal 41 internal revenue code of 1986, as amended, or determined to be organ-42ized and operated as a bona fide nonprofit fraternal organization by the 43

1 administrator.

(r) "Nonprofit educational organization" means any public or private 2 elementary or secondary school or institution of higher education which 3 has been determined by the administrator to be organized and operated 4 as a bona fide educational organization and which has been exempted 5 from the payment of federal income taxes as provided by section $501(\hat{c})(3)$ 6 of the federal internal revenue code of 1986, as amended, or determined 7 to be organized and operated as a bona fide nonprofit educational organ-8 ization by the administrator. 9

10(s) "Nonprofit veterans' organization" means any organization within this state or any branch, lodge, or chapter of a national or state organi-11 zation within this state, the membership of which consists exclusively of 12individuals who qualify for membership because they were or are mem-13bers of the armed services or forces of the United States, or an auxiliary 14unit or society of such a nonprofit veterans' organization the membership 15of which consists exclusively of individuals who were or are members of 16 the armed services or forces of the United States, or are cadets, or are 17spouses, widows or widowers of individuals who were or are members of 18the armed services or forces of the United States, and of which no part 19 of the net earnings inures to the benefit of any private shareholder or 20individual member of such organization, and has been determined by the 21administrator to be organized and operated as a bona fide veterans' or-22 ganization and which has been exempted from the payment of federal 23income taxes as provided by section 501(c)(4) or 501(c)(19) of the federal 24internal revenue code of 1986, as amended, or determined to be organ-25ized and operated as a bona fide nonprofit veterans' organization by the 2627administrator.

(t) "Person" means any natural person, corporation, partnership, trustor association.

30 (u) "Premises" means any room, hall, building, enclosure or outdoor
31 area used for the management, operation or conduct of a game of bingo
32 by a licensee.

(v) "Progressive bingo" means a game of call bingo in which either
the established prize amount or number of bingo balls or objects called,
or both, may be increased from one session to the next scheduled session
if no player completes the required pattern within the specified number
of bingo balls or objects drawn. The player's opportunity to win shall
increase as the prize amount increases.

(w) "Regular game of bingo" means any game of bingo which is subject to the 25 game limit, \$50 prize limit and the \$1 charge limit imposed
under subsections (g), (h) and (j) of K.S.A. 79-4706, and amendments
thereto.

43 (x) "Secretary" means the secretary of revenue or the secretary's

1	designee.
2	(y) "Session" means a day on which a licensee conducts games of
3	bingo.
4	(z) "Video lottery machine" or "lottery machine" shall have the mean-
5	ing ascribed thereto by K.S.A. 74-8702, and amendments thereto.
6	Sec. 6. K.S.A. 74-8702 and 74-8722 and K.S.A. 2000 Supp. 74-8710,
7	74-8718 and 79-4701 are hereby repealed.
8	Sec. 7. This act shall take effect and be in force from and after its
9	publication in the statute book.
