| | (b) "Criminal history record information" means data initiated or col- |
| | lected by a criminal justice agency on a person pertaining to a reportable |
| | event. The term does not include: |
| | (1) Data contained in intelligence or investigatory files or police work- product records used solely for police investigation purposes; |
| | (2) wanted posters, police blotter entries, court records of public ju- |
| | dicial proceedings or published court opinions; |
| | (3) data pertaining to violations of the traffic laws of the state or any |
| | other traffic law or ordinance, other than vehicular homicide; or |
| | (4) presentence investigation and other reports prepared for use by |
| | a court in the exercise of criminal jurisdiction or by the governor in the |
| | exercise of the power of pardon, reprieve or commutation. |
| | (c) "Criminal justice agency" means any government agency or sub- |

the Kansas parole board; and (5)

(6)the juvenile justice authority.

10 (d) "Criminal justice information system" means the equipment (in-11 cluding computer hardware and software), facilities, procedures, agreements and personnel used in the collection, processing, preservation and 12dissemination of criminal history record information. 13

"Director" means the director of the Kansas bureau of 14 (e) 15investigation.

"Disseminate" means to transmit criminal history record infor-16 (f) mation in any oral or written form. The term does not include: 17

The transmittal of such information within a criminal justice 18(1)19 agency;

20(2)the reporting of such information as required by this act; or

21 the transmittal of such information between criminal justice agen-(3)22 cies in order to permit the initiation of subsequent criminal justice proceedings against a person relating to the same offense. 23

"Reportable event" means an event specified or provided for in 24(g) 25K.S.A. 22-4705, and amendments thereto.

Sec. 2. K.S.A. 2001 Supp. 22-4701 is hereby repealed. 26

Sec. 3. This act shall take effect and be in force from and after its publication in the statute book. 28
