K.S.A. 59-2126 is hereby amended to read as follows: 59-14 2126. (a) In an independent adoption venue shall be in the county in 15which the petitioner resides or in the county in which the child to be 16 adopted resides. (b) In an agency adoption venue shall be: 1718 (1) In the county in which the petitioner resides; 19 (2) in the county in which the child to be adopted resided prior to 20receipt of custody by the agency; or 21(3) where the child placing agency is located. 22 Venue location established in this subsection is not prioritized in any particular order. Any one location shall be the proper venue. 2324(c) In a stepparent adoption venue shall be in the county in which 25the petitioner resides or where the child resides. 26 (d) If the petitioner resides upon or is stationed at a United States 27 military post or reservation within this state, and the child to be adopted 28is then residing with the petitioner, venue may be in the district court of the county in which the post or reservation is located, or in the district 29 30 court of any county located immediately adjacent to such county. 31 (e) Where the residence of the child, as defined in K.S.A. 59-2112, 32 serves as the basis for venue, a sworn affidavit shall be filed with the 33 petition setting forth the factual basis for the child's residency. 34 Sec. 2.
