13	Be it enacted by the Legislature of the State of Kansas:
14	Section 1. K.S.A. 59-2121 is hereby amended to read as follows: 59-
15 16	2121. (a) Except as otherwise authorized by law, no person shall request,
$16 \\ 17$	receive, give or offer to give any consideration in connection with an adoption, or a placement for adoption, other than:
18	(1) Reasonable fees for legal and other professional services rendered
19	in connection with the placement or adoption not to exceed customary
20	fees for similar services by professionals of equivalent experience and
21	reputation where the services are performed, except that fees for legal
22	and other professional services as provided in this section performed out-
23	side the state shall not exceed customary fees for similar services when
24	performed in the state of Kansas;
25	(2) reasonable fees in the state of Kansas of a licensed child-placing
26	agency;
27	(3) actual and necessary expenses, based on expenses in the state of
28 29	<ul><li>Kansas, incident to placement or to the adoption proceeding;</li><li>(4) actual medical expenses of the mother attributable to pregnancy</li></ul>
29 30	and birth;
31	(5) actual medical expenses of the child; and
32	(6) reasonable living expenses of the mother which are incurred dur-
33	ing or as a result of the pregnancy.
34	(b) If such costs were paid by the department of social and rehabili-
35	tation services, moneys paid by the adopting parents of a Kansas child
36	pursuant to paragraphs $(4)$ and $(5)$ of subsection $(a)$ shall be turned over
37	to the department of social and rehabilitation services.
38	(b) (c) In an action for adoption, a detailed accounting of all consid-
39	eration given, or to be given, and all disbursements made, or to be made,
40	in connection with the adoption and the placement for adoption shall
41	accompany the petition for adoption. Upon review of the accounting, the
42 42	court shall disapprove any such consideration which the court determines
43	to be unreasonable or in violation of this section and, to the extent nec-

essary to comply with the provisions of this section, shall order reim-bursement of any consideration already given in violation of this section. (e) (d) Knowingly and intentionally receiving or accepting clearly ex-cessive fees or expenses in violation of subsection (a) shall be a severity level 9, nonperson felony. Knowingly failing to list all consideration or  $\mathbf{5}$ disbursements as required by subsection (b) shall be a class B nonperson misdemeanor. Sec. 2. K.S.A. 59-2121 is hereby repealed.
