HOUSE BILL No. 2965

9 AN ACT concerning affordable housing; establishing within the depart10 ment of corrections a pilot project to build homes for low income and
11 elderly citizens.

13 Be it enacted by the Legislature of the State of Kansas:

14 Section 1. There is hereby created in the Kansas department of cor-15rections the Kansas affordable housing program. The secretary of correc-16 tions shall negotiate, develop and administer a pilot project for affordable 17housing for the low income and elderly citizens of our state. The pilot 18 project shall last three years, unless the legislature extends the term of 19 the program. The secretary shall work with the Kansas department of 20 commerce and housing-division of housing in the development and ad-21ministration of this program.

Sec. 2. The Kansas affordable housing program shall train and use inmates under the jurisdiction of the Kansas department of corrections to build these houses. The affordable houses will be built at a designated correctional facility and then transported to qualified purchasers in Kansas communities. In order to start this project, the secretary shall seek appropriations for any start up funds.

28 Sec. 3. (a) There is hereby established in the state treasury the Kan-29 sas affordable housing operating fund.

30 (b) The secretary of corrections shall remit all moneys collected from 31 the sale of affordable homes and any other moneys received by or on 32 behalf of the Kansas affordable housing program to the state treasurer in 33 accordance with the provisions of K.S.A. 75-4215, and amendments 34 thereto. Upon receipt of each such remittance, the state treasurer shall 35 deposit the entire amount in the state treasury to the credit of the Kansas 36 affordable housing operating fund. Moneys credited to the fund shall be 37 expended or transferred only as provided by this act. Expenditures from 38 such fund shall be made in accordance with appropriations acts upon 39 warrants of the director of accounts and reports issued pursuant to vouch-40ers approved by the secretary or by a person designated by the secretary. 41 (c) Moneys in the Kansas affordable housing operating fund shall be

42 used for:

43 (1) The payment of expenses of the affordable housing program

1 which shall include all costs incurred in the operation and administration 2 of the Kansas affordable housing program; all costs resulting from con-3 tracts entered into for the purchase or lease of goods and services needed 4 for operation of the affordable housing program, including but not limited 5 to supplies, materials, advertising, all expenses for construction costs, 6 training, transportation and all other services provided in order to con-7 tinue the project.

8 Sec. 4. The secretary shall adopt rules and regulations governing the 9 establishment and operation of the Kansas affordable housing operating 10 program.

11 Sec. 5. The secretary of corrections on the first Tuesday in January 12 of each year of the pilot project shall prepare and publish an annual report 13 of its activities for the information of the governor, the standing commit-14 tee on Kansas futures of the house of representatives, any member of the 15 Kansas legislature which requests a copy and the public which shall be 16 available at different locations across the state.
