(a) There is hereby established the domestic security 15council. 16 (b) The council shall consist of the following members: (1) The 17governor; the lieutenant governor; 18(2)19 (3)the attorney general; 20 (4)the secretary of health and environment; 21 the director of the office of emergency management; (5)22 (6)the secretary of transportation; 23 (7)the secretary of agriculture; 24(8)the state livestock commissioner; 25(9)the secretary of commerce; 26 (10) the adjutant general; 27 (11)the superintendent of the Kansas highway patrol; the director of the Kansas bureau of investigation; 28(12)29 (13)the state fire marshal; and 30 (14)such other persons as the governor may appoint. 31 (c) The governor shall serve as chairperson of the council. The coun-32 cil shall meet upon call of the chairperson as necessary to carry out duties 33 pursuant to this act. 34 (d) The council shall: (1) Plan and coordinate all agencies of state 35 government in preparing for, preventing and responding to any act of 36 terror or threatened act of terror; 37 coordinating state efforts with federal and local governmental (2)38 agencies related to any such act of terror or threatened act of terror; 39 (3)work with state departments and agencies, federal and local governmental entities and private entities to ensure the adequacy of state 40 efforts to combat terrorism with a focus on detection, preparedness, pre-41 42 vention, protection, response and recovery and incident management; 43 and

1 (4) prepare a comprehensive strategy to secure the state of Kansas 2 from terrorist threats or attacks and coordinate such state governmental 3 efforts to detect, prepare for, prevent, protect against, respond to and 4 recover from terrorist attacks within Kansas.

5 (e) The council, in accordance with K.S.A. 75-4319, and amendments 6 thereto, may recess for a closed or executive session to receive informa-7 tion and discuss security issues or operations of which disclosure of such 8 issues or operation could compromise the effectiveness of security plan-9 ning or operations.

10 Sec. 2. K.S.A. 2001 Supp. 75-4319 is hereby amended to read as 11 follows: 75-4319. (a) Upon formal motion made, seconded and carried, 12 all bodies and agencies subject to the open meetings act may recess, but not adjourn, open meetings for closed or executive meetings. Any motion 13 14 to recess for a closed or executive meeting shall include a statement of: 15(1) The justification for closing the meeting; (2) the subjects to be dis-16 cussed during the closed or executive meeting; and (3) the time and place 17at which the open meeting shall resume. Such motion, including the required statement, shall be recorded in the minutes of the meeting and 1819 shall be maintained as a part of the permanent records of the body or 20agency. Discussion during the closed or executive meeting shall be limited 21to those subjects stated in the motion.

(b) No subjects shall be discussed at any closed or executive meeting,except the following:

(1) Personnel matters of nonelected personnel;

(2) consultation with an attorney for the body or agency which would26 be deemed privileged in the attorney-client relationship;

(3) matters relating to employer-employee negotiations whether or
not in consultation with the representative or representatives of the body
or agency;

(4) confidential data relating to financial affairs or trade secrets of
 corporations, partnerships, trusts, and individual proprietorships;

(5) matters relating to actions adversely or favorably affecting a person as a student, patient or resident of a public institution, except that
any such person shall have the right to a public hearing if requested by
the person;

36 (6) preliminary discussions relating to the acquisition of real property;

matters permitted to be discussed in a closed or executive meeting
 pursuant to K.S.A. 74-8804 and amendments thereto;

(8) matters permitted to be discussed in a closed or executive meeting
pursuant to subsection (e) of K.S.A. 38-1507 and amendments thereto or
subsection (f) of K.S.A. 38-1508 and amendments thereto;

(9) matters permitted to be discussed in a closed or executive meeting
 pursuant to subsection (j) of K.S.A. 22a-243 and amendments thereto;

1 (10) matters permitted to be discussed in a closed or executive meet-2 ing pursuant to subsection (e) of K.S.A. 44-596 and amendments thereto;

3 (11) matters permitted to be discussed in a closed or executive meet-

4 ing pursuant to subsection (g) of K.S.A. 39-7,119 and amendments5 thereto;

6 (12) matters required to be discussed in a closed or executive meeting 7 pursuant to a tribal-state gaming compact;

8 (13) matters relating to the security of a public body or agency, public 9 building or facility or the information system of a public body or agency, 10 if the discussion of such matters at an open meeting would jeopardize 11 the security of such public body, agency, building, facility or information 12 system; and

(14) matters permitted to be discussed in a closed or executive meet ing pursuant to subsection (f) of K.S.A. 65-525, and amendments thereto;
 and

(15) matters permitted to be discussed in a closed or executive meeting
 pursuant to section 1, and amendments thereto.

(c) No binding action shall be taken during closed or executive recesses, and such recesses shall not be used as a subterfuge to defeat the
purposes of this act.

Sec. 3. K.S.A. 2001 Supp. 75-4319 is hereby repealed.
