9 AN ACT enacting the uniform prescription drug information card act. 10 11 Be it enacted by the Legislature of the State of Kansas: 12 Section 1. This act shall be known and may be cited as the uniform 13 prescription drug information card act. 14Sec. 2. It is the intent and purpose of the legislature to lessen pa-15tient's waiting times, decrease administrative burdens for pharmacies and 16 improve care to patients by minimizing confusion, eliminating unneces-17sary paperwork and streamlining the dispensing of prescription products 18 paid for by third-party payors. This act shall be broadly applied and con-19 strued to effectuate this purpose. 20 Sec. 3. As used in this act: 21"Commissioner" means the Kansas commissioner of insurance; (a) 22 (b) "department" means the Kansas department of insurance; and 23 "health benefit plan" shall have the meaning ascribed to such term (c)24by subsection (1) of K.S.A. 40-2209d, and amendments thereto. 25Sec. 4. (a) A health benefit plan that provides coverage for prescrip-26 tion drugs or devices and issues a card for claims processing and an ad-27 ministrator of any such plan, including, but not limited to, pharmacy ben-28efits managers, third-party administrators for self-insured plans and 29 state-administered plans, shall issue to each insured a card containing 30 uniform prescription drug information. The uniform prescription drug 31 information card shall specifically identify and display the following man-32 datory data elements: 33 (1)Bank identification number (BIN); processor control number or group number or both, if required 34 (2)35 for claims adjudication; 36 (3)card issuer identifier; 37 prescription claims processor, if different from card issuer; (4)cardholder identification number; 38 (5)cardholder name; 39 (6)40 claims submission names and addresses; and (7)41 (8)help desk telephone numbers. 42 (b) A uniform prescription drug information card shall be issued by 43 a health benefit plan to each participant in the plan upon enrollment and

reissued upon any change in the insured's coverage that affects one or
 more mandatory data elements contained on the card.

3 (c) If the card has been issued for both health and prescription drug
4 benefits, all information necessary to process a claim shall be located on
5 the front of such card. If the group number for prescription benefits
6 differs from the group number for health benefits, the group number for
7 prescription benefits shall be clearly identified.

8 Sec. 5. The uniform prescription drug information card may be used 9 for any and all health insurance coverage. Nothing in this act shall be 10 construed as requiring any person issuing a card for processing of claims 11 under a health benefit plan to issue a separate card for prescription drug 12 coverage, as long as the card is able to accommodate the information 13 necessary to process a prescription drug claim, as required by section 4, 14 and amendments thereto.

15 Sec. 6. (a) This act shall apply to any health benefit plan that is 16 amended, delivered, issued or renewed on or after the effective date of 17 this act.

(b) The commissioner may adopt rules and regulations that are nec-essary to implement the provisions of this act.

20Sec. 7. This act shall be administered and enforced by the commis-21sioner in the same manner as is provided for administering and enforcing 22 the statutes regarding insurers' unfair methods of competition and unfair 23or deceptive acts or practices, as provided by K.S.A. 40-2405, 40-2406, 2440-2407, 40-2408 and 40-2411, and amendments thereto, and the com-25missioner shall have and may exercise the powers granted by K.S.A. 40-26 2405, 40-2406, 40-2407, 40-2408 and 40-2411, and amendments thereto, 27 in administering and enforcing the provisions of this act.

28 Sec. 8. This act shall take effect and be in force from and after its 29 publication in the statute book.
