9 AN ACT concerning sales taxation; relating to manufacturer's rebates on 10 sales or leases of motor vehicles; amending K.S.A. 2003 Supp. 79-3602 and repealing the existing section. 11 1213 Be it enacted by the Legislature of the State of Kansas: 14Section 1. K.S.A. 2003 Supp. 79-3602 is hereby amended to read as 15follows: 79-3602. Except as otherwise provided, as used in the Kansas 16retailers' sales tax act: 17(a) "Agent" means a person appointed by a seller to represent the 18seller before the member states. 19 "Agreement" means the multistate agreement entitled the (b) 20streamlined sales and use tax agreement approved by the streamlined 21sales tax implementing states at Chicago, Illinois on November 12, 2002. 22 (c) "Alcoholic beverages" means beverages that are suitable for hu-23 man consumption and contain .05% or more of alcohol by volume. 24 "Certified automated system (CAS)" means software certified un-(d) 25der the agreement to calculate the tax imposed by each jurisdiction on a 26 transaction, determine the amount of tax to remit to the appropriate state 27and maintain a record of the transaction. 28(e) "Certified service provider (CSP)" means an agent certified under 29the agreement to perform all the seller's sales and use tax functions, other 30 than the seller's obligation to remit tax on its own purchases. 31 "Computer" means an electronic device that accepts information (f) 32 in digital or similar form and manipulates it for a result based on a se-33 quence of instructions. 34 "Computer software" means a set of coded instructions designed (g) 35 to cause a computer or automatic data processing equipment to perform 36 a task. 37 "Delivered electronically" means delivered to the purchaser by (h) 38 means other than tangible storage media. 39 "Delivery charges" means charges by the seller of personal prop-(i) erty or services for preparation and delivery to a location designated by 4041the purchaser of personal property or services including, but not limited 42to, transportation, shipping, postage, handling, crating and packing. 43 "Direct mail" means printed material delivered or distributed by (j)

1 United States mail or other delivery services to a mass audience or to 2 addressees on a mailing list provided by the purchaser or at the direction 3 of the purchaser when the cost of the items are not billed directly to the 4 recipients. Direct mail includes tangible personal property supplied di-5 rectly or indirectly by the purchaser to the direct mail seller for inclusion 6 in the package containing the printed material. Direct mail does not in-7 clude multiple items of printed material delivered to a single address.

(k) "Director" means the state director of taxation.

9 (l) "Educational institution" means any nonprofit school, college and 10 university that offers education at a level above the twelfth grade, and 11 conducts regular classes and courses of study required for accreditation 12 by, or membership in, the North Central Association of Colleges and 13 Schools, the state board of education, or that otherwise qualify as an 14"educational institution," as defined by K.S.A. 74-50,103, and amend-15ments thereto. Such phrase shall include: (1) A group of educational in-16 stitutions that operates exclusively for an educational purpose; (2) non-17profit endowment associations and foundations organized and operated 18 exclusively to receive, hold, invest and administer moneys and property 19 as a permanent fund for the support and sole benefit of an educational 20 institution; (3) nonprofit trusts, foundations and other entities organized 21and operated principally to hold and own receipts from intercollegiate 22 sporting events and to disburse such receipts, as well as grants and gifts, 23 in the interest of collegiate and intercollegiate athletic programs for the 24 support and sole benefit of an educational institution; and (4) nonprofit 25trusts, foundations and other entities organized and operated for the pri-26mary purpose of encouraging, fostering and conducting scholarly inves-27tigations and industrial and other types of research for the support and 28sole benefit of an educational institution.

(m) "Electronic" means relating to technology having electrical, dig-ital, magnetic, wireless, optical, electromagnetic or similar capabilities.

(n) "Food and food ingredients" means substances, whether in liquid,
concentrated, solid, frozen, dried or dehydrated form, that are sold for
ingestion or chewing by humans and are consumed for their taste or
nutritional value. "Food and food ingredients" does not include alcoholic
beverages or tobacco.

36 "Gross receipts" means the total selling price or the amount re- $(\mathbf{0})$ 37 ceived as defined in this act, in money, credits, property or other consid-38 eration valued in money from sales at retail within this state; and em-39 braced within the provisions of this act. The taxpayer, may take credit in 40the report of gross receipts for: (1) An amount equal to the selling price 41of property returned by the purchaser when the full sale price thereof, 42 including the tax collected, is refunded in cash or by credit; and (2) an 43 amount equal to the allowance given for the trade-in of property.

"Ingredient or component part" means tangible personal property 1 (\mathbf{p}) 2 which is necessary or essential to, and which is actually used in and be-3 comes an integral and material part of tangible personal property or services produced, manufactured or compounded for sale by the producer, 4 manufacturer or compounder in its regular course of business. The fol-56 lowing items of tangible personal property are hereby declared to be 7 ingredients or component parts, but the listing of such property shall not be deemed to be exclusive nor shall such listing be construed to be a 8 9 restriction upon, or an indication of, the type or types of property to be 10 included within the definition of "ingredient or component part" as 11 herein set forth:

(1) Containers, labels and shipping cases used in the distribution of
 property produced, manufactured or compounded for sale which are not
 to be returned to the producer, manufacturer or compounder for reuse.

(2) Containers, labels, shipping cases, paper bags, drinking straws,
paper plates, paper cups, twine and wrapping paper used in the distribution and sale of property taxable under the provisions of this act by
wholesalers and retailers and which is not to be returned to such wholesaler or retailer for reuse.

20 (3) Seeds and seedlings for the production of plants and plant prod-21 ucts produced for resale.

(4) Paper and ink used in the publication of newspapers.

(5) Fertilizer used in the production of plants and plant productsproduced for resale.

(6) Feed for animals, fowl and aquatic plants and animals, the primary
purpose of which is use in agriculture or aquaculture, as defined in K.S.A.
47-1901, and amendments thereto, the production of food for human
consumption, the production of animal, dairy, poultry or aquatic plant
and animal products, fiber, fur, or the production of offspring for use for
any such purpose or purposes.

31 (q) "Isolated or occasional sale" means the nonrecurring sale of tan-32 gible personal property, or services taxable hereunder by a person not 33 engaged at the time of such sale in the business of selling such property or services. Any religious organization which makes a nonrecurring sale 34 35 of tangible personal property acquired for the purpose of resale shall be 36 deemed to be not engaged at the time of such sale in the business of 37 selling such property. Such term shall include: (1) Any sale by a bank, 38 savings and loan institution, credit union or any finance company licensed 39 under the provisions of the Kansas uniform consumer credit code of tan-40 gible personal property which has been repossessed by any such entity; 41 and (2) any sale of tangible personal property made by an auctioneer or 42agent on behalf of not more than two principals or households if such 43 sale is nonrecurring and any such principal or household is not engaged 1 at the time of such sale in the business of selling tangible personal 2 property.

3 (r) "Lease or rental" means any transfer of possession or control of 4 tangible personal property for a fixed or indeterminate term for consid-5 eration. A lease or rental may include future options to purchase or 6 extend.

(1) Lease or rental does not include: (A) A transfer of possession or
control of property under a security agreement or deferred payment plan
that requires the transfer of title upon completion of the required
payments;

(B) a transfer or possession or control of property under an agreement that requires the transfer of title upon completion of required payments and payment of an option price does not exceed the greater of
\$100 or 1% of the total required payments; or

(C) providing tangible personal property along with an operator for
a fixed or indeterminate period of time. A condition of this exclusion is
that the operator is necessary for the equipment to perform as designed.
For the purpose of this subsection, an operator must do more than maintain, inspect or set-up the tangible personal property.

20 (2) Lease or rental does include agreements covering motor vehicles 21 and trailers where the amount of consideration may be increased or de-22 creased by reference to the amount realized upon sale or disposition of 23 the property as defined in 26 U.S.C. 7701(h)(1).

(3) This definition shall be used for sales and use tax purposes regardless if a transaction is characterized as a lease or rental under generally accepted accounting principles, the internal revenue code, the uniform commercial code, K.S.A. 84-1-101 *et seq.* and amendments thereto,
or other provisions of federal, state or local law.

(4) This definition will be applied only prospectively from the effective date of this act and will have no retroactive impact on existing leases
or rentals.

(s) "Load and leave" means delivery to the purchaser by use of a
tangible storage media where the tangible storage media is not physically
transferred to the purchaser.

(t) "Member state" means a state that has entered in the agreement,pursuant to provisions of article VIII of the agreement.

(u) "Model 1 seller" means a seller that has selected a CSP as its
agent to perform all the seller's sales and use tax functions, other than
the seller's obligation to remit tax on its own purchases.

(v) "Model 2 seller" means a seller that has selected a CAS to perform
part of its sales and use tax functions, but retains responsibility for remitting the tax.

43 (w) "Model 3 seller" means a seller that has sales in at least five

1 member states, has total annual sales revenue of at least \$500,000,000, 2 has a proprietary system that calculates the amount of tax due each juris-3 diction and has entered into a performance agreement with the member 4 states that establishes a tax performance standard for the seller. As used 5 in this subsection a seller includes an affiliated group of sellers using the 6 same proprietary system. 7 (r) "Municipal comportion" means any situ incomported under the

7~(x)~ "Municipal corporation" means any city incorporated under the 8~ laws of Kansas.

9 (\mathbf{v}) "Nonprofit blood bank" means any nonprofit place, organization, 10institution or establishment that is operated wholly or in part for the 11 purpose of obtaining, storing, processing, preparing for transfusing, fur-12nishing, donating or distributing human blood or parts or fractions of 13 single blood units or products derived from single blood units, whether 14or not any remuneration is paid therefor, or whether such procedures are done for direct therapeutic use or for storage for future use of such 1516products.

(z) "Persons" means any individual, firm, copartnership, joint adventure, association, corporation, estate or trust, receiver or trustee, or any
group or combination acting as a unit, and the plural as well as the singular
number; and shall specifically mean any city or other political subdivision
of the state of Kansas engaging in a business or providing a service specifically taxable under the provisions of this act.

23 (aa) "Political subdivision" means any municipality, agency or sub-24 division of the state which is, or shall hereafter be, authorized to levy taxes 25upon tangible property within the state or which certifies a levy to a 26 municipality, agency or subdivision of the state which is, or shall hereafter 27be, authorized to levy taxes upon tangible property within the state. Such 28term also shall include any public building commission, housing, airport, 29port, metropolitan transit or similar authority established pursuant to law. 30 "Prescription" means an order, formula or recipe issued in any (bb)31 form of oral, written, electronic or other means of transmission by a duly 32 licensed practitioner authorized by the laws of this state.

33 "Prewritten computer software" means computer software, in-(cc)34 cluding prewritten upgrades, which is not designed and developed by the 35 author or other creator to the specifications of a specific purchaser. The 36 combining of two or more prewritten computer software programs or 37 prewritten portions thereof does not cause the combination to be other 38 than prewritten computer software. Prewritten computer software in-39 cludes software designed and developed by the author or other creator 40 to the specifications of a specific purchaser when it is sold to a person 41other than the purchaser. Where a person modifies or enhances computer 42software of which the person is not the author or creator, the person shall 43 be deemed to be the author or creator only of such person's modifications

or enhancements. Prewritten computer software or a prewritten portion 1 2 thereof that is modified or enhanced to any degree, where such modifi-3 cation or enhancement is designed and developed to the specifications of 4 a specific purchaser, remains prewritten computer software, except that 5where there is a reasonable, separately stated charge or an invoice or 6 other statement of the price given to the purchaser for such modification 7 or enhancement, such modification or enhancement shall not constitute 8 prewritten computer software. 9 (dd)"Property which is consumed" means tangible personal property 10 which is essential or necessary to and which is used in the actual process 11 of and consumed, depleted or dissipated within one year in (1) the pro-12 duction, manufacture, processing, mining, drilling, refining or compound-13 ing of tangible personal property, (2) the providing of services, (3) the 14irrigation of crops, for sale in the regular course of business, or (4) the 15storage or processing of grain by a public grain warehouse or other grain 16 storage facility, and which is not reusable for such purpose. The following 17is a listing of tangible personal property, included by way of illustration 18but not of limitation, which qualifies as property which is consumed: 19 (A) Insecticides, herbicides, germicides, pesticides, fungicides, fu-20migants, antibiotics, biologicals, pharmaceuticals, vitamins and chemicals 21for use in commercial or agricultural production, processing or storage of 22 fruit, vegetables, feeds, seeds, grains, animals or animal products whether 23fed, injected, applied, combined with or otherwise used; 24 electricity, gas and water; and (B) (C) petroleum products, lubricants, chemicals, solvents, reagents and 2526catalysts. 27(ee) "Purchase price" applies to the measure subject to use tax and 28has the same meaning as sales price. 29"Purchaser" means a person to whom a sale of personal property (ff)30 is made or to whom a service is furnished. 31 "Quasi-municipal corporation" means any county, township, (gg)32 school district, drainage district or any other governmental subdivision in 33 the state of Kansas having authority to receive or hold moneys or funds. 34 (hh) "Registered under this agreement" means registration by a seller 35 with the member states under the central registration system provided in 36 article IV of the agreement. 37 (ii) "Retailer" means a seller regularly engaged in the business of 38 selling, leasing or renting tangible personal property at retail or furnishing electrical energy, gas, water, services or entertainment, and selling only 39 40to the user or consumer and not for resale. "Retail sale" or "sale at retail" means any sale, lease or rental for 41 (**ii**) 42 any purpose other than for resale, sublease or subrent.

43 (kk) "Sale" or "sales" means the exchange of tangible personal prop-

erty, as well as the sale thereof for money, and every transaction, condi-1 2 tional or otherwise, for a consideration, constituting a sale, including the 3 sale or furnishing of electrical energy, gas, water, services or entertainment taxable under the terms of this act and including, except as provided 4 5in the following provision, the sale of the use of tangible personal property 6 by way of a lease, license to use or the rental thereof regardless of the 7 method by which the title, possession or right to use the tangible personal property is transferred. The term "sale" or "sales" shall not mean the sale 8 9 of the use of any tangible personal property used as a dwelling by way of 10 a lease or rental thereof for a term of more than 28 consecutive days. (11) (1) "Sales or selling price" applies to the measure subject to 11

12 sales tax and means the total amount of consideration, including cash, 13 credit, property and services, for which personal property or services are 14 sold, leased or rented, valued in money, whether received in money or 15 otherwise, without any deduction for the following:

16 (A) The seller's cost of the property sold;

(B) the cost of materials used, labor or service cost, interest, losses,
all costs of transportation to the seller, all taxes imposed on the seller and
any other expense of the seller;

20 (C) charges by the seller for any services necessary to complete the 21 sale, other than delivery and installation charges;

22 (D) delivery charges;

23 (E) installation charges; and

(F) the value of exempt personal property given to the purchaserwhere taxable and exempt personal property have been bundled togetherand sold by the seller as a single product or piece of merchandise.

27 (2) "Sales or selling price" shall not include:

(A) Discounts, including cash, term or coupons that are not reimbursed by a third party that are allowed by a seller and taken by a purchaser on a sale and, including cash rebates granted by a manufacturer to a purchaser or lessee of a new motor vehicle if paid directly to the retailer or dealer as a result of the original sale;

(B) interest, financing and carrying charges from credit extended on
the sale of personal property or services, if the amount is separately stated
on the invoice, bill of sale or similar document given to the purchaser;

36 (C) any taxes legally imposed directly on the consumer that are sep 37 arately stated on the invoice, bill of sale or similar document given to the
 38 purchaser; and

(D) the amount equal to the allowance given for the trade-in of property, if separately stated on the invoice, billing or similar document given
to the purchaser.

42 (mm) "Seller" means a person making sales, leases or rentals of per-43 sonal property or services. 1 (nn) "Service" means those services described in and taxed under the 2 provisions of K.S.A. 79-3603 and amendments thereto.

3 (oo) "Sourcing rules" means the rules set forth in K.S.A. 2003 Supp. 4 79-3670 through 79-3673, K.S.A. 12-191 and 12-191a, and amendments 5 thereto, which shall apply to identify and determine the state and local 6 taxing jurisdiction sales or use taxes to pay, or collect and remit on a 7 particular retail sale.

8 (pp) "Tangible personal property" means personal property that can 9 be seen, weighed, measured, felt or touched, or that is in any other man-10 ner perceptible to the senses. Tangible personal property includes elec-11 tricity, water, gas, steam and prewritten computer software.

12 (qq) "Taxpayer" means any person obligated to account to the direc-13 tor for taxes collected under the terms of this act.

14 (rr) "Tobacco" means cigarettes, cigars, chewing or pipe tobacco or 15 any other item that contains tobacco.
