(a) Notwithstanding any other provision of law to the 15 contrary and subject to the provisions of this section, in any civil action 16 of any nature commenced or appealed in any court in this state, the court 17shall award reasonable attorney fees to the prevailing party as part of the 18courts judgment and taxed as part of the costs of the action in addition 19to any costs otherwise assessed pursuant to K.S.A. 60-2003, and amend-20ments thereto. Such costs and fees shall be paid by the nonprevailing 21party or parties. If more than one party is responsible for costs and fees, such costs and fees shall be equitably apportioned by the court among 22 23 the responsible parties. 24 (b) As used in this section: 25"Civil action" shall not include a personal injury action. 10 (9) Reasonable attorney fees awarded to the prevailing party pursu-11 ant to section 1, and amendments thereto.
