AN ACT concerning insurance; providing coverage for telemedicine; amending K.S.A. 2006 Supp. 40-2,103 and 40-19c09 and repealing the existing sections.

Be it enacted by the Legislature of the State of Kansas:

New Section 1. (a) (1) Any individual or group health insurance policy, medical service plan, contract, hospital service corporation contract, hospital and medical service corporation contract, fraternal benefit society or health maintenance organization which provides coverage for accident and health services and which is delivered, issued for delivery, amended or renewed on or after January 1, 2008, shall also provide coverage for telemedicine.

- (2) Such telemedicine coverage shall be provided in a manner determined in consultation with the attending physician and the patient. Such coverage may be subject to annual deductibles and coinsurance provisions as may be deemed appropriate and as are consistent with those established for other benefits under the plan or coverage.
- (b) Each individual or group health insurance policy, medical service plan, contract, hospital service corporation contract, hospital and medical service corporation contract, fraternal benefit society or health maintenance organization which provides coverage for accident and health services which provides medical and surgical benefits shall provide written notice, as currently required, to all enrollees, insureds or subscribers regarding the coverage required by this section.
- (c) No individual or group health insurance policy, medical service plan, contract, hospital service corporation contract, hospital and medical service corporation contract, fraternal benefit society or health maintenance organization which provides coverage for accident and health services which provides medical and surgical benefits shall:
- (1) Deny to a patient eligibility, or continued eligibility, to enroll or to renew coverage under the terms of the plan, solely for the purpose of avoiding the requirements of this section; and
- (2) penalize or otherwise reduce or limit the reimbursement of an attending provider, or provide incentives (monetary or otherwise) to an attending provider, to induce such provider to provide care to an individ-

ual participant or beneficiary in a manner inconsistent with this section.

- (d) The provisions of this section shall not apply to any policy or certificate which provides coverage for any specified disease, specified accident or accident only coverage, credit, dental, disability income, hospital indemnity, long-term care insurance as defined by K.S.A. 40-2227 and amendments thereto, vision care or any other limited supplemental benefit nor to any medicare supplement policy of insurance as defined by the commissioner of insurance by rule and regulation, any coverage issued as a supplement to liability insurance, workers' compensation or similar insurance, automobile medical-payment insurance or any insurance under which benefits are payable with or without regard to fault, whether written on a group, blanket or individual basis.
 - For the purposes of this section:
- "Emergency services" shall have the meaning ascribed to it in K.S.A. 40-4603 and amendments thereto.
 - "Physician" shall have the meaning ascribed to it in K.S.A. 40-4603 and amendments thereto.
- "Provider" shall have the meaning ascribed to it in K.S.A. 40-4603 and amendments thereto.
- "Telecommunications services" means providing the means of transmission, between or among points specified by the user, of infor-22 mation of the user's choosing, without change in the form or content of the information as sent and received, including, but not limited to twoway video or data messages.
 - "Telemedicine" means the use of telecommunications services to link health care practitioners and patients in different locations. Telemedicine includes any of the following provided through the use of telecommunications services:
- 29 (A) Consultation or office visit with a licensed health care practitioner; 30
 - individual psychotherapy;
 - pharmacological management service; or
 - (D) emergency services.

- (b) No policy, agreement, contract or certificate issued by a corporation to which this section applies shall contain a provision which excludes, limits or otherwise restricts coverage because medicaid benefits as permitted by title XIX of the social security act of 1965 are or may be available for the same accident or illness.
