9 AN ACT concerning certain public officers and employees; relating to use of unexpended campaign funds; amending K.S.A. 25-4142 and 25-104157a and K.S.A. 2006 Supp. 25-4143 and repealing the existing 11 12sections. 13 14Be it enacted by the Legislature of the State of Kansas: 15Section 1. K.S.A. 25-4142 is hereby amended to read as follows: 25-164142. K.S.A. 25-4119e, 25-4119f, 25-4119g, 25-4142 through 25-4187 and 17K.S.A. 25-4153b sections 4 and 5, and amendments thereto, shall be known and may be cited as the campaign finance act. 18 Sec. 2. K.S.A. 2006 Supp. 25-4143 is hereby amended to read as 1920follows: 25-4143. As used in the campaign finance act, unless the context 21otherwise requires: 22 "Candidate" means an individual who: (1) Appoints a treasurer or (a) 23 a candidate committee; 24 (2)makes a public announcement of intention to seek nomination or 25election to state or local office; 26 makes any expenditure or accepts any contribution for such per-(3)27son's nomination or election to any state or local office; or 28(4)files a declaration or petition to become a candidate for state or 29 local office. 30 (b) "Candidate committee" means a committee appointed by a can-31didate to receive contributions and make expenditures for the candidate. 32 (c) "Clearly identified candidate" means a candidate who has been 33 identified by the: 34 Use of the name of the candidate; (1)35 (2)use of a photograph or drawing of the candidate; or unambiguous reference to the candidate whether or not the 36 (3)37 name, photograph or drawing of such candidate is used. 38 (d) "Commission" means the governmental ethics commission. 39 (e) (1)"Contribution" means: 40 Any advance, conveyance, deposit, distribution, gift, loan or pay-(A) ment of money or any other thing of value given to a candidate, candidate 4142committee, party committee or political committee for the express pur-43 pose of nominating, electing or defeating a clearly identified candidate 17

2 (B) Any advance, conveyance, deposit, distribution, gift, loan or pay-3 ment of money or any other thing of value made to expressly advocate 4 the nomination, election or defeat of a clearly identified candidate for a 5 state or local office;

6 (C) a transfer of funds between any two or more candidate commit-7 tees, party committees or political committees;

8 (D) the payment, by any person other than a candidate, candidate 9 committee, party committee or political committee, of compensation to 10 an individual for the personal services rendered without charge to or for 11 a candidate's campaign or to or for any such committee;

12 (E) the purchase of tickets or admissions to, or advertisements in 13 journals or programs for, testimonial events;

(F) a mailing of materials designed to expressly advocate the nomination, election or defeat of a clearly identified candidate, which is made
and paid for by a party committee with the consent of such candidate.

(2) "Contribution" does not include:

18 (A) The value of volunteer services provided without compensation;

(B) costs to a volunteer related to the rendering of volunteer services
not exceeding a fair market value of \$50 during an allocable election
period as provided in K.S.A. 25-4149, and amendments thereto;

(C) payment by a candidate or candidate's spouse for personal meals,
lodging and travel by personal automobile of the candidate or candidate's
spouse while campaigning;

(D) the value of goods donated to events such as testimonial events,
bake sales, garage sales and auctions by any person not exceeding a fair
market value of \$50 per event; or

(E) the transfer of campaign funds to a bona fide successor committee
or candidacy in accordance with K.S.A. 25-4157a, and amendments
thereto.

31 (f) "Election" means:

(1) A primary or general election for state or local office; and

(2) a convention or caucus of a political party held to nominate acandidate for state or local office.

35 (g) (1) "Expenditure" means:

(A) Any purchase, payment, distribution, loan, advance, deposit or
gift of money or any other thing of value made by a candidate, candidate
committee, party committee or political committee for the express purpose of nominating, electing or defeating a clearly identified candidate
for a state or local office.

(B) Any purchase, payment, distribution, loan, advance, deposit or
gift of money or any other thing of value made to expressly advocate the
nomination, election or defeat of a clearly identified candidate for a state

2 (C) any contract to make an expenditure;

3 (D) a transfer of funds between any two or more candidate commit-4 tees, party committees or political committees; or

5 (E) payment of a candidate's filing fees.

(2) "Expenditure" does not include:

(A) The value of volunteer services provided without compensation;

8 (B) costs to a volunteer incidental to the rendering of volunteer serv-9 ices not exceeding a fair market value of \$50 during an allocable election 10 period as provided in K.S.A. 25-4149, and amendments thereto;

(C) payment by a candidate or candidate's spouse for personal meals,
lodging and travel by personal automobile of the candidate or candidate's
spouse while campaigning or payment of such costs by the treasurer of a
candidate or candidate committee;

(D) the value of goods donated to events such as testimonial events,
bake sales, garage sales and auctions by any person not exceeding fair
market value of \$50 per event; or

(E) any communication by an incumbent elected state or local officer
with one or more individuals unless the primary purpose thereof is to
expressly advocate the nomination, election or defeat of a clearly identified candidate.

(h) "Expressly advocate the nomination, election or defeat of a clearly
identified candidate" means any communication which uses phrases including, but not limited to:

25 (1) "Vote for the secretary of state";

26 (2) "re-elect your senator";

27 (3) "support the democratic nominee";

28 (4) "cast your ballot for the republican challenger for governor";

29 (5) "Smith for senate";

30 (6) "Bob Jones in '98";

31 (7) "vote against Old Hickory";

32 (8) "defeat" accompanied by a picture of one or more candidates; or

33 (9) "Smith's the one."

34 (i) "Party committee" means:

(1) The state committee of a political party regulated by article 3 of
 chapter 25 of the Kansas Statutes Annotated, and amendments thereto;

(2) the county central committee or the state committee of a political
party regulated under article 38 of chapter 25 of the Kansas Statutes
Annotated, and amendments thereto;

40 (3) the bona fide national organization or committee of those political41 parties regulated by the Kansas Statutes Annotated;

42 (4) not more than one political committee established by the state 43 committee of any such political party and designated as a recognized 1 political committee for the senate;

(5) not more than one political committee established by the state 2 committee of any such political party and designated as a recognized 3 political committee for the house of representatives; or 4 (6) not more than one political committee per congressional district 5established by the state committee of a political party regulated under 6 7 article 38 of chapter 25 of the Kansas Statutes Annotated, and amendments thereto, and designated as a congressional district party committee. 8 9 (j) "Person" means any individual, committee, corporation, partnership, trust, organization or association. 10(k) (1) "Political committee" means any combination of two or more 11 12individuals or any person other than an individual, a major purpose of 13 which is to expressly advocate the nomination, election or defeat of a clearly identified candidate for state or local office or make contributions 1415 to or expenditures for the nomination, election or defeat of a clearly 16identified candidate for state or local office. 17"Political committee" shall not include a candidate committee or (2)18a party committee.

(l) "Receipt" means a contribution or any other money or thing of
value, but not including volunteer services provided without compensation, received by a treasurer in the treasurer's official capacity.

22 (m) "Public office" means a state or local office.

23 (n) "Local office" means:

24 (1) A member of the governing body of a city of the first class;

25 (2) an elected office of:

(A) A unified school district having 35,000 or more pupils regularly
 enrolled in the preceding school year;

(B) a county; or

(C) the board of public utilities.

(m) (*o*) "State office" means any state office as defined in K.S.A. 25-31 2505, and amendments thereto.

36 (o)(q) "Treasurer" means a treasurer of a candidate or of a candidate 37 committee, a party committee or a political committee appointed under 38 the campaign finance act or a treasurer of a combination of individuals 39 or a person other than an individual which is subject to paragraph (2) of 40 subsection (a) of K.S.A. 25-4172, and amendments thereto.

41 (p) "Local office" means a member of the governing body of a city

2 Sec. 3. K.S.A. 25-4157a is hereby amended to read as follows: 25-3 4157a. (a) No moneys received by any candidate or candidate commit-4 tee of any candidate as a contribution under this act shall be used or be 5 made available for the personal use of the candidate and no such moneys 6 shall be used by such candidate or the candidate committee of such can-7 didate except for:

(1) Legitimate campaign purposes;

(2) expenses of holding political office;

10 (3) contributions to the party committees of the political party of 11 which such candidate is a member;

(4) any membership dues or donations paid to a community service,
 charitable or civic organization in the name of the candidate or candidate
 committee of any candidate;

(5) expenses incurred in the purchase of tickets to meals and special
events sponsored by any organization the major purpose of which is to
promote or facilitate the social, business, commercial or economic well
being of the local community; or

(6) expenses incurred in the purchase and mailing of greeting cardsto voters and constituents.

For the purpose of this subsection, expenditures for "personal use" shall include expenditures to defray normal living expenses for the candidate or the candidate's family and expenditures for the personal benefit of the candidate having no direct connection with or effect upon the campaign of the candidate or the holding of public office.

(b) No moneys received by any candidate or candidate committee of
any candidate as a contribution shall be used to pay interest or any other
finance charges upon moneys loaned to the campaign by such candidate
or the spouse of such candidate.

(c) No candidate or candidate committee shall accept from any other
candidate or candidate committee for any candidate for local, state or
national office, any moneys received by such candidate or candidate committee as a campaign contribution. The provisions of this subsection shall
not be construed to prohibit:

(1) A candidate or candidate committee from accepting moneys from another candidate or candidate committee if such moneys constitute a reimbursement for one candidate's proportional share of the cost of any campaign activity participated in by both candidates involved. Such reimbursement shall not exceed an amount equal to the proportional share of the cost directly benefiting and attributable to the personal campaign of the candidate making such reimbursement; or

42 (2) A candidate or candidate committee from transferring campaign
 43 funds to a bona fide successor committee or candidacy established by the

1 candidate.

2 (d) At the time of the termination of any campaign and prior to the 3 filing of a termination report in accordance with K.S.A. 25-4157, and amendments thereto, all residual funds otherwise not obligated for the 4 payment of expenses incurred in such campaign or the holding of office 5 shall be contributed to a charitable organization, as defined by the laws 6 7 of the state, contributed to a party committee or returned as a refund in whole or in part to any contributor or contributors from whom received 8 or paid into the general fund of the state. At the time of the termination 9 of any campaign and prior to the filing of a termination report in ac-10cordance with K.S.A. 25-4157, and amendments thereto, all residual funds 11 12not otherwise obligated for the payment of expenses incurred in such campaign or the holding of office, or any portion of such funds, shall be: 13 (1) Contributed to a charitable organization, as defined by the laws 1415of the state; or contributed to a party committee; or 16(2)(3) returned as a refund in whole or in part to any contributor or 17contributors from whom such funds were received; or 18paid into the general fund of the state; or 19(4)20(5) transferred to a bona fide successor committee or candidacy es-21tablished by the candidate; or (6) transferred for the purpose of retiring the remaining debt to the 22 23 original committee or candidacy from which funds were transferred pursuant to paragraph (2) of subsection (e). 24 Whenever a transfer to a bona fide successor committee or candidacy 2526is made pursuant to paragraph (5), all moneys shall be transferred to the 27 bona fide successor committee or candidacy. 28(e) For the purposes of this section, "bona fide successor committee 29 or candidacy" means: (1) The candidate's campaign committee or candidacy for a public 30 office initiated at the termination of the original candidacy; or 31 32 (2) the candidate's campaign committee or candidacy initiated at the time of the transfer of all moneys to a new campaign committee or can-33 34 didacy for public office when there is debt in the original campaign at the 35 time of the transfer and the candidate does not terminate the original campaign committee or candidacy. 36 New Sec. 4. (a) Upon transferring money to a bona fide successor 37 38 committee or candidacy as defined by paragraph (2) of subsection (e) of 39 K.S.A. 25-4157a, and amendments thereto, the candidate may only accept contributions to the original candidacy sufficient to retire the debt. Such 40 contributions shall be subject to the contribution limits for the original 41office sought as set forth in K.S.A. 25-4153, and amendments thereto. 42

43 Once the candidate has received sufficient contributions to retire the

1 debt, the candidate must terminate the candidacy pursuant to the pro-

visions set forth in subsection (d) of K.S.A. 25-4157a, and amendmentsthereto.

4 (b) This section shall be part of and supplemental to the campaign 5 finance act.

New Sec. 5. (a) For the period commencing on January 1, 1976, and 6 7 ending on the day preceding the effective date of this act, any candidate who transferred campaign funds to a bona fide successor candidacy, as 8 9 such term is defined in K.S.A. 25-4157a, and amendments thereto, shall be deemed to have made such transfer in compliance with the provisions 10 of the campaign finance act in existence at the time of such transfer 11regardless of when the original campaign fund is closed after the date 1213 such transfer is made and such transfer is hereby validated. (b) This section shall be part of and supplemental to the campaign 14 15 finance act.

Sec. 6. K.S.A. 25-4142 and 25-4157a and K.S.A. 2006 Supp. 25-4143
are hereby repealed.

18 Sec. 7. This act shall take effect and be in force from and after its19 publication in the statute book.
