9 AN ACT concerning school districts; concerning grants for the payment of costs relating to attaining endorsement as an ESOL teacher.

Be it enacted by the Legislature of the State of Kansas:

Section 1. (a) As used in this section:

- (1) "ESOL" means English for speakers of other languages.
- (2) "Direct costs" means the costs of books, fees, tuition or other charges for courses necessary to attain full endorsement as an ESOL teacher.
- (b) The board of education of any school district may reimburse any teacher employed by the school district for the direct costs incurred by such teacher in attaining full endorsement as an ESOL teacher.
- (c) Subject to the limitations of appropriations therefor, each school year any school district which has reimbursed teachers as authorized by subsection (b) is eligible to receive a grant of state moneys in an amount to be determined by the state board.
- (d) In order to be eligible for a grant under this section, the board of education of the school district shall submit to the state board an application for a grant and shall certify the amount expended on such reimbursements. The application and certification shall be prepared in such form and manner as required by the state board and shall be submitted at a time to be determined and specified by the state board.
- (e) Each school district which is awarded a grant under this section shall make such periodic and special reports to the state board as it may request.
- (f) All moneys received by a school district under authority of this section shall be deposited in the general fund of the school district and shall be considered reimbursement of the district for the purpose of the school district finance and quality performance act. To the extent that grant moneys have been awarded to the district, the board of education of any district which has been awarded a grant pursuant to this section shall reimburse teachers employed by the school district for the direct costs incurred by such teacher in attaining full endorsement as an ESOL teacher.
 - (g) The state board shall establish standards and criteria for review-

1 ing, evaluating and approving applications for grants submitted pursuant to this section. All grants shall be awarded by the state board in accord-3 ance with the standards and criteria established by the state board. The state board shall approve applications of school districts for grants, de-4 termine the amount of grants and be responsible for payment of grants to school districts. When awarding grants pursuant to this section, the 6 state board shall give priority to those districts with the greatest need for teachers with an ESOL endorsement. If the amount of appropriations for 8 9 the payment of grants under this section is insufficient to pay in full the amount each school district is determined to be eligible to receive for the 10 school year, the state board shall prorate the amount appropriated among 11 12 all school districts which are eligible to receive grants of state moneys in 13 proportion to the amount each school district is determined to be eligible 14 to receive.

- (h) Nothing in this section shall be construed as prohibiting districts from reimbursing teachers for such direct costs from other moneys of the district.
