9 AN ACT concerning the Kansas sports hall of fame; relating to funding
10 therefor.

12 *Be it enacted by the Legislature of the State of Kansas:*

13 Section 1. (a) The Kansas sports hall of fame board of trustees shall
14 enter into an agreement with the secondary and postsecondary educa-
15 tional institutions prescribed pursuant to this act.

16 (b) Each university and community college shall designate one inter-
17 collegiate athletic event in football, men's and women's basketball, base-
18 ball, volleyball and softball as a Kansas sports hall of fame game. For the
19 designated football, baseball, basketball, volleyball and softball games the
20 host university shall collect two dollars in addition to the admission price
21 paid by each paying attendee, except that community colleges shall charge
22 one dollar in addition to the admission price paid by each paying attendee.
23 A paying attendee means any person who gives monetary consideration,
24 regardless of the amount, for admission to a specific designated athletic
25 event, including single game tickets, season tickets and student tickets,
26 but not including student activity tickets which allow admission to non-
27 athletic events as well as athletic events.

28 (c) The funds collected pursuant to this section shall be remitted to
29 the board of trustees, and disbursement by the universities shall not be
30 construed as a contribution or donation of funds of the universities to the
31 board.

32 Sec. 2. The intercollegiate athletic events designated as state of Kan-
33 sas sports hall of fame games shall be men's and women's, as the case
34 may be, varsity events and shall be selected by the host university.

35 Sec. 3. The funds collected on behalf of the board of trustees from
36 the designated games pursuant to sections 1 and 2 shall be disbursed by
37 each of the universities and community colleges to the board of trustees
38 semiannually, with one disbursement of all funds collected between July
39 1 and December 31, to be made on or before the following January 15,
40 and one disbursement of all funds collected between January 1 and June
41 30, to be made on or before the following July 15. Each university and
42 community college shall determine its policy concerning the withholding
43 of sales tax, and shall indicate on a report form provided by the board of

1 trustees, whether sales tax has been withheld.

2 Sec. 4. The Kansas state high school activities association shall collect
3 \$.50 in addition to the admission price paid by each paying attendee at
4 high school state football championship games and to men's and women's
5 sports championship tournaments. The governing body of the Kansas
6 state high school activities association shall collect and disburse the funds
7 collected to the board of trustees.

8 Sec. 5. (a) As used in this section:

9 (1) "Board of trustees" means the state of Kansas hall of fame board
10 of trustees.

11 (2) "Community college" shall have the meaning ascribed thereto by
12 K.S.A. 74-3201b, and amendments thereto.

13 (3) "University" means Emporia state university, Fort Hays state uni-
14 versity, university of Kansas, Kansas state university, Pittsburg state uni-
15 versity, Wichita state university and Washburn university.

16 Sec. 6. This act shall take effect and be in force from and after its
17 publication in the statute book.
