9 AN ACT relating to motor vehicles; providing for a Kansas military family license plate; amending K.S.A. 2008 Supp. 8-1,141 and repealing the existing section.

 Be it enacted by the Legislature of the State of Kansas:

New Section 1. On and after January 1, 2010, any owner or lessee of one or more passenger vehicles, trucks of a gross weight of 20,000 pounds or less, motorcycles or travel trailers, who is a resident of the state of Kansas, may apply for and be issued one distinctive license plate for each such passenger vehicle, truck, motorcycle or travel trailer, a Kansas military family license plate. Such license plates shall be issued for the same period of time as other plates upon proper registration and payment of the regular license fee as provided in K.S.A. 8-143, and amendments thereto.

- (b) Any person may make application for such distinctive license plates, not less than 60 days prior to such person's renewal of registration date, on a form prescribed and furnished by the director of vehicles. Application for the registration of a passenger vehicle, truck, motorcycle or travel trailer and issuance of the license plates under this section shall be made by the owner or lessee in a manner prescribed by the director of vehicles upon forms furnished by the director.
- (c) No registration or distinctive license plates issued under the authority of this section shall be transferable to any other person.
- (d) Renewals of registration under this section shall be made annually, upon payment of the fee prescribed in subsection (a), in the manner prescribed in subsection (b) of K.S.A. 8-132, and amendments thereto. No renewal of registration shall be made to any applicant until such applicant has filed with the director a form as provided in subsection (b). If such form is not filed, the applicant shall be required to comply with K.S.A. 8-143, and amendments thereto, and return the distinctive license plates to the county treasurer of such person's residence.
- (e) The Kansas military family license plate shall have a background design, an emblem or colors that designate the license plate as a Kansas military family license plate.
 - (f) Any person issued a license plate under this section may request:

(1) A decal for each license plate indicating a military branch; or (2) upon submitting satisfactory proof to the director of vehicles in accordance with rules and regulations adopted by the secretary, a decal indicating that such person is a gold star family member of a person who died while in good standing on active duty in the military service of the United States.

A fee of \$2 shall be paid for each decal issued under this subsection. The director of vehicles shall design such decals. Such decals shall be affixed to the license plate in the location required by the director.

- Sec. 2. K.S.A. 2008 Supp. 8-1,141 is hereby amended to read as follows: 8-1,141. (a) Any new distinctive license plate authorized for issuance on and after July 1, 1994, shall be subject to the personalized license plate fee prescribed by subsection (c) of K.S.A. 8-132, and amendments thereto. This section shall not apply to any distinctive license plate authorized prior to July 1, 1994.
- (b) The director of vehicles shall not issue any new distinctive license plate authorized for issuance on and after July 1, 1995, unless there is a guarantee of an initial issuance of at least 500 license plates.
- (c) The provisions of this section shall not apply to distinctive license plates issued under the provisions of K.S.A. 8-1,145, or K.S.A. 2008 Supp. 8-177d $or\ section\ 1$, and amendments thereto.
- (d) The provisions of subsection (a), shall not apply to distinctive license plates issued under the provisions of K.S.A. 8-1,146 or 8-1,148, and amendments thereto, or K.S.A. 2008 Supp. 8-1,153 or 8-1,158, and amendments thereto.
- (e) (1) Any person or organization sponsoring any distinctive license plate authorized by the legislature on and after July 1, 2004, shall submit to the division of vehicles a nonrefundable amount not to exceed \$10,000, to defray the division's cost for developing such distinctive license plate.
- (2) All moneys received under this subsection shall be remitted by the secretary of revenue to the state treasurer in accordance with the provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of each such remittance, the state treasurer shall deposit the entire amount in the state treasury to the credit of the distinctive license plate fund which is hereby created in the state treasury. All moneys credited to the distinctive license plate fund shall be used by the department of revenue only for the purpose associated with the development of distinctive license plates. All expenditures from the distinctive license plate application fee fund shall be made in accordance with appropriation acts, upon warrants of the director of accounts and reports issued pursuant to vouchers approved by the secretary of the department of revenue.
- 42 (f) (1) Except for educational institution license plates issued under 43 K.S.A. 8-1,142, and amendments thereto, the director of vehicles shall

discontinue the issuance of any distinctive license plate authorized prior 2 to July 1, 2004, and which is subject to the provisions of subsection (b) 3

- (A) Less than 500 license plates, including annual renewals, are issued for that distinctive license plate by July 1, 2006; and
- (B) less than 250 license plates, including annual renewals, are issued for that distinctive license plate during any subsequent two-year period after July 1, 2006.
- 9 (2) The director of vehicles shall discontinue the issuance of any distinctive license plate authorized on and after July 1, 2004, if: 10
 - (A) Less than 500 plates, including annual renewals, are issued for that distinctive license plate by the end of the second year of sales; and
- 13 (B) less than 250 license plates, including annual renewals, are issued for that distinctive license plate during any subsequent two-year period. 14
- 15 Sec. 3. K.S.A. 2008 Supp. 8-1,141 is hereby repealed.
- Sec. 4. This act shall take effect and be in force from and after its 16 publication in the statute book. 17
