Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 2008 Supp. 79-32,202 is hereby amended to read as follows: 79-32,202. (a) For all taxable years commencing after December 31, 2005, and in addition to the credit provided in subsection (b), there shall be allowed as a credit against the tax liability of a resident individual imposed under the Kansas income tax act an amount equal to: (1) 25% of the amount of the credit allowed against such taxpayer's federal income tax liability pursuant to section 23 determined without regard to subsection (c) thereof of the federal internal revenue code; (2) in addition to subsection (a)(1), 25% of the amount of such federal income tax credit, if the child adopted by the taxpayer was a resident of Kansas prior to such lawful adoption; and (3) and in addition to subsections (a)(1) and (a)(2), 25% of the amount of such federal income tax credit, if the child adopted by the taxpayer is a child with special needs, as defined in section 23 of the federal internal revenue code, and the child was a resident of Kansas prior to such lawful adoption, for the taxable year in which such credit was claimed against the taxpayer's federal income tax liability.

(b) For all taxable years commencing after December 31, 1996 2003, in addition to the credit provided in subsection (a), there shall be allowed as a credit against the tax liability of a resident individual imposed under the Kansas income tax act an amount equal to \$1,500 for the taxable year in which occurs the lawful adoption of a child in the custody of the secretary of social and rehabilitation services or a child with special needs, whether or not such individual is reimbursed for all or part of qualified adoption expenses or has received a public or private grant therefor. As used in this subsection, terms and phrases shall have the meanings ascribed thereto by the provisions of section 23 of the federal internal revenue code. No eredit shall be allowed under subsection (a) for any qualified adoption expenses incurred in the adoption of a child described by this subsection. Notwithstanding any provision of law to the contrary, a taxpayer may file an amended return to claim the credit under this sub-

section or subsection (a) for taxable years 2004, 2005, 2006, 2007 and 2008, as applicable, if the taxpayer only claimed the credit under subsection (a) or (b), but not both subsections for such applicable tax years.

- (c) The credit allowed by subsections (a) and (b) shall not exceed the amount of the tax imposed by K.S.A. 79-32,110, and amendments thereto, under the Kansas income tax act reduced by the sum of any other credits allowable pursuant to law. If the amount of such tax credit exceeds the taxpayer's income tax liability for such taxable year, the amount thereof which exceeds such tax liability may be carried over for deduction from the taxpayer's income tax liability in the next succeeding taxable year or years until the total amount of the tax credits has been deducted from tax liability.
