9 AN ACT concerning district court fines, penalties and forfeitures; relat-
10 ing to traffic fines; relating to funding of the alcohol and drug abuse
11 treatment fund; amending K.S.A. 2009 Supp. 8-2118 and 74-7336 and
12 repealing the existing sections.

14 *Be it enacted by the Legislature of the State of Kansas:*

15 Section 1. K.S.A. 2009 Supp. 8-2118 is hereby amended to read as
16 follows: 8-2118. (a) A person charged with a traffic infraction shall, except
17 as provided in subsection (b), appear at the place and time specified in
18 the notice to appear. If the person enters an appearance, waives right to
19 trial, pleads guilty or no contest, the fine shall be no greater than that
20 specified in the uniform fine schedule in subsection (c) and court costs
21 shall be taxed as provided by law.

22 (b) Prior to the time specified in the notice to appear, a person
23 charged with a traffic infraction may enter a written appearance, waive
24 right to trial, plead guilty or no contest and pay the fine for the violation
25 as specified in the uniform fine schedule in subsection (c) and court costs
26 provided by law. Payment may be made by mail or in person and may be
27 by personal check. The traffic citation shall not have been complied with
28 if a check is not honored for any reason, or if the fine and court costs are
29 not paid in full. When a person charged with a traffic infraction makes
30 payment without executing a written waiver of right to trial and plea of
31 guilty or no contest, the payment shall be deemed such an appearance,
32 waiver of right to trial and plea of no contest.

33 (c) The following uniform fine schedule shall apply uniformly
34 throughout the state but shall not limit the fine which may be imposed
35 following a court appearance, except an appearance made for the purpose
36 of pleading and payment as permitted by subsection (a). The description
37 of offense contained in the following uniform fine schedule is for refer-
38 ence only and is not a legal definition.

18 (d) Traffic offenses classified as traffic infractions by this section shall
19 be classified as ordinance traffic infractions by those cities adopting
20 ordinances prohibiting the same offenses. A schedule of fines for all
21 ordinance traffic infractions shall be established by the municipal judge
22 in the manner prescribed by K.S.A. 12-4305, and amendments thereto.
23 Such fines may vary from those contained in the uniform fine schedule
24 contained in subsection (c).

25 (e) Fines listed in the uniform fine schedule contained in subsection
26 (c) shall be doubled if a person is convicted of a traffic infraction, which
27 is defined as a moving violation in accordance with rules and regulations
28 adopted pursuant to K.S.A. 8-249, and amendments thereto, committed
29 within any road construction zone as defined in K.S.A. 8-1458a, and
30 amendments thereto.

31 (f) For a second violation of K.S.A. 8-1908 or 8-1909, and
32 amendments thereto, within two years after a prior conviction of K.S.A.
33 8-1908 or 8-1909, and amendments thereto, such person, upon conviction
34 shall be fined 1½ times the applicable amount from one, but not both,
35 of the schedules listed in the uniform fine schedule contained in
36 subsection (c). For a third violation of K.S.A. 8-1908 or 8-1909, and
37 amendments thereto, within two years, after two prior convictions of
38 K.S.A. 8-1908 or 8-1909, and amendments thereto, such person, upon
39 conviction shall be fined two times the applicable amount from one, but
40 not both, of the schedules listed in the uniform fine schedule contained
41 in subsection (c). For a fourth and each succeeding violation of K.S.A. 8-
42 1908 or 8-1909, and amendments thereto, within two years after three
43 prior convictions of K.S.A. 8-1908 or 8-1909, and amendments thereto,

1 such person, upon conviction shall be fined 2½ times the applicable
2 amount from one, but not both, of the schedules listed in the uniform
3 fine schedule contained in subsection (c).

4 (g) Fines listed in the uniform fine schedule contained in subsection
5 (c) relating to exceeding the maximum speed limit, shall be doubled if a
6 person is convicted of exceeding the maximum speed limit in a school
7 zone authorized under subsection (a)(4) of K.S.A. 8-1560, and
8 amendments thereto.

9 Sec. 2. K.S.A. 2009 Supp. 74-7336 is hereby amended to read as
10 follows: 74-7336. (a) Of the remittances of fines, penalties and forfeitures
11 received from clerks of the district court, at least monthly, the state
12 treasurer shall credit:

- 13 (1) ~~11.99%~~ 11.27% to the crime victims compensation fund;
- 14 (2) ~~2.45%~~ 2.30% to the crime victims assistance fund;
- 15 (3) ~~3.01%~~ 2.83% to the community alcoholism and intoxication
16 programs fund;
- 17 (4) ~~2.01%~~ 7.89% to the department of corrections alcohol and drug
18 abuse treatment fund;
- 19 (5) ~~0.17%~~ 0.16% to the boating fee fund;
- 20 (6) ~~0.12%~~ 0.11% to the children's advocacy center fund;
- 21 (7) ~~2.50%~~ 2.35% to the EMS revolving fund;
- 22 (8) ~~2.50%~~ 2.35% to the trauma fund;
- 23 (9) ~~2.50%~~ 2.35% to the traffic records enhancement fund; and
- 24 (10) the remainder of the remittances to the state general fund.

25 (b) The county treasurer shall deposit grant moneys as provided in
26 subsection (a), from the crime victims assistance fund, to the credit of a
27 special fund created for use by the county or district attorney in
28 establishing and maintaining programs to aid witnesses and victims of
29 crime.

30 Sec. 3. K.S.A. 2009 Supp. 8-2118 and 74-7336 are hereby repealed.

31 Sec. 4. This act shall take effect and be in force from and after its
32 publication in the statute book.
