9 AN ACT making and concerning appropriations for the fiscal year ending
10 June 30, 2010, for state agencies; authorizing certain transfers, impos-
11 ing certain restrictions and limitations, and directing or authorizing
12 certain receipts, disbursements and acts incidental to the foregoing.
13

14 *Be it enacted by the Legislature of the State of Kansas:*

15 Section 1. (a) For the fiscal year ending June 30, 2010, appropriations
16 are hereby made, restrictions and limitations are hereby imposed, and
17 transfers, capital improvement projects, fees, receipts, disbursements and
18 acts incidental to the foregoing are hereby directed or authorized as pro-
19 vided in this act.

20 (b) The agencies named in this act are hereby authorized to initiate
21 and complete the capital improvement projects specified and authorized
22 by this act or for which appropriations are made by this act, subject to
23 the restrictions and limitations imposed by this act.

24 (c) This act shall not be subject to the provisions of subsection (a) of
25 K.S.A. 75-6702, and amendments thereto.

26 (d) The appropriations made by this act shall not be subject to the
27 provisions of K.S.A. 46- 155, and amendments thereto.

30 (a) On the effective date of this act, of the \$613,625 appropriated for
31 the above agency for the fiscal year ending June 30, 2010, by section 31(a)
32 of chapter 124 of the 2009 Session Laws of Kansas from the state general
33 fund in the legislative coordinating council — operations account, the
34 sum of \$86,885 is hereby lapsed.

35 (b) On the effective date of this act, of the \$3,643,401 appropriated for
36 the above agency for the fiscal year ending June 30, 2010, by section 31(a)
37 of chapter 124 of the 2009 Session Laws of Kansas from the state general
38 fund in the legislative research department — operations account, the
39 sum of \$426,615 is hereby lapsed.

40 (c) On the effective date of this act, of the \$3,324,250 appropriated for
41 the above agency for the fiscal year ending June 30, 2010, by section 31(a)
42 of chapter 124 of the 2009 Session Laws of Kansas from the state general
43 fund in the office of revisor of statutes — operations account, the sum of

1 \$649,379 is hereby lapsed.

4 (a) On the effective date of this act, of the \$17,031,301 appropriated
5 for the above agency for the fiscal year ending June 30, 2010, by section
6 32(a) of chapter 124 of the 2009 Session Laws of Kansas from the state
7 general fund in the operations (including official hospitality) account, the
8 sum of \$1,366,648 is hereby lapsed.

10 DIVISION OF POST AUDIT

11 (a) On the effective date of this act, of the \$2,732,354 appropriated for
12 the above agency for the fiscal year ending June 30, 2010, by section 33(a)
13 of chapter 124 of the 2009 Session Laws of Kansas from the state general
14 fund in the operations (including legislative post audit committee) ac-
15 count, the sum of \$225,457 is hereby lapsed.

18 (a) There is appropriated for the above agency from the state general

22 DEPARTMENT OF TRANSPORTATION

23 (a) On February 1, 2010, or as soon thereafter as moneys are available,
24 the director of accounts and reports shall transfer \$40,000,000 from the
25 state highway fund of the department of transportation to the state gen-
26 eral fund: *Provided*, That the transfer of such amount shall be in addition
27 to any other transfer from the state highway fund of the department of
28 transportation to the state general fund as prescribed by law: *Provided*
29 *further*, That, in addition to other purposes for which transfers and ex-
30 penditures may be made from the state highway fund during fiscal year
31 2010 and notwithstanding the provisions of K.S.A. 68-416, and amend-
32 ments thereto, or any other statute, transfers may be made from the state
33 highway fund to the state general fund under this subsection during fiscal
34 year 2010: *And provided further*, That all moneys transferred from the
35 state highway fund to the state general fund under this subsection shall
36 be moneys credited to the state highway fund pursuant to K.S.A. 79-3620
37 or 79-3710, and amendments thereto.

38 (b) On May 1, 2010, or as soon thereafter as moneys are available, the
39 director of accounts and reports shall transfer \$40,000,000 from the state
40 highway fund of the department of transportation to the state general
41 fund: *Provided*, That the transfer of such amount shall be in addition to
42 any other transfer from the state highway fund of the department of
43 transportation to the state general fund as prescribed by law: *Provided*

1 *further*, That, in addition to other purposes for which transfers and ex-
2 penditures may be made from the state highway fund during fiscal year
3 2010 and notwithstanding the provisions of K.S.A. 68-416, and amend-
4 ments thereto, or any other statute, transfers may be made from the state
5 highway fund to the state general fund under this subsection during fiscal
6 year 2010: *And provided further*, That all moneys transferred from the
7 state highway fund to the state general fund under this subsection shall
8 be moneys credited to the state highway fund pursuant to K.S.A. 79-3620
9 or 79-3710, and amendments thereto.

11 OFFICE OF THE SECURITIES COMMISSIONER OF KANSAS

12 (a) On the effective date of this act, or as soon thereafter as moneys
13 are available, notwithstanding the provisions of K.S.A. 17-12a601, and
14 amendments thereto, or any other statute, the director of accounts and
15 reports shall transfer \$5,000,000 from the investor education fund of the
16 office of the securities commissioner of Kansas to the state general fund:
17 *Provided*, That the transfer of such amount shall be in addition to any
18 other transfer from the investor education fund to the state general fund
19 as prescribed by law: *Provided further*, That the amount transferred from
20 the investor education fund to the state general fund pursuant to this
21 subsection is to reimburse the state general fund for accounting, auditing,
22 budgeting, legal, payroll, personnel and purchasing services and any other
23 governmental services which are performed on behalf of the office of the
24 securities commissioner of Kansas by other state agencies which receive
25 appropriations from the state general fund to provide such services.

27 DEPARTMENT OF COMMERCE

28 (a) On the effective date of this act, of the \$291,630 appropriated for
29 the above agency for the fiscal year ending June 30, 2010, by section
30 54(b) of chapter 124 of the 2009 Session Laws of Kansas from the state
31 economic development initiatives fund in the older Kansans employment
32 program account, the sum of \$3,021 is hereby lapsed.

33 (b) On the effective date of this act, of the \$1,856,859 appropriated for
34 the above agency for the fiscal year ending June 30, 2010, by section
35 54(b) of chapter 124 of the 2009 Session Laws of Kansas from the state
36 economic development initiatives fund in the rural opportunity program
37 account, the sum of \$118,575 is hereby lapsed.

38 (c) On the effective date of this act, of the \$211,737 appropriated for
39 the above agency for the fiscal year ending June 30, 2010, by section
40 54(b) of chapter 124 of the 2009 Session Laws of Kansas from the state
41 economic development initiatives fund in the Kansas commission on dis-
42 ability concerns account, the sum of \$15,396 is hereby lapsed.

43 (d) On the effective date of this act, of the \$330,710 appropriated for

1 the above agency for the fiscal year ending June 30, 2010, by section
2 54(b) of chapter 124 of the 2009 Session Laws of Kansas from the state
3 economic development initiatives fund in the strong military bases pro-
4 gram account, the sum of \$7,500 is hereby lapsed.

5 (e) On the effective date of this act, of the \$14,019,902 appropriated
6 for the above agency for the fiscal year ending June 30, 2010, by section
7 54(b) of chapter 124 of the 2009 Session Laws of Kansas from the state
8 economic development initiatives fund in the operating grant (including
9 official hospitality) account, the sum of \$655,508 is hereby lapsed.

12 (a) On the effective date of this act, of the \$358,874 appropriated for
13 the above agency for the fiscal year ending June 30, 2010, by section 55(a)
14 of chapter 124 of the 2009 Session Laws of Kansas from the state eco-
15 nomic development initiatives fund in the operations (including official
16 hospitality) account, the sum of \$10,000 is hereby lapsed.

18 KANSAS TECHNOLOGY ENTERPRISE CORPORATION

19 (a) On the effective date of this act, of the \$7,000,000 appropriated for
20 the above agency for the fiscal year ending June 30, 2010, by section 37(a)
21 of chapter 144 of the 2009 Session Laws of Kansas from the state eco-
22 nomic development initiatives fund in the operations, assistance and
23 grants (including official hospitality) account, the sum of \$390,000 is
24 hereby lapsed.

25 Sec. 11. On the effective date of this act, or as soon thereafter as mon-
26 eys are available, notwithstanding the provisions of K.S.A. 79-4804, and
27 amendments thereto, or any other statute, the director of accounts and
28 reports shall transfer \$5,800,000 from the state economic development
29 initiatives fund to the state general fund.

30 Sec. 12. On the effective date of this act, or as soon thereafter as mon-
31 eys are available, notwithstanding the provisions of K.S.A. 74-8959, and
32 amendments thereto, K.S.A. 2009 Supp. 12- 5256, and amendments
33 thereto, or any other statute, the director of accounts and reports shall
34 transfer \$2,000,000 from the state housing trust fund of the Kansas hous-
35 ing resources corporation to the state general fund.
