Hall of the House of Representatives, Topeka, KS, Tuesday, February 13, 2001, 11:00 a.m.

A RESOLUTION in memory of Vernon L. Williams.

WHEREAS, Vernon L. Williams of Wichita died January 28, 2001, at age 80; and WHEREAS, Vernon L. Williams served in the Kansas House of Representatives from 1953-57 and 1983-91. Positions held while in the House of Representatives included speaker pro tem, chairperson of the Aviation Committee and the Labor and Industry Committee; and

WHEREAS, Vernon L. Williams retired from the Coleman Company in 1986 as the company's vice-president for industrial relations. At the Coleman Company he was known as a dedicated person who knew everyone in the company and had a great zest for life; and

WHEREAS, Vernon L. Williams was a native of Wichita who graduated from North High School and attended Wichita University before joining the United States Coast Guard during World War II. After the war he attended and graduated from Washburn Law School. An excellent athlete, he signed a professional baseball contract with the St. Louis Cardinals but was unable to fulfill it because of a severe shoulder injury. He was the leading scorer on the Wichita University basketball team in 1941. In later years he was instrumental in raising money for Levitt Arena, and when the University's basketball team wasn't doing well, would exclaim he still had a year of eligibility and was thinking about going back to school to help the team; and

WHEREAS, Vernon L. Williams is survived by his wife, Marjorie, three sons, Michael, T. Patrick and Bill, and five grandchildren: Now, therefore,

#### EXPLANATION OF VOTE

Mr. Speaker: I vote no on **HB 2084. HB 2084** challenges the current philosophy of state psychiatric hospitals. We have state psychiatric hospitals to treat the mentally ill . . . **NOT** to house folks found not competent to stand trial for reasons other than mental illness. Committing people without mental illness is nonproductive for the individual and we question the Constitutionality of this bill.

In addition, there could be major fiscal implications. SRS has said additional housing units would likely be needed at an estimated cost of \$8 million with approximately \$3.5 million needed annually for operating costs.—Kenny A. Wilk, Melvin Neufeld

may, with the approval of the secretary of revenue and upon such conditions as the secretary of revenue may prescribe, pay the tax required by this act on the same basis and at the same time such person pays the retailer's sales tax. Each business shall make a true report to the department of revenue, on a form prescribed by the secretary of revenue, providing such information as may be necessary to determine the amounts to which any such tax shall apply for all gross rental receipts for the applicable month or months, which report shall be accompanied by the tax disclosed thereby. Records of gross rental receipts shall be kept separate and apart from the records of other retail sales made by a business in order to facilitate the examination of books and records as provided herein.

- (b) The secretary of revenue or the secretary's authorized representative shall have the right at all reasonable times during business hours to make such examination and inspection of the books and records of a business as may be necessary to determine the accuracy of such reports.
- (c) The secretary of revenue is hereby authorized to administer and collect any transient guest tax levied pursuant to this act and to adopt such rules and regulations as may be necessary for the efficient and effective administration and enforcement of the collection thereof. Whenever any business liable to pay any transient guest tax refuses or neglects to pay the same, the amount, including any penalty, shall be collected in the manner prescribed for the collection of the retailers' sales tax by K.S.A. 79-3617, and amendments thereto. All of the taxes collected under the provisions of this act shall be paid into the state treasury daily by the secretary of revenue, and the state treasurer shall place 2% of all taxes so collected in the state general fund to defray the expenses of the department in administration and enforcement of the collection thereof. The remainder of such taxes shall be credited to the county and city transient guest tax fund, which fund is hereby established. All moneys in the county and city transient guest tax fund shall be remitted at least quarterly by the state treasurer, on instruction from the secretary of revenue, to the treasurers of those cities which, by virtue of their participation in the election provided for in K.S.A. 12-1693, and amendments thereto, are qualified to receive disbursements from such transient guest tax fund for the amount collected within such city, and to the treasurer of such county for the amount collected in the unincorporated areas of such county.
- (d) The director of taxation shall provide, upon request by a city or county clerk or treasurer of any city or county levying a transient guest tax, of any city located within any such county or of any county within which is located any such city monthly reports identifying each person doing business in such city or county to which such tax is applicable setting forth the tax liability and the amount of such tax remitted by such business during the preceding month, and identifying each business location maintained by the person within such city or county. Such report shall be made available to the clerk or treasurer of such city or county within a reasonable time after it has been requested from the director of taxation. The director of taxation shall be allowed to assess a reasonable fee for the issuance of such report. Information received by any city or county pursuant to this section shall be kept confidential, and it shall be unlawful for any officer or employee of such city or county to divulge any such information in any manner, except that, such information may be divulged by any such clerk or treasurer to any member of an appropriate governing body or to any financial officer designated by any such governing body to receive such information. Any violation of this paragraph by a city or county officer or employee is a class B misdemeanor, and such officer or employee shall be dismissed from office.
- (e) All such moneys received by the county treasurer or city treasurer from disbursements from the county and city transient guest tax fund shall be credited to the tourism and convention promotion fund of such county or city and shall only be expended for convention and tourism promotion, except that not more than 20% of the moneys credited to such fund shall be expended for tourism promotion.
- Sec. 3. K.S.A. 2000 Supp. 12-1698 is hereby amended to read as follows: 12-1698. (a) Any tax levied and collected pursuant to K.S.A. 12-1697, and amendments thereto, shall become due and payable by the business monthly, on or before the 25th day of the month immediately succeeding the month in which it is collected, with the first payment due and payable on or before the 25th day of the month specified in the resolution of the governing body which levies the tax, but any person filing an annual or quarterly return under the

Records of gross rental receipts shall be kept separate and apart from the records of other retail sales made by a business in order to facilitate the examination of books and records as provided herein.

- (b) The secretary of revenue or the secretary's authorized representative shall have the right at all reasonable times during business hours to make such examination and inspection of the books and records of a business as may be necessary to determine the accuracy of such reports.

The remainder of such taxes shall be credited to the county or city transient guest tax fund, which fund is hereby established. All moneys in the county or city transient guest tax fund shall be remitted at least quarterly by the state treasurer to the county or city treasurer of each county or city levying a transient guest tax under the provisions of this act in the proportion, as certified by the director of taxation, that the amount collected from such tax in each such county or city bears to the total amount collected from such taxes in all counties or cities for the period covered by the distribution.
- (d) The director of taxation shall provide, upon request by a city or county clerk or treasurer of any city or county levying a transient guest tax of any city located within any such county or of any county within which is located any such city, monthly reports identifying each person doing business in such city or county to which such tax is applicable setting forth the tax liability and the amount of such tax remitted by such business during the preceding month, and identifying each business location maintained by the person within such city or county. Such report shall be made available to the clerk or treasurer of such city or county within a reasonable time after it has been requested from the director of taxation. The director of taxation shall be allowed to assess a reasonable fee for the issuance of such report. Information received by any city or county pursuant to this section shall be kept confidential, and it shall be unlawful for any officer or employee of such city or county to divulge any such information in any manner, except that, such information may be divulged by any such clerk or treasurer to any member of an appropriate governing body or to any financial officer designated by any such governing body to receive such information. Any violation of this paragraph by a city or county officer or employee is a class B misdemeanor, and such officer or employee shall be dismissed from office.
- (e) Except as otherwise provided in K.S.A. 12-1774, and amendments thereto, all such moneys received by the county or city treasurer from disbursements from the county or city transient guest tax fund shall be credited to the tourism and convention promotion fund of such county or city and shall only be expended for convention and tourism promotion.";
