- SB 161, An act concerning school districts; authorizing boards of education to adopt policies relating to the use of credit or debit cards, by Senator Gilstrap.
- SB 162, An act concerning veterinarians; amending K.S.A. 47-816, 47-822 and 47-825 and repealing the existing sections, by Committee on Agriculture.
- SB 163, An act concerning the flag of the United States of America; relating to the use and display thereof, by Senators Jackson, Adkins, Allen, Brownlee, Brungardt, Clark, Emler, Gilstrap, Gooch, Haley, Harrington, Jordan, Lyon, Oleen, Pugh, Schmidt, Schodorf, Taddiken, Teichman, Tyson, Umbarger and Wagle.
