Senate Chamber, Topeka, Kansas Wednesday, January 31, 2001—2:30 p.m.

The Senate was called to order by President Dave Kerr.

The roll was called with forty senators present.

President Kerr introduced as guest chaplain, Rabbi Lawrence P. Karol, Temple Beth Sholom, Topeka, Kansas, who delivered the invocation:

SENATE CONCURRENT RESOLUTION No. 1606—

By Committee on Utilities

A CONCURRENT RESOLUTION requesting all state agencies to lower the temperature setting in all state buildings to 66 degrees.

WHEREAS, The price paid for natural gas has increased substantially; and

WHEREAS, The taxpayers of Kansas not only have to pay their own heating bills, but are also responsible for paying the heating bills for the state of Kansas; and

WHEREAS, One of the suggestions presented to the citizens of Kansas for lowering their heating bills, is to lower the temperature setting on their thermostats; and

WHEREAS, If that suggestion is good for the citizens of Kansas, it makes perfect sense for the stewards of the citizen's tax dollars to follow suit: Now, therefore,

Be it resolved by the Senate of the State of Kansas, the House of Representatives concurring therein: That all state agencies are requested to lower the temperature setting in all state buildings to 66 degrees during the time period the cold weather rule of the state corporation commission is in effect; and

Be it further resolved: That the Secretary of State be directed to send enrolled copies of this resolution to the chief administrative officer or governing board of each state agency having control or supervision of any state buildings or facilities.

SENATE CONCURRENT RESOLUTION No. 1607—

By Committee on Utilities

A CONCURRENT RESOLUTION urging the United States government to establish a federal energy policy.

WHEREAS. The nation faces a growing shortage of domestic oil and the world may face petroleum shortages in the next fifty years; and

WHEREAS, Natural gas has risen dramatically in price because demand has increased faster than supplies are discovered; and

WHEREAS, Domestic consumers are faced with ever-increasing price spikes and lowered expectations of the market meeting the demand for energy; and

WHEREAS, The American association of petroleum geologists, in concert with other scientific professional learned societies, is convening in Washington, D.C., on April 23, 2001, to address the need for a national energy supply and to look for new sources of energy; and

WHEREAS, The United States does not have a public policy on energy: Now, therefore, Be it resolved by the Senate of the State of Kansas, the House of Representatives concurring therein: That the legislature of the state of Kansas encourages the development of a federal energy policy that considers all possible future sources of energy.

Be it further resolved: That the Secretary of State be directed to send enrolled copies of this resolution to the President of the United States; the Vice-President of the United States; Majority Leader and Minority Leader of the United States Senate; the Speaker, Majority Leader and Minority Leader of the United States House of Representatives; the Secretary of the United States Department of Energy; to each member of the Kansas Congressional Delegation; and to the American Association of Petroleum Geologists, P.O. Box 979, Tulsa, Oklahoma, 74101-0979.

INTRODUCTION OF ORIGINAL MOTIONS AND SENATE RESOLUTIONS

Senators Donovan and Gilstrap introduced the following Senate resolution, which was read:

SENATE RESOLUTION No. 1813-

A RESOLUTION recognizing Catholic Schools Week.

WHEREAS, The Catholic schools in Kansas are nationally acclaimed for academic excellence and provide students more than a superior scholastic education; and

WHEREAS, Catholic schools ensure a broad, values-added education emphasizing the lifelong development of moral, intellectual, physical and social values in the young people of Kansas: and

WHEREAS, Catholic schools produce students strongly dedicated to their faith, values, families and communities by providing an intellectually stimulating environment rich in spiritual, character and moral development; and

WHEREAS, Catholic schools together with a strong public school system and a diverse network of other independent and religious schools give the citizens of Kansas unparalleled educational opportunities: Now, therefore,

Be it resolved by the Senate of the State of Kansas: That in recognition of Catholic Schools Week, January 28-February 3, the Kansas Senate salutes the Catholic schools of Kansas and congratulates all Catholic school students, parents and teachers across Kansas for the role they play in promoting and ensuring a brighter, stronger future for this state and patien.

On emergency motion of Senator Donovan SR 1813 was adopted unanimously.

REPORTS OF STANDING COMMITTEES

Committee on **Federal and State Affairs** recommends **SB 71** be amended on page 1, following line 13, by inserting:

"Section 1. As used in this section and sections 2 through 6, and amendments thereto:

- (a) "Director" means the director of the division of facilities management.
- (b) "Division" means the division of facilities management within the department of administration.
- (c) "Memorial" means any permanent commemorative plaque, monument, sculpture, statuary, work of art or other object, structure or capital improvement project, but does not

include construction or maintenance of walkways or roadways or any landscaping, landscape gardening or other maintenance or development of the capitol grounds unless such project or activity is specifically for commemorative purposes.";

By renumbering sections accordingly;

Also on page 1, in line 17, by striking "of architectural services"; in line 19, by striking "of architectural services"; in line 22, by striking "of architectural services"; in line 28, by striking "5" and inserting "6"; in line 34, by striking "of architectural services";

On page 3, in line 1, by striking "of architectural services"; in line 3, before "may" by inserting "also"; in line 4, by striking "also"; in line 9, by striking "1" and inserting "2";

On page 5, by striking all in lines 21 through 27; and the bill be passed as amended.

Committee on **Transportation** recommends **SB 56** be passed.

Also **SB 53**, **SB 54** be passed and, because the committee is of the opinion that the bills are of a noncontroversial nature, be placed on the consent calendar.

COMMITTEE OF THE WHOLE

On motion of Senator Oleen, the Senate resolved itself into Committee of the Whole for consideration of bills on the calendar under the heading of General Orders with Senator Vratil in the chair.

On motion of Senator Vratil the following report was adopted:

Recommended SR 1808 be adopted.

SB 1, SB 20 be amended by adoption of the committee amendments, and the bills be passed as amended.

SB 29 be amended by adoption of the committee amendments.

Senator Huelskamp moved to amend **SB 29**, as amended by Senate Committee, on page 2, following line 43, by inserting:

"New Sec. 2. (a) As used in this section, "drug" means mifeprex, methotrexate or other medication used to induce an abortion or terminate a pregnancy.

(b) No public moneys shall be expended to purchase any drug intended to be used to induce an abortion or terminate a pregnancy.";

By renumbering sections accordingly;

In the title, by striking all in lines 10, 11 and 12 and inserting:

"AN ACT concerning the expenditure of public moneys; concerning the use thereof for medical or health-related purposes; amending K.S.A. 38-2001 and repealing the existing section."

A ruling of the chair was requested on the amendment. The chair ruled the amendment not to be germane to the bill.

The Committee recommended **SB 29**, as amended by adoption of the committee amendments, be passed as amended.

SB 19 be amended by adoption of the committee amendments, be further amended by motion of Senator Praeger as amended by Senate Committee, on page 1, in line 13, after "insurer", by inserting "and the state health care benefits program"; in line 14, after "insurer", by inserting "or such program", and **SB** 19 be passed as further amended.

SB 44 be amended by adoption of the committee amendments, be further amended by motion of Senator Lee as amended by Senate Committee, on page 3, in line 22, by striking "and" and inserting a comma; in line 24, before the period by inserting "and for payment of property tax refunds allowed pursuant to the provisions of K.S.A. 2000 Supp. 79-255, and amendments thereto";

On page 5, after line 18, by inserting a new section to read as follows:

"Sec. 5. K.S.A. 2000 Supp. 79-255 is hereby amended to read as follows: 79-255. (a) For all taxable years commencing after December 31, 1999, and subject to the provisions of this section, there shall be allowed as a property tax refund to the operator of an oil lease an amount equal to 50% of the total amount of property tax levied and actually and timely paid by the operator for a property tax year which is attributable to the working interest of an oil lease the average daily production per well from which is 15 barrels or less when the price per barrel of oil is \$16 or less, as prescribed in the oil and gas appraisal guide by the director of property valuation for the applicable tax year. No refund shall be allowed for

property tax paid upon machinery and equipment for which a credit is claimed pursuant to K.S.A. 2000 Supp. 79-32,206 and amendments thereto.

- (b) No claim for a refund allowable pursuant to subsection (a) shall be paid unless filed with and in possession of the department of revenue on or before April 15 of the year next succeeding the year in which such taxes were paid, except that the director of taxation may extend the time for filing any claim or accept a claim filed after the deadline for filing when good cause exists therefor if the claim has been filed within three years of the deadline.
- (c) The allowable amount of such claim shall be paid to the operator from funds appropriated for such purposes the income tax refund fund upon warrants of the director of accounts and reports pursuant to vouchers approved by the director of taxation or by any person designated by the claimant, but no warrant issued hereunder shall be drawn in an amount of less than \$5. No interest shall be allowed on any payment made to an operator pursuant to this section.
- (d) Insofar as the same may be made applicable, the provisions of K.S.A. 79-3226, and amendments thereto, shall apply to claims for refunds allowable pursuant to this section which may become in dispute.
- (e) The department of revenue shall devise and provide forms and instructions necessary to administer this section, and the secretary of revenue may adopt rules and regulations for such purpose.";

In the title, in line 10, by striking all after "ACT"; in line 11, by striking all before the semicolon and inserting "relating to property taxation; concerning the administration of certain refunds thereof"; in line 12, after "Supp" by inserting ". 79-255 and", and **SB 44** be passed as further amended.
