SENATE CHAMBER, TOPEKA, KANSAS
Monday, March 5, 2001—2:30 p.m.

The Senate was called to order by President Dave Kerr.

The roll was called with thirty-nine senators present.

Senator Downey was excused.

President Kerr introduced as guest chaplain, Pastor Wayne Wilson, Emanuel Mennonite Church, Meade, Kansas, who delivered the invocation:
