Also, there is also no requirement that those who qualify be notified of such fund availability. Without such a requirement few will avail themselves as is the case with funds currently available to these same individuals. This bill needs more work.—Deena Horst

- (c) No registration or distinctive license plates issued under the authority of this section shall be transferable to any other person.

No renewal of registration shall be made to any applicant until such applicant has filed with the director a form as provided in subsection (b).
